Sir,

At 1006 hours on Wednesday January 23, 2013 myself and Sgt J. LaDuca #249 were assigned as Bomb Technicians to [REDACTED] in Cresskill, NJ to investigate a report of a suspicious package. Upon arrival we spoke with PO Birne of the Cresskill PD who relayed the following information to us.

At approximately 0950 hours on this date the homeowner of the above address contacted the Cresskill Police Dept and advised them that an unknown person had left a suitcase at the end of their driveway. The resident is an executive with CNN and has received threats in the past. Cresskill PD established [REDACTED] around the location, evacuated the residence and contacted the Bomb Squad.

Sgt LaDuca and I observed a black colored, rectangular suitcase at the foot of the driveway of the residence. It was an unknown brand with wheels at the bottom edge and a retractable handle that was in the down position.

Using proper render safe procedures, Sgt LaDuca x-rayed the suitcase and found no evidence of any explosive or electronic components. Closer inspection of the suitcase found it to be empty.

The suitcase was turned over to Cresskill PD for disposal.
