Thank you for your email. Please see email chain below. I would like to speak to the person responsible regarding answers to my questions. I have pushed my my deadline to Sunday afternoon which should give plenty of time. Transparency is practiced at all the credible news outlets and I expect the public will expect this from Al Jazeera.

I read your letter and plan to run it in full. But several points:

- Any debate of fact or disagreement about how to the handle the three imprisoned journalists cases between Mr. Farag and Al Jazeera, and now Khaled Abu Bakr, also gone, is a matter of great public interest.
- Please note that your blanket response of falsity and your charges of Farag's unethical character and acts, only addresses a few questions and the issues we raised.

- For example, the questions about the Al Jazeera letter to the press center. This has nothing to do with Farag and your letter does not address these questions.
- We have also verified with another lawyer --Khaled Abu Bakr--that he is also no longer on the case either. This also has nothing to do with Farag.
- We asked who are the criminal lawyers now, as we are trying to verify what we were told by multiple sources that the three journalists have gone without criminal lawyers and we want to verify if true.
- Farag's complaints about your client and the conflict with Al Jazeera is documented by emails, in part. I have asked for your client to verify a few emails to fact check their authenticity. But you or your clients have given no reply.

We are interested in the truth and finding out all we can about any and all mitigating circumstances and facts that your client has related to these serious accusations we understand Egyptian prosecutors are looking into, as well as report to us any specific errors of fact that they believe counter accusations. We have pushed back our deadline multiple times to accommodate your clients.

Again, we have given your client fair opportunity to verify documents linked below to determine their authenticity and address the specific and fair questions we have asked.

I must tell you in fairness, I am not a lawyer, but based on the facts and testimony I have gathered and on belief, the revelations in my report involve possible crimes committed in Egypt by Al Jazeera in its operation, including wiring money to your lawyer's bank account to be paid out in cash, to, who you claimed at the time, was your "staff." I am told the money that you wired (\$1.5 million), your lawyer discovered, was instead to pay protesters. You asked to allow someone to arrive at his office to pick up cash instead of registered payments by cheque. Other allegations include your use of illegal TVU equipment for Mubasher Misr broadcasts and the attempt to operate this live news channel in Egypt without registering properly in compliance with Media City rules including money to be kept on deposit and maintaining an office.
