You appealed the action of the National Records Center regarding your request for access to records pertaining to Brigido Acosta Luis, dated December 10, 2013. The original determination of the National Records Center was to withhold 43 pages in part and 41 in full.

After careful consideration of your appeal, and as a result of discussions with the National Records Center, we have decided to release 5 additional pages to you, copies of which are enclosed. We are releasing these pages in part. We have redacted information pursuant to 5 U.S.C. §§ 552 (b)(6) and (b)(7)(C).

On the remaining pages, we found that the National Records Center properly withheld certain information that is protected from disclosure. We have determined that this information is not appropriate for discretionary release.

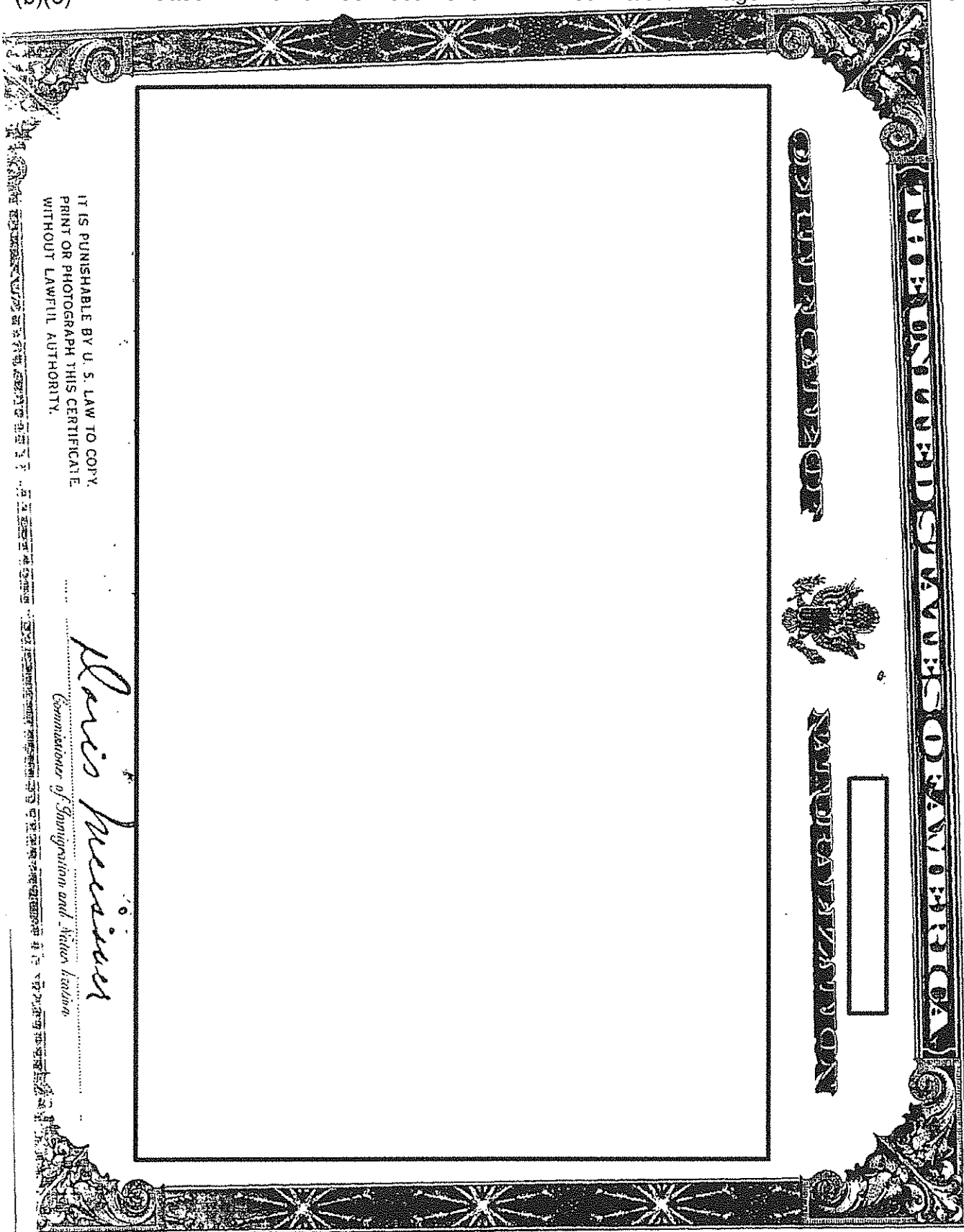
