This letter is a follow-up to my October 27, 2014 letter in response to your FOIL request dated October 20, 2014 that was received by the ECB on October 20, 2014 requesting:

"Any and all DSNY or ECB violations in which the respondent is 2010 7-201 West 120 LLC for the property located at 2010 7<sup>th</sup> Avenue, New York, New York 10027.

I seek violations dating from August 16, 2013 through the date when this request is processed, both open and closed.

I also seek correspondence between the DSNY or ECB and 2010 7-201 West 120 LLC, as well as any fines or dispositions related to any violations".

ECB has conducted a search on its electronic system to identify Notices of Violation ("NoVs") issued to the Respondent, 2010 7-201 West 120 LLC for the property located at 2010 7<sup>th</sup> Avenue, New York, NY 10027 from August 16, 2013 to the present.
