SUBJECT: Freedom of Information Act Request; Office of Tribal Justice

Dear Ms.Gerson:

The following request is filed pursuant to the Freedom of Information Act (5 U.S.C. § 552, *et. seq.*). As detailed in this letter, our request for agency records relate to events surrounding official activities performed by a former Director, Executive Office for U.S. Attorneys ("EOUSA"), Mr. Guy Lewis, EOUSA personnel, as well as the Office of Tribal Justice.

From 2002-2004, Mr. Lewis served as the Executive Director of the EOUSA. On or about 2004 due to fraud, travel malfeasance and/or other professional misconduct, Mr. Lewis was relieved of his duties as the EOUSA Executive Director. Our specific requests for information are as follows:

1. Agency records that detail Office of Tribal Justice collaboration with Mr. Lewis;
2. Agency records that detail Office of Tribal Justice collaboration with the office of AOUSA during the above referenced time frame;
3. Agency records related to any complaints against the office of AOUSA from Indian Country, individual Native-Americans or Native American Indian Tribes during the above reference time frame;


4. Agency records that detail the alleged professional misconduct that led to Mr. Lewis's termination in 2004.

As the Miccosukee Tribe of Indians of Florida is in ongoing litigation involving Mr. Lewis and his law firm, Lewis Tein, PL, for professional misconduct while he represented the Tribe in the past, the Miccosukee Tribe respectfully requests expedited consideration of this FOIA matter. The information requested herein is critical to the Tribe's case. A copy of the two civil complaints filed against Mr. Lewis in the state and federal courts of Miami-Dade County, Florida is enclosed for your information.

The Miccosukee Tribe is willing to pay fees up to a maximum of \$100. If you estimate that the fees will exceed this limit, let us know first.
