

On 02/27/2013 I traveled to [REDACTED], Wichita KS to assist Task Force Officers in locating Steven Jerome DENSON. DENSON had a State Parole warrant.

Upon arrival we developed reasonable suspicion that DENSON was in the residence. We knocked on the door but did not get an answer. We announced "Police come to the door" numerous times. While knocking on the door a thin piece of wood fell off the door. This allowed us to reach into the residence and unlock the door. Before making entry into the house we announced our presence numerous times. After making entry we entered the living room. From the living room I could see into the southwest bedroom because the door was open. In the bedroom I saw a black male lying in a bed. This person was identified as Steven Jerome DENSON. DENSON was placed in handcuffs. I then assisted with checking the southeast bedroom for unknown threats. While looking into the closet I saw two long guns in plain view. I notified TFO Bansenmer of the guns. The first long gun was a Western Field bolt action model M172 12 gauge shotgun. The magazine was missing and the bolt action was open with no ammunition. The second long gun was a Stevens Savage Arms bolt action model M-15-A .22 LR. The bolt action was open with no ammunition.

I then notified Special Agent Neil Tierney with the ATF about the weapons. The weapons were secured by KDOC. DENSON was transported to the Sedgwick County Jail.
