## Agreement Between Uber Technologies, Inc. and the City of Boston On the Provision of Uber City Data

This Agreement is entered into this 12<sup>th</sup> day of January, 2015, between the City of Boston (hereinafter the "City"), and Uber Technologies, Inc. (hereinafter "Uber") (collectively, the "Parties").

WHEREAS, with tens of thousands of Uber rides on the streets of Boston everyday, Uber desires to voluntarily share with the City certain proprietary and sensitive commercial data that will help serve city planning and the public interest.

WHEREAS, the City believes that this data will help City government policymakers and researchers develop a more detailed understanding of the traffic implications, commute patterns, and location of tens of thousands of daily trips.

WHEREAS, the Parties share the view that this data can help improve traffic planning, congestion reduction, pedestrian safety, passenger safety, movement of residents across the City, emergency and disaster planning, and beneficially contribute to other activities related to City transportation, as well as assist in identifying zoning changes and needs, opportunities to create or reducing parking, prioritize street remediation projects, facilitate additional transportation solutions for marquee City initiatives like championship celebrations, Olympic bids, and many more possibilities.

WHEREAS, the Parties have a shared vision that smart cities generally should benefit from such smart data.

In consideration of the above, Uber and the City have reached the following agreement:

- 1. Uber will provide to the City the following proprietary and sensitive commercial information (hereinafter "Uber's confidential information"):
  - a. anonymous pick-up and drop-off location of each Uber trip, by Zip Code Tabulation Area (ZCTA) and by neighborhood (using the attached boundaries supplied by the City) that originates and/or ends in the City;
  - b. the date-stamp and approximate time-stamp of each trip that originates and/or ends in the City;
  - c. the duration of each trip that originates and/or ends in the City;
  - d. wait time for rideshare vehicles to arrive if similar data is provided to the City by taxi companies.
- 2. Uber will provide the first tranche of Uber's confidential information within ten (10) days of the final execution of this agreement and then on a quarterly basis thereafter.
- 3. Uber also will provide limited technical support to the City to interpret and use Uber's confidential information subject to the availability of its resources.

- 4. The Parties agree that Uber's confidential information constitutes Uber's trade secrets or commercial or financial information that is exempt from disclosure pursuant to M.G.L. c. 4, sec. 7(26)(g) of the Massachusetts Public Records Law. All information that is claimed by Uber to be confidential information must be clearly identified as such by Uber when provided to City.
- 5. The Parties agree that Uber is providing such information voluntarily for use in developing the City's governmental policies.
- 6. The Parties further agree that Uber's confidential information is not being submitted by law or as a condition of receiving a governmental benefit.
- 7. The City shall keep confidential Uber's confidential information except as described in paragraphs 9, 10, 11 and 12 herein.
- 8. If the City receives a request for Uber's confidential information pursuant to the Massachusetts Public Records Law or is sued in order to obtain the disclosure of such information, the City shall promptly notify Uber upon receipt of such request or lawsuit so as to afford Uber the opportunity to take steps to prevent disclosure. Uber agrees at its expense to defend and indemnify the City against any lawsuit or administrative proceeding against the City for failure to disclose Uber's confidential information, including court costs and reasonable fees of attorneys, provided that the City shall obtain Uber's express written consent prior to retaining any outside law firm to represent the City, which consent will not be unreasonably withheld, and shall regularly consult with Uber regarding costs or fees associated with defending such a claim. Notwithstanding the above, Uber shall not have a duty to defend or indemnify the City if Uber notifies the City that Uber does not support withholding Uber's confidential information from disclosure but the City nevertheless chooses to continue to withhold such information, or if the City does not publicly support in court or an administrative proceeding withholding Uber's confidential information from disclosure contrary to Uber's position.
- 9. In the event the City is ordered by a court of competent jurisdiction that a portion or all of Uber's confidential information is not required to be kept confidential or does not constitute trade secrets or commercial or financial information exempt from disclosure, or disclosure is otherwise required by law, the City shall provide Uber notice before complying with the court order or law, unless such notice is prohibited by law or court order, so that Uber may take appropriate actions, including an appeal and stay of the court order or legal challenge of the law.
- 10. The City may disclose Uber's confidential information pursuant to a valid, legally binding subpoena; provided, however, that the City shall provide Uber reasonable notice before complying with a subpoena so that Uber may seek to quash the subpoena, if so desired, unless such notice is prohibited by law.
- 11. The City may include aggregate data, and conclusions drawn from the study or analysis of Uber's confidential information in publicly available reports, presentations, plans, press releases and other publications or any other City work product derived from Uber's confidential information, as long as none of Uber's confidential information is disclosed to the public, and provided that the Parties will first jointly develop standards to allow for such use without the need for prior approval from Uber.

- 12. The limitations on disclosure in this Agreement shall not apply to information where Uber agrees in writing that the specific information can be disclosed.
- 13. Within the City government, the City may only share Uber's confidential information with City employees or contractors who have a need to use the confidential information for City purposes. The City shall ensure that any contractors with whom it shares Uber's confidential information are subject to the confidentiality obligations set forth herein.
- 14. This Agreement will remain in force for one year and shall automatically be renewed for subsequent one-year periods unless either Party provides notice of termination in accordance with Paragraph 15.
- 15. Either Party may terminate this Agreement, at any time, for any reason, by giving not less than thirty (30) days' prior written notice thereof to the other Party.
