





Hi Darrell --Here is my answer.

The main result of Strong and Davis [2007] is that wintertime jet core speeds have increased in the 1958-2007 timeframe at northern midlatitudes. This result does not have obvious importance to summertime pollution in the United States. Using the same dataset at Strong and Davis [2007], Leibensperger et al. [2008] showed that the frequency of cyclones tracking across eastern North America in the 40-500 N latitudinal band strongly predicts the frequency of summertime pollution episodes in the eastern United States. Leibensperger et al. [2007] further identified a 1980-2007 decline in summertime cyclone frequency in this band, and Mickley et al. [2004] projected that such a decline will continue in the future atmosphere.

Both Leibensperger [2007] and Mickley et al [2004] cite weakening baroclinicity as one cause for the observed and modeled declines in cyclone frequency at 40-500N in eastern North America in summer. (Another cause, cited by Mickley et al. [2004], is more efficient meridional transport of latent heat in the future climate.) During the 1958-2007 time period, Strong and Davis [2007] found increasing baroclinicity farther north in eastern North America, at 50-600N. If such an increase also took place in summer during this time period, one would expect the region of the increase to be shifted still farther north, well away from the 40-500N band important to ventilation of summertime US pollution.
