



Four Corners District Confirms its First Case of Travel-Related COVID-19

As of Monday, March 30, 2020, Four Corners Health Department has confirmed its first case of COVID-19. A man in his 50's in York County has tested positive for the virus. This case has been determined by Four Corners to be travel-related.

He has minor symptoms and is currently self-isolating at home. He has had very minimal contact with others, and is considered a low-risk to the community.

To help prevent the spread of COVID-19, everyone should do the following:

- Wash your hands often
- Avoid close contact
- Stay home if sick
- Cover coughs and sneezes
- Clean and disinfect
- Avoid touching your eyes, nose and mouth

Four Corners District Has Second Positive Lab-Confirmed COVID-19 Test

As of Friday, April 3, 2020, Four Corners Health Department reports a second lab confirmed COVID-19 case in York County. The new case is a female in her 30's, and the situation is under investigation. More information will be forthcoming as available.

As we continue to address COVID-19 in our area, we remind you of our community goals: 1) To slow the spread of COVID-19 and, 2) To protect in particular individuals at increased risk for severe illness, including older adults and persons of any age with underlying health issues as well as Healthcare and critical infrastructure workers.

Symptoms of the disease include a fever, cough, or shortness of breath. If you have COVID-19 symptoms, call your health care provider and tell them how you are feeling. Please notify them of any potential exposure to a confirmed case of the COVID-19. It's important that you call ahead before you go to the doctor's office. Do not go to the emergency room unless it is essential.

To reduce the spread of the virus, residents stay home as much as possible and practice social distancing (at least 6 feet between you and another person). Practice frequent hand washing with soap and water for at least 20 seconds. If soap and water are not available, use a hand sanitizer with at least 60 percent alcohol. Cover your nose and mouth when you cough or sneeze. Avoid touching your eyes, nose and mouth with unwashed hands. Clean and disinfect surfaces regularly.

Four Corners Health Department Reports First Positive COVID-19 Case in Seward County

Saturday, April 4, 2020, Four Corners Health Department (Butler, Polk, Seward and York Counties) reports its third confirmed case of COVID-19. This is the first case reported in Seward County. The new case is a male in his 60's, who worked outside the health district, where it is believed he contracted the virus. He has been isolating at home since becoming ill.

Symptoms of the disease include a fever, cough, or shortness of breath. If you have COVID-19 symptoms, call your health care provider and tell them how you are feeling. Please notify them of any potential exposure to a confirmed case of the COVID-19. It's important that you call ahead before you go to the doctor's office. Do not go to the emergency room unless it is essential.

To limit the spread of the virus:

- Stay home if you feel unwell
- Practice social distancing (at least 6 feet between you and another person)
- Wash your hands often and use hand sanitizer
- Cover your nose and mouth when you cough or sneeze
- Don't touch your eyes, nose and mouth with unwashed hands
- Clean and disinfect surfaces regularly.

Four Corners Health Department Reports Its First Positive COVID-19 Case in Polk County

Thursday, April 9, 2020, Polk County's first positive case of COVID-19 has been reported by the Four Corners Health Department. A woman in her 40's has tested positive for the virus and is self-isolating in her home. Four Corners is investigating the situation to determine any possible exposures in the workplace and community. This is the fourth lab-confirmed case in the Four Corners District (Butler, Polk, Seward and York Counties).

Four Corners and the other local health departments in Nebraska join Governor Ricketts in urging every Nebraskan to do all we can to...

Stay Home, Stay Healthy, Stay Connected.

What could that mean to for you?

Stay Home

- **Stay home whenever possible.**
- **Avoid gathering in any groups** (if a group is necessary, limit it to no more than 10 people – and remember the 6 feet rule)
- **Do not visit or host people who do not live with you.** This includes family.
- Work from home if you can.

Stay Healthy

- Keep at least **6 feet distance from anyone you don't live with.**
- **Wash your hands**
- Stay home if you are sick or if someone in your home is sick.
- If you are an employer, make plans so that you employees can stay home when they need to.
- Cover your nose and mouth with a cloth mask when you are out in public.
- Shop 1x each week, alone, and be efficient. Avoid browsing

Stay Connected

- **Stay in touch with friends and loved ones** by using your phone, tablet, computer, letters, or cards.
- **Check in on** neighbors and other **people who may be alone or need help.**

All Nebraskans need to act, today to limit the impact of coronavirus on our communities.



Cases of COVID-19 Community Spread Determined in Polk and York Counties

Friday, April 10, 2020, Four Corners Health Department (FCHD) has identified its first lab confirmed cases of community spread of COVID-19 in Polk and York Counties. During the investigation process, staff at Four Corners were unable to identify how or where the people became exposed to COVID-19. The Polk County case is a woman in her 40's and was reported yesterday as "under investigation" (April 9, 2020). A new lab-confirmed case is being reported today in York County, a man in his 40's; this is the third case in York County and the first case of community spread. This case is self-isolating at home.

To date, the Four Corners District (Butler, Polk, Seward and York Counties) reports 5 cases of COVID-19. Butler County is the only county still without a lab-confirmed case. York County has had 3 cases; Polk and Seward Counties each have had one.

FCHD continues to monitor the situation 24-hours a day, seven days a week and has measures in place to detect any cases quickly and to minimize the spread of the virus.

Symptoms of COVID-19 include fever, cough, and shortness of breath or difficulty breathing. Those who experience these symptoms should self-quarantine and call their health care providers for recommended follow up before visiting. If you need help accessing care, contact the Four Corners Health Department at (877) 337-3573. Do not go to the emergency room unless it is essential.

To reduce the spread of the virus, residents need to stay home and practice social distancing (at least 6 feet between you and another person). Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use a hand sanitizer with at least 60 percent alcohol. Cover your nose and mouth when you cough or sneeze. Avoid touching your eyes, nose and mouth with unwashed hands. Clean and disinfect surfaces regularly.

Cases of COVID-19 Community Spread Determined in Polk and York Counties

As of late afternoon on Sunday, April 12, 2020, two new people have been lab-confirmed with COVID-19 in the Four Corners (Butler, Polk, Seward and York Counties).

A man in his 30's in Polk County has been diagnosed with COVID-19 and is self-isolating at home. Contacts with this case have been identified and are self-quarantining at home.

A man in his 60's in York County has also been tested and confirmed as having COVID-19. He, too, is isolating at home, and his contacts are self-quarantining.

This brings the Four Corners COVID-19 case total to 7. Seward County has had one case; Butler County case count is still at zero.



New Lab-Confirmed COVID-19 Case in Four Corners District as of Tuesday evening, April 14, 2020

As of late afternoon on Tuesday, April 14, 2020, one new person has been lab-confirmed with COVID-19 in the Four Corners District (Butler, Polk, Seward and York Counties).

A woman in her 40's in York County has tested positive for COVID-19 and is self-isolating at home. Contacts with this case have been identified and are self-quarantining at home.

This brings the Four Corners COVID-19 case total to 8. York County has 5 positive cases; Polk County - 2; Seward County - 1; Butler County case count is still at zero.

Four Corners Reports Another Person Positive for COVID-19 in Polk County

April 15, 2020, Another person has tested positive for COVID-19 in Polk County for a county total of 3 positives. This brings the Four Corners District (Butler, Polk, Seward and York Counties) total to 9. A woman in her 20's, who is a close contact of a previous COVID-19 case and has been in self-quarantine, is the latest Polk County resident to test positive. This brings the Four Corners District COVID-19 case total to 9. York County positive case total is 5; Polk County – 3; Seward County – 1; Butler County case count is still at 0.

Slow the Spread of the Virus – How Cloth Face Coverings Can Help

The spread and effects of the novel coronavirus (COVID-19) across the United States continues to be studied. We now know from recent studies that a good number of people with COVID-19 don't have symptoms. Those who eventually do develop symptoms can spread the virus to others before showing any signs of having it.

In light of this new information, the Centers for Disease Control and Prevention (CDC) recommends wearing cloth face coverings in public settings, such as grocery stores and pharmacies, and especially where community spread is occurring.

Most important though is that everyone wearing a face covering still keep 6 feet distance between themselves and other people. This is a key practice for slowing the spread of the virus. CDC also advises the use of simple cloth face coverings to slow the spread of the virus. The cloth face coverings can help people who may have the virus, and do not know it, from spreading it to others. Cloth face coverings can be made at home from common materials at a low cost.

Visitors and patients should be wearing a cloth face covering when arriving at a health care facility. Cloth face coverings should not be placed on young children under age 2, anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the face covering without assistance.

How to Wear a Cloth Face Covering

Cloth face coverings should—

- Cover mouth and nose area, with the top of the face covering fitting just below the eyes and the bottom of it extending to cover the chin.
- fit snugly but comfortably against the side of the face, covering about half of the person's cheek.
- be secured with ties or ear loops
- include multiple layers of fabric
- allow for breathing without restriction
- be able to be laundered and machine dried without damage or change to shape. A washing machine works well for cleaning a face covering. There is no mention of microwaving as a reliable way to clean these.

Today, newly diagnosed persons include one (1) Polk County resident; one (1) York County resident:

Polk County

- 1 male in his 20s. He is self-isolating at home. Contacts have been identified and are self-quarantining.

York County

- 1 male in his 30s. He is self-isolating and contacts are in quarantine.

Gov. Ricketts': Six Rules to Keep Nebraska Healthy

1. **Stay home.** No non-essential errands and no social gatherings. Respect the ten-person limit.
2. **Socially distance your work.** Work from home or use the six-foot rule as much as possible in the workplace.
3. **Shop alone and only shop once a week.** Do not take family with you.
4. **Help kids follow social distancing.** Play at home. No group sports. And no playgrounds.
5. **Help seniors stay at home by shopping for them.** Do not visit long-term care facilities.
6. **Exercise daily at home or with an appropriately socially-distanced activity.**



Friday, April 17, 2020, Four Corners Health Department (FCHD) has identified its first lab confirmed case COVID-19 in Butler County. The individual is a male in his 20's. Another lab confirmed case has been identified in Polk County. The individual is a male in his 50's. Both of the individuals are self-isolating at home.

Four Corners is reporting daily any new individuals who are laboratory-confirmed with COVID-19. The District's count (Butler, Polk, Seward and York Counties) has increased by 2 cases today for a new total of 13 cases. Today, newly diagnosed persons include one (1) Polk County resident; one (1) Butler County resident:

Four Corners Health Department Update on COVID-19 Case Numbers for Saturday, April 18, 2020

Two more laboratory-confirmed cases of COVID-19 are being reported by the Four Corners Health Department for Saturday, April 18, 2020:

Seward County: A male in his 40's tested positive for COVID-19. He is self-isolating at home and his contacts are quarantining.

York County: A male in his 40's has been tested and diagnosed with COVID-19. He is also isolating himself at home. Four Corners is tracing contacts and notifying those identified to self-quarantine.

Lastly, Four Corners has identified that people who visited the Ace Rent-To-Own in the city of York on Monday April 13, during regular store hours, have possibly been exposed to COVID-19. The Ace-Rent-To-Own, located at 700 S. Lincoln Ave. in York, had previously implemented extra infection control precautions within the store, so this is considered a low-risk exposure situation. However, for those visiting the store that day, Four Corners advises those people to monitor themselves for fever, cough and shortness of breath through Tuesday, April 28, and diligently practice social distancing. If symptoms develop, please isolate immediately and contact your medical provider.

Saturday's newest COVID-19 cases bring the Four Corners District total to 15. York County total is 7, Polk County 5, Seward County 2 and Butler County has 1.

April 20, 2020--It is with deep sadness that Four Corners Health Department (FCHD) is announcing the first coronavirus disease (COVID-19) related death of a Seward County resident, a woman in her 50's with underlying health conditions. She was transported to the hospital by rescue squad, and was pronounced dead at the hospital.

"We share our condolences with the family of this individual," said Laura McDougall, FCHD Executive Director. "It is a grim reality that there will be deaths from COVID-19 in our Four Corners' counties, and this reveals the potential seriousness of the disease. The measures we are taking as individuals and as a state to help slow the spread of the virus are crucial. As we all hold this family in our thoughts, we urge everyone to continue to practice social distancing."

An additional case of COVID-19 has been laboratory-confirmed in York County. A woman in her 40's has tested positive and is self-isolating at home.

Total COVID-19 cases in the District now total 17: York County has 8, Polk County 5, Seward County 3 (1 Death), and Butler County remains at 1.

According to the Centers for Disease Control and Prevention (CDC), certain people are at higher risk of getting very sick from COVID-19 including older adults and people of any age who have serious underlying medical conditions like heart disease, diabetes, and lung disease, or who are immune-compromised.

One new case of COVID-19 was lab-confirmed in the Four Corners District (Butler, Polk, Seward and York Counties) for April 21, 2020. A Seward County resident is the newest individual to test positive—a male in his 50's who is self-isolating at home.

COVID-19 case totals today for the Four Corners District are 18, including 1 death, and 8 people have recovered. The breakdown of cases: York County has had 8, Polk County 5, Seward County 4, and Butler County remains at 1.



Two additional cases of COVID-19 are lab-confirmed in the Four Corners District

April 23, 2020—Two additional cases of COVID-19 are reported in the Four Corners District: one in Seward County, and one in York County. Both cases are direct contacts of other previously-reported known COVID-19 cases.

Seward County: A male in his 30's has tested positive and is self-isolating at home.

York County: A male in his 40's was diagnosed and is self-isolating at home.

Total COVID-19 cases for the Four Corners District are now at 20. York County has 9, Seward County 5 (including one death), Polk County 5, and Butler County remains at 1. Total recoveries number 11.



Nebraska National Guard Tests 89 people for COVID-19 in York

April 24, 2020, This is the first time the Four Corners Health Department was able to provide mass testing.

With the help of state and local health officials, the Nebraska National Guard tested 89 people that were pre-identified by the Four Corners Health Department. For several days ahead of the event, staff worked with medical providers, businesses, and others to schedule higher risk individuals. The priorities for this event were close contacts of those who have a positive COVID-19 test, those who had symptoms and hadn't been tested yet, and individuals who employers felt needed to be tested.

"This mass testing event was offered to us through the Nebraska Department of Health and Human Services. They asked me if I wanted to do some mass testing and my team gave a resounding "Yes!", said Executive Director, Laura McDougall. "We want to get a better picture of the level of COVID-19 within our communities, which hopefully can be provided by the expanded testing" she said.

The results from the event in York were received on Friday, April 24th. Of the 89 individuals tested, there was one positive case identified. This case is a male from Seward Co. in his 50's, with a known contact to another positive case. He is self-isolating at home.

McDougall stated that "our team felt very positive about the outcomes of the event. It was rewarding to see that the extra precautions and social distancing being done in the district has been paying off. None of us expected the number of positives to be so low, and it was a great way to end our week."

The total number of COVID-19 cases in the Four Corners District is 21. York County has 9, Seward County 6 (including one death), Polk County 5, and Butler County remains at 1. Total recoveries number 11.



Four Corners COVID-19 Cases Increase by One

April 25, 2020—Four Corners Health Department is reporting a new case of COVID-19 in a young person (a minor). The individual is a male residing in York County, and is isolating at home. Close contacts of the case have been notified and are in quarantine.

Upon investigation, it has been determined that there has been a low-risk exposure to this person for those people who may have been in Grand Central Foods on Monday, April 20, 2020 from 4-6:45 pm. This is considered a LOW-RISK exposure because the individual wore a mask during their time at Grand Central, and the team at the store was actively disinfecting surfaces as part of their infection control protocols. In fact, management at Grand Central requires staff with customer contact to wear a mask and promotes the use of masks by customers in the store.

Symptoms of COVID-19 include fever, cough, shortness of breath. Some have experienced a sore throat, a loss of taste and/or smell, headache and extreme tiredness. If you are experiencing these symptoms, call your medical provider to see if you may need to be tested. The latest case brings the total COVID-19 cases to 22 in the Four Corners District. York County has 10 positives, Seward County 6, Polk County 5 and Butler County remains at 1.



Four Corners Health Department Reports New Cases of COVID-19 in Butler and York Counties

April 26, 2020—Butler County has its second lab-confirmed case of COVID-19. A male in his 30s has tested positive as a result of workplace testing outside the Four Corners District. He is self-isolating at home.

A woman in her 50's from York County has also been lab-confirmed with COVID-19. She is a direct contact of an earlier case in York County, and is self-isolating at home.

This brings the Four Corners total COVID-19 cases to 24. Butler County has 2 confirmed cases, York County 11, Seward County 6 and Polk County 5.



Four Corners Health Department Daily Report of New COVID-19 Cases

April 27, 2020—Seward County has a new lab-confirmed case of COVID-19. A female in her 30s has tested positive and is self-isolating at home. She developed symptoms and was tested after being in quarantine because of contact with another known case.

This brings the Four Corners total COVID-19 cases to 25. Seward County has 7 cases, York County 11, Polk County 5, and Butler County 2. A total of 15 people have recovered from the virus.



Four Corners Health Department Daily Report of New COVID-19 Cases

April 28, 2020—Butler County has a new lab-confirmed case of COVID-19. A male in his 50s has tested positive and is self-isolating at home. Additional COVID-19 cases are being identified at his worksite outside the District.

This brings the Four Corners total COVID-19 cases to 26. Butler County has 3 cases, York County 11, Seward County 7 (including 1 death), and Polk County 5. A total of 16 people have recovered from the virus.



Four Corners Health Department Reports Two New COVID-19 Cases in Polk County

April 29, 2020—Four Corners Health Department reports two new lab-confirmed cases of COVID-19 in Polk County. A male in his 50s and female in her 20s have tested positive and are both self-isolating at home. Both cases are related and originated at a worksite outside the District.

This brings the Four Corners total COVID-19 cases to 28. Polk County has increased to 7 cases, York County has 11, Seward County 7 (including 1 death), and Butler County 3. A total of 16 people have recovered from the virus.



Four Corners Health Department Reports Three New Cases of COVID-19

April 30, 2020—As of today, Four Corners Health Department (serving Butler, Polk, Seward and York Counties) reports three new lab-confirmed cases of COVID-19:

- Seward County—A male, who is a minor, who is isolating at home. His COVID-19 disease is a result of community transmission outside the district.
- Butler County—A female in her 40's, who is self-isolating at home. She works outside the district where additional cases have been found.
- Butler County—A male in his 60s, who is self-isolating at home. He works outside the district where additional cases are being identified.

This brings the total of COVID-19 cases to 31 in the Four Corners District. Butler has 5 cases, Polk 7, Seward 8 and York 11. There are now 20 recovered individuals.

Four Corners Health Department Daily COVID-19 Report

May 2, 2020—Four Corners Health Department announces two cases of COVID-19:

- Polk County—A male in his 30's has tested positive for COVID-19 and is self-isolating at home. This case is associated with a workplace outside the District.
- Butler County—A male in his 50's has been hospitalized and lab-confirmed for COVID-19. He and his contacts are associated with a workplace outside the District.

Management at Subway requires social distancing in the venue and the use of masks by staff. In addition, there is no current evidence that takeout or drive-thru meals will increase the chances of getting sick with COVID-19.
