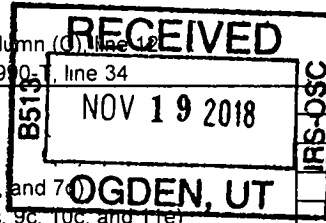

During 2016 the Organization participated in a number of significant amicus briefs before the U S Supreme Court including merits briefs in Little Sisters of the Poor v Burwell and U S v Texas and a cert-stage brief in United Student Aid Funds v Bible. It also filed amicus briefs at other courts, including in Veasey v Abbott in the U S Court of Appeals for the Fifth Circuit. The Organization engaged in significant education and media efforts regarding the aforementioned cases as well as others including Friedrichs v California Teachers Association, Whole Women's Health v Hellerstedt, U S v Texas, Matal v Tam, Murr v Wisconsin, Trinity Lutheran Church of Columbia v Comer. The Organization conducted legal research on the original understanding of the Commerce Clause, the Wisconsin John Doe law, felon voting in Virginia, and the validity of certain railway regulations
