During 2015 the Organization participated in a number of significant amicus briefs before the US Supreme Court, including merits briefs in Evenwel v Texas, Fisher v. Texas, Perez v. Mortgage Bankers Association, and Nichols v Mortgage Bankers Association, both cert- and merits-stage briefs in Friedrichs v. California Teachers Association, and a cert-stage brief in Little Sisters of the Poor v. Burwell. It also filed briefs at other courts, including an amicus brief in Dept. of Transportation v Association of American Railroads with the D.C. Circuit. The Organization engaged in significant education and media efforts regarding the aforementioned cases as well as others including Reed v. Town of Gilbert, Williams-Yulee v. The Florida Bar, EEOC v Abercrombie & Fitch, King v Burwell, Horne v Dept of Agriculture, and Obergefell v Hodges. The Organization conducted legal research on campus crime, Wisconsin's John Doe law, libel law, association privacy rights, and federal college accreditation.
