Dear Ms. Cafasso:

This correspondence is in response to your Freedom of Information Act (FOIA) request dated and received in the Office of the Pardon Attorney (PARDON) on April 17, 2018. I apologize for our delayed response, but we are a very small office with limited resources, so we have to prioritize mission critical work over all other responsibilities. Nonetheless, pursuant to the Freedom of Information Act, 5 U.S.C. § 552 et seq., you originally requested all emails that contain the words Scooter, Libby, Cheney, Plame, or Fitzgerald between April 11, 2018 and April 16, 2018. However, on Monday, December 4, 2020, you narrowed the scope of your request to only include emails that meet the scope but were also sent by an official the Office of the Attorney General, the Office of the Deputy Attorney General, the Office of Public Affairs, or the Office of the Pardon Attorney.

After carefully considering your request, I have determined that the attached 21 pages are appropriate for release with redactions pursuant to 5 U.S.C. § 552(b)(5), which concerns certain inter- and intra-agency communications protected by the deliberative process privilege, as well as 5 U.S.C. § 552(b)(6), which concerns material the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties. Please also be aware that I am withholding an additional 28 pages in full because those communications are protected pursuant to 5 U.S.C. § 552(b)(5), which concerns certain inter- and intraagency communications protected by the deliberative process privilege as well as the presidential communications privilege.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.


