Subject: US Marshals Expenditures for deployment to Portland, Oregon between June 1, 2020 and August 12, 2020.

Dear Mr. Evers:

The United States Marshals Service (USMS) is responding to your Freedom of Information Act (FOIA) requests pertaining to expenditures related to federal officials who deployed to Portland, Oregon between June 1, 2020 and August 12, 2020.

The FOIA and Department of Justice (DOJ) regulations allow the USMS to aggregate requests if they concern clearly related matters. Because of the similarity of your requests, they were aggregated and processed under 2020USMS35573.

Pursuant to your request, the USMS conducted a search of records in its Financial Services Division (FSD). To respond to your request as efficiently as possible, FSD compiled the information you requested in aggregate, as indicated in the table below:

Payments or reimbursements include any payments associated with travel, lodging, the cost of government transportation, individual airfare for employees, meals, per diem payments, rental vehicles, overtime payments, payments made via government issued charge cards or travel cards, or other reimbursable expenses. American Oversight has previously received this information in an aggregated form from federal agencies."

If your office does not have records that compile, aggregate, or total those costs, then American Oversight requests any and all invoices reflecting expenses at any lodging or hotels located in the greater Portland, Oregon, which were incurred from June 20, 2020 to August 12, 2020, by federal officials employed at your agency."

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2006 & Supp. IV (2010)). Your appeal must be postmarked or electronically transmitted within 90 days of the date of my response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
