Pursuant to the federal Freedom of Information Act, 5 U.S.C. § 552, I request access to and electronic copies of any FBI records from July 26, 1908 to the date of this request on the following deceased American:

Senator Frank Forrester Church

Per FBI FOIA guidelines, I have attached to this request the page on Senator Church from the Biographical Directory of the United States Congress. Senator Church was born on July 25, 1924 in Boise, Idaho and died on April 7, 1984 in Bethesda, Maryland.

As to any records located in investigative files for investigations, the FBI may not assert Exemption 7(A) without conducting a document-by-document review to determine whether release of the records would interfere with ongoing law enforcement proceedings.

The United States District Court for the District of Columbia recently "remind[ed] the FBI of its obligation to conduct record-level reviews at the administrative level before refusing to produce records contained in its investigative files." *Tipograph v. Dep't of Justice*, 83 F. Supp. 2d 234, 236 (D.D.C. Mar. 18, 2015).

In order to help to determine my status to assess fees, you should know that I am a policy analyst and scholar at the Cato Institute, an IRS-recognized 501(c)(3) nonprofit educational and public interest organization. As I am employed by an educational or noncommercial scientific institution, this request is made for a scholarly or scientific purpose and not for a commercial use. FBI material on Beard will be used in a book I am under contract to write for Georgetown University Press. Accordingly, I request a waiver of all fees for this request.

Disclosure of the requested information to me is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in my commercial interest.

Whenever possible, please provide the requested information in electronic Portable Document Format (PDF).

If my request is denied in whole or part, I ask that you justify all deletions by reference to specific exemptions of the act. I will also expect you to release all segregable portions of otherwise exempt material. I, of course, reserve the right to appeal your decision to withhold any information or to deny a waiver of fees.

Please provide expedited processing of this request which concerns a significant public policy matter. As a research fellow, my main function is disseminating information.

Senator Church was the leader of the investigative committee that bears his name and which exposed massive, illegal domestic surveillance by the FBI, CIA, and NSA, and I believe FBI records (both headquarters files and field office files) likely contain reporting on Senator Church and his activities, surveillance and related activities that would have been in violation of Senator Church's 1st and 4th Amendment rights under the Constitution. I certify that my statements concerning the need for expedited processing and fee waivers are true and correct to the best of my knowledge and belief.

I look forward to your determination regarding my request for expedited processing within 10 calendar days, as the statute requires. Thank you for your assistance.



CHURCH, Frank Forrester, a Senator from Idaho; born in Boise, Ada County, Idaho, July 25, 1924; attended the public schools; graduated from Stanford (Calif.) University in 1947 and from Stanford Law School in 1950; during the Second World War served in the United States Army and was assigned to Military Intelligence in India, Burma, and China 1942-1946; admitted to the bar in 1950 and commenced the practice of law in Boise, Idaho; elected as a Democrat to the United States Senate in 1956; reelected in 1962, 1968, and again in 1974 and served from

January 3, 1957, to January 3, 1981; unsuccessful candidate for reelection in 1980; chairman, Special Committee on Aging (Ninety-second through Ninety-fifth Congresses), Special Committee on Termination of the National Emergency (Ninety-second through Ninety-fourth Congresses), Select Committee on Government Intelligence Activities (Ninety-fourth Congress), Committee on Foreign Relations (Ninety-sixth Congress); United States delegate to the twenty-first General Assembly of the United Nations; resumed the practice of law; was a resident of Bethesda, Md., until his death there on April 7, 1984; interment in Morris Hill Cemetery, Boise, Idaho.

Thank you for your inquiry regarding the status of your Freedom of Information Act/Privacy (FOIPA) requests.

Requests are processed in the order in which they are received through our multi-track processing system. Requests are divided into two primary tracks--simple (under 50 pages of potentially responsive documents) and complex (over 50 pages of potentially responsive documents). Complex requests are further divided into medium, large, and extra-large sub-tracks based upon request size. Simple track requests typically require the least amount of time to process. Currently, simple track cases average approximately 106 days from the date of receipt for processing. Our complex requests in the medium processing track are currently averaging 785 days, large processing track are currently averaging approximately 1,695 days, and extra-large processing track are currently averaging 2,088 days for processing.

Frank Church (1438019-000): This request is being preprocessed to another open request on the same subject, meaning a request on the same subject had been received and was already in process prior to receipt of your request. To avoid duplicative efforts, you will receive the same releases at the same time as the original requester for this subject. The request to which yours will be preprocessed is presently assigned to a Disclosure analyst who is reviewing the records to determine if any redactions are required pursuant to subsections of Title 5, U. S. Code, Section 552 and 552a. The estimated date of completion is June 2021.

Barry Goldwater (1438619-000): The request is presently awaiting assignment to a Disclosure analyst who will then review the records to determine if any redactions are required pursuant to subsections of Title 5, U. S. Code, Section 552 and 552a. Your request is currently in the complex request large processing track, and the estimated date of completion for your request is March 2024.

Pursuant to the federal Freedom of Information Act, 5 U.S.C. § 552, I request access to and electronic copies of any FBI records from July 26, 1908 to the date of this request on the following deceased American:

Senator Barry Morris Goldwater

Per FBI FOIA guidelines, I have attached to this request the page from the Biographical Directory of the United State Congress on Senator Goldwater, who was born on January 1, 1909 in Phoenix, Arizona and died on May 29, 1998 in Paradise Valley, Arizona.

As to any records located in investigative files for investigations, the FBI may not assert Exemption 7(A) without conducting a document-by-document review to determine whether release of the records would interfere with ongoing law enforcement proceedings.

The United States District Court for the District of Columbia recently "remind[ed] the FBI of its obligation to conduct record-level reviews at the administrative level before refusing to produce records contained in its investigative files." *Tipograph v. Dep't of Justice*, 83 F. Supp. 2d 234, 236 (D.D.C. Mar. 18, 2015).

In order to help to determine my status to assess fees, you should know that I am a policy analyst and scholar at the Cato Institute, an IRS-recognized 501(c)(3) nonprofit educational and public interest organization. As I am employed by an educational or noncommercial scientific institution, this request is made for a scholarly or scientific purpose and not for a commercial use. FBI material on Goldwater will be used in a book I am under contract to write for Georgetown University Press. Accordingly, I request a waiver of all fees for this request.

Disclosure of the requested information to me is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in my commercial interest.

Whenever possible, please provide the requested information in electronic Portable Document Format (PDF).

If my request is denied in whole or part, I ask that you justify all deletions by reference to specific exemptions of the act. I will also expect you to release all segregable portions of otherwise exempt material. I, of course, reserve the right to appeal your decision to withhold any information or to deny a waiver of fees.

I would appreciate your communicating with me by email or telephone, rather than by mail. My email address is peddington@cato.org and my cell number is 571-215-3468.

Please provide expedited processing of this request which concerns a significant public policy matter. As a research fellow, my main function is disseminating information.

As a member of the Church Committee, Goldwater supported the domestic surveillance reform efforts promoted by the committee and related policies, and I believe FBI records (both headquarters files and field office files) likely contain reporting on Goldwater and his activities, surveillance and related activities that would have been in violation of his 1st and 4th Amendment rights under the Constitution. I certify that my statements concerning the need for expedited processing and fee waivers are true and correct to the best of my knowledge and belief.

I look forward to your determination regarding my request for expedited processing within 10 calendar days, as the statute requires. Thank you for your assistance.



GOLDWATER, Barry Morris, (father of Barry Morris Goldwater, Jr.), a Senator from Arizona; born in Phoenix, Maricopa County, Ariz., January 1, 1909; attended the Phoenix public schools, Staunton Military Academy, and one year at the University of Arizona at Tucson in 1928; began business career in 1929 in family mercantile business; during the Second World War entered active service in August 1941 in the United States Army Air Corps, serving in the Asiatic Theater in India, and was discharged in November 1945 as a

lieutenant colonel with rating as pilot; organized the Arizona National Guard 1945-1952; brigadier general in the Air Force Reserve in 1959 and promoted to major general in 1962; retired in 1967 after thirtyseven years service; member of advisory committee, Indian Affairs, Department of the Interior 1948-1950; member of the city council of Phoenix 1949-1952; elected as a Republican to the United States Senate in 1952; reelected in 1958, and served from January 3, 1953, to January 3, 1965; did not seek reelection to the Senate in 1964; unsuccessful Republican nominee for President in 1964; elected to the United States Senate in 1968; reelected in 1974 and again in 1980, and served from January 3, 1969, to January 3, 1987; did not seek reelection in 1986; chairman, Select Committee on Intelligence (Ninety-seventh and Ninety-eighth Congresses), Committee on Armed Services (Ninety-ninth Congress); awarded the Presidential Medal of Freedom on March 12, 1986; died May 29, 1998, at Paradise Valley, Ariz.; remains were cremated.
