Request under the Freedom of Information (Scotland) Act 2002

I refer to your correspondence received on 24th November 2020 in which you requested the following information be provided to you:-

- 1a) How many single homeless people were accommodated in B&Bs as of April 2020?
- b) How many single homeless people have been accommodated in B&Bs by the LA since April 2020?
- c) How many single homeless people are currently accommodated in B&Bs by the LA?
- 2) Of those single homeless people currently in B&B accommodation how many have been there for:
 - one to six days
 - * seven days to one month
 - * one month to six months
 - * six months to one year
 - more than a year
- 3a) What is the total cost (gross) of providing B&B accommodation since April 2020?
- b) How much additional governmental funding, received during the coronavirus pandemic, was spent on housing people in B&Bs (if any)?





The Council is treating your request as a request under the Freedom of Information (Scotland) Act 2002.

I can confirm that the Council holds the information you have requested, our response is as follows:-

- 1a) On 1st April 2020, there were 325 single homeless households accommodated in Bed and Breakfast.
- 1b) Between 1st April 2020 and 24th November 2020 (the date of your request) the number of single homeless households who have been accommodated in Bed and Breakfast is 2,294
- 1c) On 24th November 2020 (the date of your request) there were 464 single homeless households accommodated in Bed and Breakfast.
- 2. Of the 464 individuals noted in question 1c) (as at 24th November 2020):

58 had been in BnB for between one and six days 137 had been in BnB between seven days and one month 229 had been in BnB between one month and six months 36 had been in BnB between six months and one year 4 had been in BnB for over one year.

- 3a) The total cost of providing Bed and Breakfast accommodation between 1st April 2020 and 24th November 2020 was £7.52m
- 3b) To date, Glasgow City Council have received an additional 3.61m in funding in relation to the costs in question 3a).

As you may be aware, due to government guidelines around social distancing, Registered Social Landlords in the city have been significantly impacted and there have been unavoidable delays in letting properties to applicants, including those who are homeless. This has inevitably led to an increased demand on temporary accommodation within the city and the length of time households have spent in temporary accommodation has increased compared to the same time period last year.

I hope the information provided is helpful.

Right of Review

If you are dissatisfied with the way Glasgow City Council has dealt with your request under the Freedom of Information Act (Scotland) 2002 you are entitled to require the Council to review its decision. Please note that for a review to take place you must:

- Lodge a written requirement for a review within 40 working days of the date of this letter
- Include a correspondence address and a description of the original request and the reason why you are dissatisfied

You will receive notice of the results of the review within 20 working days of receipt of your request. The notice will state the decision reached by the reviewing officer as well as details of how to appeal to the Scottish Information Commissioner if you are still dissatisfied with the Council's response. You must request an internal review by the Council before a complaint can be directed to the Scottish Information Commissioner.
