Oceana's request was submitted nearly two years ago on December 1, 2017. We accommodated the agency and agreed to accept rolling productions, of which only one partial production was ever made and that was over a year and a half ago. We have not had anyone at the FOIA liaison office or the agency respond with the next production date, despite repeated follow-ups. Our last resort—which we are prepared to do—is litigating against the agency under FOIA, as the agency is well-past its statutorily mandated timeframe for a response. 
