Plaintiff, through her undersigned attorney, agrees to accept the Settlement Amount as full payment of any costs and/or attorney's fees that she has incurred in connection with this matter, as further set forth. 5. The parties understand and agree that this Stipulation and Order contains the entire agreement between them. No statements, representations, promises, agreements, or negotiations, oral or otherwise, between the parties or their counsel that are not included herein shall be of any force or effect. 6. This action is hereby dismissed with prejudice. provided that the Court shall retain jurisdiction over any issues that may arise relating to this Stipulation and Order. 7. This stipulation may be executed in counterparts. Facsimile or PDF signatures shall have the same force and effect as original signatures. SO ORDERED.
