**Narrative:** On Wednesday 10 FEB 21 at 1301hrs R/O SCHNEIDER #1822 was dispatched to investigate possible child abuse that was being reported by the Children's Advocacy Team at Children's Hospital, at 8400 W. Dodge Road. Upon arrival R/O spoke to nurse practitioner [REDACTED] who advised that a 5 month old child, victim [REDACTED], had been brought in by her mother, [REDACTED], to be examined for an injury on the left side of her head. [REDACTED] stated she and her husband noticed three areas of bruising on the left side of her head, near the temple, after they picked up [REDACTED] from her daycare, the Rosewood Academy, near 156/ Fort St., on Tuesday 09 FEB 21 around 1700hrs. Ashley stated she spoke with the director of Rosewood, "Emily", and she indicated that she nor her staff were aware of any instances where [REDACTED] could have injured her head, other than possibly when she had placed in an excersaucer during a portion of the afternoon hours.
