In my June 3, 2020, request, I asked for "all information related to the Case Investigative File ("Case File") or Case Files for the investigation(s) and report posted April 13, 2020, 'Report on the Joint Enterprise Defense Infrastructure (JEDI) Cloud Procurement," including the involvement of the Defense Criminal Investigative Service ('DCIS'), DCIS investigators, or any other Department of Defense Office of Inspector General investigators." On August 14, 2020, after informally narrowing this request to any DCIS Report of Investigation, your office produced a single, 22-page DCIS Report of Investigation ("ROI") into allegations against the first two of seven officials identified in the June 3, 2020, report. Those seven Department of Defense officials, as identified in the Table of Contents for the June 3, 2020, report are: "1. Mr. Deap Ubhi"; "2. Mr. Victor Gavin"; "3. Secretary James N. Mattis"; 4. Ms. Sally B. Donnelly"; "5. Mr. Anthony DeMartino"; "6. Mr. Robert Daigle"; and "7. Ms. Stacy Cummings."

Accordingly, I hereby request expedited production of: (a) any and all DCIS "Information Reports" or other DCIS "reports" -- other than the DCIS ROI produced on August 14, 2020 -- related to the April 13, 2020, "Report on the Joint Enterprise Defense Infrastructure (JEDI) Cloud Procurement"; and (b) any and all reports prepared by other investigators within the DoD Office of Inspector General, *e.g.*, "senior official" or "AI" investigators, related to the April 13, 2020, "Report on the Joint Enterprise Defense Infrastructure (JEDI) Cloud Procurement."

Finally, this request for information "urgently needed by an individual primarily engaged in disseminating information in order to inform the public concerning actual or alleged government activity." 32 C.F.R. § 286.8(e)(1)(i)(B). In this regarded, the undersigned, who served as the DoD Inspector General from 2002-05, regularly posts articles under the banner "Support and Defend" at https://www.newsmax.com/archives/josepheschmitz/164/2020/6/, many of which articles are designed "to inform the public concerning actual or alleged government activity." See, e.g., "IG Report on Comey Obscures That Strzok, Page Behind Key Determinations," September 13, 2019 (https://www.newsmax.com/josepheschmitz/comey-inspector-general-strzok-page/2019/09/13/id/932570/). Moreover, to quote your letter to the undersigned of June 5, 2020, in response to FOIA request DODOIG-2020-000915, the "information is urgently needed, beyond the public's right to know about the government activity generally. See 32 C.F.R. § 286.8(e)(1)(B) & (ii)(3)." Specifically, the following press articles, which are representative of many more, demonstrate, "The existence of numerous articles published on a
