Request for Production 4. Produce reports, summaries, or notes of any kind regarding the Regional TANF office's yearly telephonic reviews or the yearly in-person visits to the Mississippi Community Education Center 2017-2020.

<u>Request for Production 5</u>. Produce reports, summaries, or notes of any kind regarding the 2018 visit by LaMonica Shelton, Regional Program Manager Administration for Children and Families, Office of Family Assistance to the Mississippi Community Education Center.
