You appealed the action of the National Records Center regarding your request for access to records pertaining to Alfonso Noveron Gonzalez, dated April 15, 2014. The original determination of the National Records Center was to withhold 11 pages in part and 18 in full.

After careful consideration of your appeal, and as a result of discussions with the National Records Center, we have decided to release 9 additional pages to you, copies of which are enclosed. We are releasing these pages in part. We have redacted information pursuant to 5 U.S.C. §§ 552 (b)(6) and (b)(7)(C).

On the remaining pages, we found that the National Records Center properly withheld certain information that is protected from disclosure. We have determined that this information is not appropriate for discretionary release.

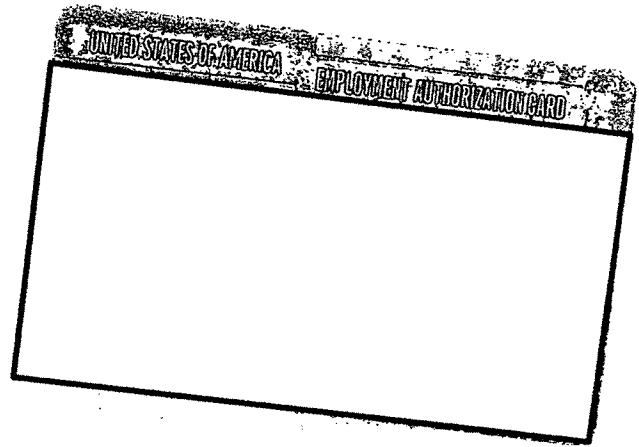
