Jeanette:

Hope you're doing well. Liz was kind enough to fly to RI yesterday, and I believe we had a very productive strategy session. I wanted to share with you some of the highlights.

1) SAVE THE DATE! Liz and I both thought that you should first immediately get a "SAVE THE DATE" notification out to Council Members and potential participants, as the time is ripe for plugging the event into everyone's calendar.

2) Preliminary Agenda: We discussed in detail the agenda, panels, speakers, etc. Liz is planning to prepare a draft agenda and will circulate it when completed. Our plan is to have something circulate the Council BEFORE the Orlando meeting to spur more

productive input from the Council.

3) Additional Council members: Thanks to Liz, we have list of additional potential council members from the industry. Our thinking is if we get more paying members, it takes the pressure off of you. To effectuate our plan, we need synergistic additions of commissioners from various states, as discussed in item 4 below.

4) New Commissioners to the Council: We have lost a few since your last update, and believe that following commissioners (and their respective states) should be added: David Boyd, MN (Chair of Electricity); Robert Kenney, MO (Chair of ERE)' Lisa Edgar, FL (Naruc 2nd V.P. , who could become NARUC President for two years in the event Colette is elevated to the FERC); Josh Epel, CO (Chair of EPA task force); David Littell, ME; Aubrey Zimmerman, NY Chair; Mike Florio, CA; and Bob Stump, AZ. These folks are high-caliber individuals within the NARUC community, and would allow us to pair them with potentially new council members within their jurisdictions. Assuming you agree, this would expand commissioner representation to cover approximately 36 states.

5) Congressional/ federal agency speakers: We will be looking for some prominent, active members of the legislative branch and federal agencies like FERC or FCC.
