State*, 616 S.W.2d 623 (Tex. Crim. App. [Panel Op.] 1981).

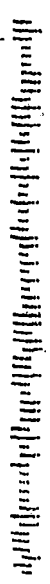

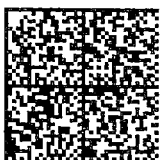
