Dear Mr. Hong:

You appealed from the action of the Executive Office for United States Attorneys (EOUSA) on your Freedom of Information Act request for "whether or not the Securities and Exchange Commission eventually has received, or will receive," any part of a settlement concerning the Royal Bank of Scotland. I note that your appeal concerns EOUSA's denial of your request.¹ Please note that this Office was closed due to a lapse in funding appropriations between December 22, 2018, and January 25, 2019, which resulted in a delay in responding to your appeal.

After carefully considering your appeal, and as a result of discussions between EOUSA personnel and this Office, I am remanding your request to EOUSA for a search for responsive records. If EOUSA locates releasable records, it will send them to you directly, subject to any applicable fees. You may appeal any future adverse determination made by EOUSA. If you would like to inquire about the status of this remanded request or to receive an estimated date of completion, please contact EOUSA directly at 202-252-6020.

I note that on appeal you seek various additional records that you did not originally request. You may not on appeal expand the scope of your initial request, which was limited to the records described above. Accordingly, to the extent that you now seek "any SEC collections from the \$4.9 billion RBS-DOJ settlement, relevant to substantial Whistleblower assistance to the SEC and DOJ in its RMBS fraud investigations," you may wish to submit a new FOIA request to EOUSA.

¹ EOUSA's response letter contained several inaccuracies. EOUSA informed this Office that its only basis for denying your request was Number 5 of the response, which indicates that the FOIA only applies to records already in existence and does not require an agency to conduct research, create new records, or answer questions presented as FOIA requests.
