Section 4 - CCW License Conditions and Restrictions

The licensee is responsible for all liability for, injury to, or death of any person, or damage to any property which may result through any act or omission of either the licensee or the agency that issued the license. In the event any claim, suit, or action is brought against the agency that issued the license, its chief officer or any of its employees, by reason of, or in connection with any such act or omission, the licensee shall defend, indemnify, and hold harmless the agency that issued the license, its chief officer or any of its employees from such claim, suit, or action.

The licensee authorizes the licensing agency to investigate, as they deem necessary, the licensee's record and character to ascertain any and all information which may concern his/her qualifications and justification to be issued a license to carry a concealed weapon and release said agency of any and all liability arising out of such investigation.

While exercising the privileges granted to the licensee under the terms of this license, the licensee shall not, when carrying a concealed weapon:

- · Consume any alcoholic beverage.
- Be in a place having a primary purpose of dispensing alcoholic beverages for on-site consumption.
- · Be under the influence of any medication or drug, whether prescribed or not.
- · Refuse to show the license or surrender the concealed weapon to any peace officer upon demand.
- · Impede any peace officer in the performance of his/her duties.
- Present himself/herself as a peace officer to any person unless he/she is, in fact, a peace officer as defined by California law.
- Unjustifiably display a concealed weapon.
- Carry a concealed weapon not listed on the permit.
- · Carry a concealed weapon at times or circumstances other than those specified in the permit.

Title 49, section 46505 of the United States Code states that a license to carry a concealed weapon does not authorize a person to carry a firearm, tear gas, or any dangerous weapon aboard commercial airlines. Further, a person must declare that he/she is carrying such firearm, tear gas, or any dangerous weapon BEFORE entering the boarding area of an air terminal where the security checks are made. Such violation can result in arrest by law enforcement.

Any violation of these restrictions or conditions may invalidate the CCW license and may void any further use of the license until reinstated by the licensing authority. Any arrest for a felony or serious misdemeanor, including driving under the influence of alcohol and/or drugs, is cause for invalidating the license.

I am a public official in San Francisco. I am certified as a Notary Public. As a notary public I hold many titles that include but are not limited to: Notary Signing Agent, Registered Process Server, and Field Inspector. I am also a certified Fingerprint Technician (FPT) and Live Scan Authorized Provider (AP). Most times I carry large amounts of cash and checks in the correction of the correction of an HR Block Tax course as an Income Tax Preparer (ITP), which will be another source of income and credentials that I will carry on my person at any given time. I am also a Bishop (Reverend) who holds a Doctor of Divinity Degree (DD).

I primarily act as a mobile Independent Contractor (IC). My work is primarily in the field. I cover the 9 Bay Area Counties that include: San Francisco, Alameda, Contra Costa, Solano, Sonoma, Napa, Marin, San Mateo, and Santa Clara.

The Field Inspection work gets dangerous at times. I have males who physically stalk, harass, and attack me when I am performing field inspections on commercial properties. I contract with at least a half a dozen agencies for assistance in recovering property or making collection efforts, and debt settlements.

I am not able to physically defend myself without any further degeneration in health or physical status.

I perform CPR classes as an Instructor and (AP) via the American Heart Association (AHA) and American Red Cross (ARC). I will soon become a training center (TC) in San Francisco County, which will also increase the amount of revenue I will carry at any given time due to the increased demand of students and medical professionals in California. Quite frankly, you might consider me a walking vault. Due to the loan documents that I carry as well as personal information for the background checks I perform, I keep locked safes and briefcases.

Finally, I do have a history of that the SFPD, SFFD, and SVU of San Francisco County can't handle. I have been a and live in a secluded area of San Francisco with a confidential address to protect

I currently have a criminal protective order against and his who have attempted

efforts to prevent paying child support. Basically, our lives have been verbally and physically threatened. I have been having problems since 2008. I have contacted the SFPH, SFFD, SVU, etc with no avail. I am basically on my own in this situation. I have to protect I do live in fear 24/7. I do my best to avoid any confrontation or visit any areas known to me that I may have altercation or run- ins with them at all costs. I can't keep hiding to avoid these people.
