Thank you for your application for a concealed weapon permit to be issued through the San Francisco Sheriff's Department.

Unfortunately, you do not present a case for good cause as defined by Department policy, Section I, B, 7. While I recognize that there have been serious crimes committed in your neighborhood, you have not shown that there are specific threats to your life or that the danger cannot be adequately dealt with by existing law enforcement resources. If I were to approve your application based on your presentation of general crime in the neighborhood, then most citizens on your block would qualify for a weapon permit as well, a standard that the Department has not adopted.

Nevertheless, since the general law enforcement duties in your neighborhood are the responsibility of the San Francisco Police Department and you apparently believe that they cannot provide safety for you and your family, you should consider applying for a weapon permit from the Chief of Police, who is also authorized under law to issue such permits in San Francisco. I think the Chief of Police is in a better position to judge whether more citizens should carry concealed weapons due to the level of crime in a particular neighborhood. And, since it is his officers who would come into contact with a person legally carrying a concealed weapon, it would be more appropriate for him to make that judgment.

Thank you for bringing your concerns to my attention.
