


COMPLAINT FOR RELIEF

1. This is an action under the Freedom of Information Act, 5 U.S.C. § 552, for injunctive and other appropriate relief and seeking the disclosure and release of agency records improperly withheld from plaintiff by defendant U.S. Department of Justice ("DOJ") and its components Federal Bureau of Investigation ("FBI") and Office of Information Policy ("OIP").

JURISDICTION AND VENUE

2. This court has both subject matter jurisdiction over this action and personal jurisdiction over the parties pursuant to 5 U.S.C. § 552(a)(4)(B). This court also has jurisdiction over this action pursuant to 28 U.S.C. § 1331. Venue lies in this district under 5 U.S.C. § 552(a)(4)(B).

3. Plaintiff Edward Dean Hohner ("Hohner") has a personal interest in the disclosure and release of agency records improperly withheld from plaintiff by defendant DOJ and its components FBI and OIP. In THE PEOPLE OF THE STATE OF CALIFORNIA v. EDWARD DEAN HOHNER, CASE NO. SCD216918, Hohner was convicted of 2X PC187(a)

and 2X PC190.2(a) counts with no physical evidence—no bodies, no DNA, and no gun—only the testimony of drug addicts and a paid government informant. Hohner believes the improperly withheld records are exculpatory and/or impeachment material.

4. Defendant DOJ is a Department of the Executive Branch of the United States Government, and includes component entities FBI and OIP. The DOJ is an agency within the meaning of U.S.C. § 552(f).

Government Agencies' Failure to Release Any and All Information Concerning Cellular Phone Number 619-787-9199 During the Month of February 1997.

5. On or about April 30, 2012, Hohner was convicted of COUNT 1: PC187(a) MURDER with PC12022.5(a)(1) ALLEGATION; with PC190.2(a)(17) ALLEGATION; COUNT 2: PC187(a) MURDER with PC12022.5(a)(1) ALLEGATION; with PC190.2(a)(17) ALLEGATION; in THE PEOPLE OF THE STATE OF CALIFORNIA v. EDWARD DEAN HOHNER, in Case No. SCD216918. Hohner was convicted in a 4 1/2 day trial with no physical evidence—no bodies, no DNA, and no gun—only the testimony of drug addicts and a paid government informant.

6. At the trial of Hohner, Arturo Camarena ("Camarena")—a witness that received immunity and an admitted heroin addict—testified that he witnessed Hohner murder two people, helped load them in a car, followed Hohner out to the Yuma, Arizona desert, and waited by the side of the road while Hohner drove off and disposed of the bodies and car. No bodies, car, DNA, or physical evidence has ever been found.

7. On or about December 20 2012, Hohner requested and received his file from trial attorney, Douglas L. Miller in Case No. SCD216918. See attached Exhibit "1", Correspondence between Hohner and Miller concerning file.

8. After Hohner received and read his file (Discovery), He noticed, through a FBI 302 report, that Special Agent James M. Bird ("SA Bird") telephoned a source ("Eric Juston Hamilton") to get the telephone numbers used by Eddie Hohner. The Source gave SA Bird Cellular No. 619-787-9199 along with some other numbers. See attached Exhibit "A", FBI 302 report, Discovery Page(s) 1558.

After Hohner saw this FBI 302 report, He remembered that Cellular Phone No. 619-787-9199 was registered to Hohner but used by Arturo Camarena on

February 21, 1997. This is the date Camarena claims to have witnessed Hohner murder 2 people and drive out to the desert to dispose of the bodies and car. Hohner believes that the Cellular phone records are exculpatory and impeachment materials.

9. On or about December 11, 2014, Hohner sent a FOIA request to the FBI requesting any and all information concerning Cellular Phone No. 619-787-9199 during the month of February 1997. See attached Exhibit "2", Exhibit "A", Hohner's original FOIA request.

10. On or about December 22, 2014, Hohner received a response stating that the FOIA was received at FBI Headquarters for processing and assigned FOIPA Request No. 1317689-000. See attached Exhibit "3", FBI acknowledges Hohner's FOIA request.

11. On or about December 22, 2014, Hohner received an additional response stating that the FBI was unable to identify main file records responsive to Hohner's FOIA request. However, the FBI also stated it could neither confirm nor deny the existence of requested records. The FBI advised that an appeal could be filed with the Office of Information Policy ("OIP"). See attached Exhibit "4", FBI neither confirms nor denies responsive records and advises right to appeal to OIP.

12. On or about January 04, 2015, Hohner sent an appeal to the OIP requesting any and all information concerning Cellular phone number 619787-9199 during the month of February 1997. See attached Exhibit "5", Hohner's Appeal to OIP.

13. On or about January 28, 2015, Hohner received a response stating the FOIA appeal was received by OIP and Appeal No. AP-2015-01642 was assigned. See attached Exhibit "6", OIP acknowledges receipt of Hohner's appeal.

14. On or about April 14, 2015, Hohner received an additional response from OIP affirming the FBI's action on requested information. Hohner was also advised that if he was dissatisfied with the action on his appeal, FOIA permits a person to file in federal district court in accordance with 5 U.S.C. § 552(a)(4)(B). See attached Exhibit "7", OIP affirming FBI's action.

Requested Relief

Wherefore, plaintiff prays that this Court:

- A. order defendants to disclose the requested records in their entireties and make copies available to plaintiff;
- B. order defendants to acknowledge the existence or nonexistence of the requested records;
- C. order defendants to perform the search, put together the responsive records and prepare a comprehensive **Vaughn Index**, if the defendants claim an exemption or a statutory right to withhold requested documents.

Under penalty of perjury, I hereby affirm that the foregoing is true and correct to the best of my knowledge and belief.

Araiza, according to Matt, hid in the front house when the Marshals went to the back portion of the residence to search for her. They eventually left without taking her into custody. The Source said that he does not know whether the Marshals were local or federal. He advised that local Marshals may be looking for her for traffic violations or federal Marshalls may have come to arrest her for probation violation. Araiza has told the Source that she had tested positive for drugs on two occasions.

The Source also advised that paramedics had to be called last week to treat Araiza for a seizure brought on by methamphetamine use. The paramedics told Hohner and Araiza that they will have to advise the police if they are called again to treat Araiza for her drug problem. In addition, the Source advised that Araiza's drivers license has been confiscated. Accordingly, Hohner will not allow her to drive.

The Source suggested that when Araiza is taken into custody it may be a good time to interview her. SA Bird mentioned that she certainly will not want to be in custody and may be willing to cooperate in order to minimize her jail time. The

FBI FACT SHEET

- **The primary function of the FBI is national security.**
- **The FBI does not keep a file on every citizen of the United States.**
- **The FBI was not established until 1908 and we have very few records prior to the 1920s.**
- **FBI files generally contain reports of FBI investigations of a wide range of matters, including counterterrorism, counter-intelligence, cyber crime, public corruption, civil rights, organized crime, white-collar crime, major thefts/violent crime, and applicants.**
- **The FBI does not issue clearances or non-clearances for anyone other than its own personnel or persons having access to FBI facilities.** Background investigations for security clearances are conducted by many different Government agencies. Persons who received a clearance while in the military or employed with some other government agency should contact that entity. Most government agencies have websites which are accessible on the internet which have their contact information.
- **An identification record or “rap sheet” is NOT the same as an “FBI file.”** It is a listing of information taken from fingerprint cards and related documents submitted to the FBI in connection with arrests, federal employment, naturalization or military service. The subject of a “rap sheet” may obtain a copy by submitting a written request to FBI, Criminal Justice Information Services (CJIS) Division, Record Request, 1000 Custer Hollow Road, Clarksburg, West Virginia 26306. Along with a specific written request, the individual must submit a new full set of his/her fingerprints in order to locate the record, establish positive identification, and ensure that an individual’s records are not disseminated to an unauthorized person. The fingerprint submission must include the subject’s name, date of birth and place of birth. There is a required fee of \$18 for this service which must be submitted in the form of a money order or certified bank check made payable to the Treasury of the United States. A credit card payment option is also available. Forms for this option and additional directions may be obtained by accessing the FBI Web site at www.fbi.gov/about-us/cjis/background-checks/background_checks.
- **The National Name Check Program (NNCP) conducts a search of the FBI’s Universal Index (UNI) to identify any information contained in FBI records that may be associated with an individual and provides the results of that search to the requesting Federal, State or local agency.** For the NNCP, a name is searched in a multitude of combinations and phonetic spellings to ensure all records are located. The NNCP also searches for both “main” and “cross reference” files. A main file is an entry that carries the name corresponding to the subject of a file while a cross reference is merely a mention of an individual contained in a file. The results from a search of this magnitude can result in several “hits” and “idents” on an individual. In each instance where UNI has identified a name variation or reference, information must be reviewed to determine whether it is applicable to the individual in question.
- **The Record/Information Dissemination Section—Freedom of Information/Privacy Act (FOIPA) searches for records and provides copies of FBI files relevant to a FOIPA request for information.** FOIPA provides responsive documents to requesters seeking “reasonably described information.” For a FOIPA search, the subject name, event, activity, or business is searched to determine whether there is an investigative file associated with the subject. This is called a “main file search” and differs from the NNCP search.



BACKGROUND

1. Hohner sent a FOIA request dated December 11, 2014, to the FBI requesting any and all information concerning cellular phone number 619-787-9199 during the month of February 1997. See attached FOIA request dated December 11, 2014.

2. On or about December 22, 2014, Hohner received a response back from David M. Hardy; Section Chief, Record/Information Dissemination Section; Records management Division; FBI; U.S. DOJ dated December 22, 2014, neither confirming or denying the requested documents exist, and Hohner could file an appeal with the OIP and U.S. DOJ. See attached response dated December 22, 2014.

MEMORANDUM OF LAW

Please be informed that Hohner considers the requested material releasable under FOIA and your agencies policy to be arbitrary and capricious.

The requested FOIA information does not fall under any of the exclusions listed on the response from the U.S. DOJ and FBI, See attached response dated December 18, 2014, and, therefore, is releasable. Hohner asks that if the Office of Information Policy ("OIP") concludes it is appropriate to assert the exemptions listed on the response, then the prevailing controlling authorities require the U.S. DOJ and FBI to acknowledge the existence or the nonexistence of the records and identify them, so that an in camera review of such documents may be performed by the U.S. District Court on collateral review.

Hohner requests, at the very least, that if the U.S. DOJ and FBI claims an exemption or a statutory right to withhold any requested documents, that the U.S. DOJ and FBI perform the search, put together the responsive records and prepare a comprehensive Vaughn Index so that a receiving court may determine the claim that the U.S. DOJ and FBI is asserting. FOIA places the burden of justifying nondisclosure on the government. 5 U.S.C. § 552(a)(4)(B). The government must prove that each of the requested documents "either have been produced, is unidentifiable, or is wholly exempt under the Act." Marks v. U.S. Dept. of Justice, 578 F.2d 261, 262 (9th Cir. 1978) (citing National Cable Television Ass'n, Inc. v. F.C.C., 479 F.2d 183, 186, 156 U.S. App. D.C. 91, (D.C., Cir. 1973)).

Furthermore, in Trammel v. United States, 445 U.S. 40, 50 (1980) the Supreme Court recognized the fundamental principle that "the public...has a right to every mans evidence." Id. 50. Also See United States v. Nixon, 418 U.S. 683, 709 (1974).

You appealed from the action of the Federal Bureau of Investigation on your request for access to records concerning "cell phone number 619-787-9199 during the month of February 1997."

After carefully considering your appeal, I am affirming the FBI's action on your request. The FOIA provides for disclosure of many agency records. At the same time, Congress included in the FOIA nine exemptions from disclosure that provide protection for important interests such as personal privacy, privileged communications, and certain law enforcement activities. To the extent that your request seeks access to records that would either confirm or deny an individual's placement on any government watch list, the FBI properly refused to confirm or deny the existence of any records responsive to your request because the existence of such records is protected from disclosure pursuant to 5 U.S.C. § 552a(j)(2) and 5 U.S.C. § 552(b)(7)(E). FOIA Exemption 7(E) concerns records or information compiled for law enforcement purposes the release of which would disclose techniques and procedures for law enforcement investigations or prosecutions. This response should not be taken as an indication that records do or do not exist. Rather, this is the standard response made by the FBI.

As to any other records, the FBI informed you that it could locate no main file records subject to the FOIA in its files. I have determined that the FBI's response was correct and that it conducted an adequate, reasonable search for records responsive to your request.

Please be advised that this Office's decision was made only after a full review of this matter. Your appeal was assigned to an attorney with this Office who thoroughly reviewed and analyzed your appeal, your underlying request, and the action of the FBI in response to your request.

If you are dissatisfied with my action on your appeal, the FOIA permits you to file a lawsuit in federal district court in accordance with 5 U.S.C. § 552(a)(4)(B).



