Re: Request for Reimbursement of Attorney's Fees // Mueller Investigation

Dear Mr. D'Alessio:

I write in response to your December 17, 2020, email requesting additional information to assist your office in evaluating Stephen K. Bannon's request for reimbursement of attorneys' fees incurred in connection with the investigation by Special Counsel Robert S. Mueller, III into possible Russian interference during the 2016 presidential election (the "Mueller Investigation"). Mr. Bannon states as follows:

- 1. Mr. Bannon confirms that he was not a subject or target of the Mueller Investigation.
- 2. Mr. Bannon's interviews by the Department of Justice concerned actions taken Mr. Bannon in the course of performing his duties as White House Chief Strategist. Specifically, Mr. Bannon produced documents and answered questions about his knowledge of or involvement with topics including (1) Michael Flynn's communications with Sergey Kislyak; (2) Michael Flynn's FBI interview; (3) White House briefings on Russian interference with the 2016 presidential election; (4) Michael Flynn's resignation; (5) former FBI Director James Comey; (6) former Attorney General Jeff Sessions; (7) meetings at White House with the Russian Foreign Minister; and (8) Russia-related sanctions.

- 3. Mr. Bannon confirms that he has paid and is responsible for paying the attorneys' fees and costs and that he has not been reimbursed, in whole or in part, by insurance or any legal defense fund.
- 4. It is our understanding that the White House supports reimbursing Mr. Bannon's attorneys' fees. We are in the process of obtaining a written statement confirming the White House's agreement and will provide it to you as soon as possible.
- 5. Itemized invoices for the work performed for Mr. Bannon in connection with the Mueller Investigation are enclosed as Appendix A. These invoices have been redacted to remove any attorney-client privileged information.

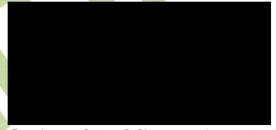
