Thank you for your inquiry regarding the status of your Freedom of Information Act/Privacy (FOIPA) request. A review of your request has determined the following:

The request is presently awaiting assignment to a Disclosure analyst who will then review the records to determine if any redactions are required pursuant to subsections of Title 5, U. S. Code, Section 552 and 552a.

You may check the status of your request online at http://vault.fbi.gov by clicking on the 'Check Status of Your FOI/PA Request' link. Online status reports are updated weekly.

Your request is currently in the complex request medium processing track.

Given the current COVID-19 pandemic and federal guidelines to mitigate the spread of the virus, the FBI's Records /Information Dissemination Section (RIDS) is operating with limited staff on a staggered schedule to protect the safety of its employees, families, and communities.

As a result, estimated dates of completion for Freedom of Information Act requests were impacted and you can expect lengthened response timelines. We now estimate that small track requests (50 pages or fewer) will require approximately 8 months to complete; medium track requests (51 - 950 pages) will require approximately 29 months to complete; large track requests (951-8,000 pages) will require approximately 56 months to complete, and extra-large requests (over 8,000 pages) will require approximately 70 months to complete. Please note that these are estimates and these timelines may change as the national emergency evolves. The FBI remains committed to fulfilling your FOIPA request in the timeliest manner possible. Thank you for your patience and understanding.

If your request is currently in either the medium, large, or extra-large track, you may wish to consider reducing its scope to place it in a smaller, potentially faster track. Please let us know if you would like to reduce the scope of your request, and a representative will contact you.
