<u>Public Utilities Commission Enbridge Routing Permit/Public Safety Escrow Account:</u>

The PUC has released an RFP to hire the Liaison to oversee the Public Safety Escrow Account. The RFP closes on November 30th. I was told that you may start submitting expenses for reimbursement, however they will not be processed until that Liaison is hired. With that, that position will also determine (with final approval by the PUC) what expenses are allowable for reimbursement and in what format they want the documentation. I have attached the forms that HSEM has historically used for any FEMA related expense reimbursement. That is likely the format that may be used. We do know for absolute certain that munitions will NOT be an allowable expense. Please consider submitting any other expenses you have related to Line 3 planning/preparation/response. This could include training, equipment, PPE, wages.....

Request for resources to all MN Sheriffs:

Our NLTF Sheriff's exec group have been meeting with all MSA District Sheriff groups recently. We have put out a request for resources (mainly MFF manpower). UPCOMING TRAINING:

***Salamander credentialing and resource tracking software system training: This training is repeated, offered on 3 different dates, but people only need to attend 1 of the days. It would be ideal to get 1 or 2 people from each County trained in this system. At a minimum, we need 2 people for each of the 5 construction spreads, but that may mean some staff may have to be willing to travel outside of their county/jurisdiction for a response. Concept of Operations document:

The Mobile Response Team (MFF) Subcommittee has drafted a concept of operations document that has been reviewed and tweaked by the NLTF Sheriffs. It also incorporates the jail/mobile booking operations into this document. I have attached the DRAFT document and would appreciate if you would review. If you wish to provide feedback/suggestions on any changes to the document, please provide any comments to me by November 27th so that we can incorporate those changes and have final document for distribution to all agencies by the week of December 1. This document will provide operational guidelines for MFF so they are consistent across the line.

LT Col Dotterer MN National Guard gave brief Guard 101 information on what is needed by Sheriffs if a request comes for assistance: The Guard has been involved in planning efforts for quite some time with NLTF and ready to assist when called. Detail Task and Purpose they are needed for Give Agency Point of Contact How Long is expected resource needed

EMS Subcommittee: They have been working with MN EMS coordination group. They have the depth to support Line 3 when requested. They are gathering a cache of PPE supplies to be staged at Aitkin County and St. Louis County

<u>Jail Ops Subcommittee</u>: They believe in a mass arrest scenario they may need up to 15 jail booking staff at primary booking site and 15 at secondary booking site. This most likely will result in a call out for mutual aid to staff to this level. We will be adding a request out to the other Sheriffs in MN for any booking staff availability.

<u>Emergency Management/Logistics subcommittee:</u> Check with your EM to see if they have identified potential Resource Staging areas in your county.

Extrication Team: This subcommittee has identified a list of all agencies across the line that have Extrication Teams. They wanted a reminder to all agencies that the extrication process is very slow and they can only go in once MFF teams have secured the scene and made it safe for them.

completed soon, matrix for use has been incorporated into the Concept of Operations document, they will also have a tracking list of available munitions across the line.

Credentialing subcommittee: To track resources in a large deployment for a mass civil unrest event, we will be utilizing software system the state purchased called Salamander. Many of you have already submitted information to Angela Packer, the subcommittee chair with your staff name/position/photo, so that information is pre-loaded into Salamander and a photo ID badge is created. This will streamline the Staging/credentialing process as these ID's can be provided to your agency ahead of any event and your staff responding just need to bring their ID with them. This will allow us to track the numerous resources during the event and have this information available for after for any civil litigation or criminal court purposes if/when needed. When you receive your ID badges for your staff, PLEASE ENCOURAGE them to hang on to them for the duration and bring them with if they are deployed.

The plan is to try to get 2 staff per county trained in the use of Salamander so they would be on-site at staging checking people in and also creating badges for those that may not already have them.
