To Whom It May Concern:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 *et seq.*, Protect Democracy makes the following request for records to both President Fann and the Arizona Senate, including those agents and contractors subject to Senate control via contract or agreement:

1. all communications and correspondence (including, for example, emails, email attachments, text messages, and messages on messaging platforms such as Slack, Signal, or WhatsApp) concerning the following Twitter accounts:
 - a. @ArizonaAudit;
 - b. @AuditWarRoom;
2. all documents listing any individuals, entities, and organizations that exercise control over content creation for the following Twitter accounts;
 - a. @ArizonaAudit;
 - b. @AuditWarRoom;
3. all documents listing any individuals, entities, and organizations that have access to login information for the following Twitter accounts;
 - a. @ArizonaAudit;
 - b. @AuditWarRoom; and
4. all direct messages sent or received by @ArizonaAudit or @AuditWarRoom Twitter accounts.

These requests are directed to Senate President Fann and the Arizona Senate as a branch of the State, and your response must include records of your agents and contractors, including but not limited to Cyber Ninjas, Ken Bennett, and Randy Pullen. If your agency does not maintain the records requested, please advise us of the proper custodian's name and address.

The timeframe for this request is March 1, 2021, through the date that searches are conducted for records responsive to this public records request.

We seek records in all media and formats. This includes, but is not limited to: agendas, manifests, calendars, schedules, notes, and any prepared documentation for meetings, calls, teleconferences, or other discussions responsive to our request; voicemails; emails; email attachments; talking points; faxes; training documents and guides; tables of contents and contents of binders; documents pertaining to instruction and coordination of couriers; and any other materials. This also includes records exchanged via the personal email accounts of the government officials and contractors covered by the above request. Where possible, please provide responsive materials in an electronic format by email.

Protect Democracy is a 501(c)3 nonprofit organization and these records are not sought for any commercial purpose. As such, Protect Democracy requests that any fees charged in connection with processing this request be limited to copying and postage charges. A.R.S. § 39-121.01(D)(1); *see also Hanania v. City of Tucson*, 128 Ariz. 135, 624 P.2d 332 (Ariz. Ct. App. 1980) (agency may not charge noncommercial requestors for costs associated with searching for records). If applicable, Protect Democracy agrees to pay up to \$100 for any fees concerning copying and postage charges. If the cost for such fees will exceed \$100, please notify me before you incur such costs. Moreover, because this request is for noncommercial purposes, the additional fees discussed in A.R.S. § 39-121.03(A) are not applicable in this instance.

Please respond to this request in a reasonable time period because time is of the essence. If you expect any delay, please contact me within seven (7) days with information about when I might expect copies or the ability to inspect the requested records.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law. If you conclude that portions of the records that I request are exempt from disclosure, please release the remainder of such records for inspection and copying, redacting only the portion or portions that you claim are exempt.
