NARRATIVE

On February 26th, 2021 at 04:33 hours I was dispatched to a armed carjacking at 2959 Campbellton Rd SW at the Chevron gas station. Upon my arrival I came in contact with the victim and Uber driver who advised me that he was robbed at gunpoint by two black males armed with an black assault rifle and a handgun for his 2021 Silver Honda Accord. Mr. Morrow states that he picked up two unidentified black males from Clayton County somewhere off of Mt. Zion Rd and advised that one of the passengers was name Rico. proceeded with the Uber ride and traveled I-75 NB to Arthur Langford Pkwy WB and got off on Campbellton Rd SW/ Greenbriar Pkwy SW. As is following his Uber GPS when one of the males passengers tell him to make a right hand turn onto Greenbriar Pkwy SW. Once made the right hand turn onto Greenbriar Pkwy SW the males passengers lead him to some apartments off of Continental Colony Pkwy. is unsure which apartments they took him to but advised me he turned left into the apartments. The apartments to the are 3000 Continental Colony Pkwy SW or 3030 Continental Colony Pkwy SW. When rode around apartments the male passengers advised him that he was at the wrong apartments. After leaving those apartments arrived to 2909 Campbellton RD SW the original destination in the Uber GPS, once in the apartments he was instructed to drive all the way to the rear of the apartments. Soon as approached the rear of the apartments he was in front of building 37 and that s when his black male passengers pointed a black Assault Rifle and put an unknown caliber handgun to the back of his head. advised me that the suspects told him to " give it up" and also ask did he have any cash on him. The males suspects then forced him out of his vehicle and took off at a high rate of speed leaving Mr. Morrow in the rear of the neighborhood.

Upon further investigations I raised our VIC unit and asked where was the latest LPR hit on the tag. VIC unit advised me that approximately at 04:29 the vehicle hit in a general vicinity. VIC unit advised me that she would put a flag on the stolen vehicle in the system. Shortly after I contacted GCIC to report the car stolen and GCIC operator **advised** placed the 2021 Silver Honda Accord on the system as stolen. Being that **advised** is a Uber driver, I reached out o Uber to see if I could get some information regarding the Uber passenger. Uber advised me that the hours I was calling they was closed to call back when they open at regular business hours at 8:00 A.M.

On 02/27/2021 at approximately 1605 hours, I, (Unit 3405, driving vehicle 32404) along with Unit 3403 conducted a traffic stop located at 584 Langhorn St SW. At this location I pulled over a Honda Accord bearing GA TAG due to the fact that I received a "hit" for the vehicle being stolen by carjacking. I exited my patrol vehicle and approached the driver from the driver s side of the vehicle. I asked the unidentified female driver did the vehicle belong to her and she replied yes. I then explained to the driver the reason for the traffic stop was due to the fact that it was showing to be stolen by carjacking. The female driver, later identified as replied that she did not report her vehicle stolen and was unaware of any carjacking. While speaking to the driver, her daughter (unidentified) stated that approximately 30 mins prior, she noticed that the tag displayed on the vehicle displayed Fulton County although they do not live in Fulton County, but did not think much of it. Nor did her daughter contact police. Upon further investigation, it was discovered that the tag that was affixed to the vehicle I pulled over was switched from the carjacked vehicle. s GA TAG was stolen from her vehicle. stated that she does not pay much attention to her tag and had not noticed the switch.

responded to the scene. Robbery Unit 4320 ACE Unit 1097 responded to the scene as well as dusted the license plate and frame for latent prints, but none were recovered. GA TAG was placed onto the system by contacting GCIC. The VIC Unit was also notified of the stolen tag status. The GA TAG was removed from vehicle and placed into property as evidence at the Zone 4 precinct property locker. My BWC was activated during the investigation of this stolen tag. Its footage was assigned its proper case number, category, and uploaded to Evidence.com. was provided her case number and contact information to the Zone 4 precinct.
