Dear Zoe Tillman:

This letter is the final response to your Freedom of Information Act/Privacy Act (FOIA/PA) request. The Executive Office for United States Attorneys (EOUSA) has processed your request and determined twenty (20) pages are responsive to your request. The EOUSA is the official record-keeper for all records located within the various United States Attorneys' Offices, to include the District of Utah.

To provide you with the greatest degree of access authorized by the FOIA and the Privacy Act, we considered your request in light of the provisions of both statutes and are making all records required to be released, or considered appropriate for release as a matter of discretion, available to you. Enclosed please find: two (2) pages released to you in full and sixteen (16) pages released to you in part.

We reviewed all the information that was redacted and/or withheld in full to determine if any information could be segregated for release. The exemption cited for withholding records or portions of records is 5 U.S.C. § 552(b)(6), which protects from release personal privacy information that if released would constitute a clearly unwarranted invasion of personal privacy.

A review of the responsive material revealed that two (2) pages contain equities that belong to a separate and distinct office within the Department of Justice. In accordance with 28 C.F.R § 16.42, the EOUSA referred a copy of the FOIA request and the respective records to the appropriate office for a release determination of the responsive material. Huber has been appointed as interim U.S. Attorney for the District of Utah under the Federal Vacancies Reform Act, which gives authority to the Attorney General to appoint an Interim USA for up to 120 days. Mr. Huber tendered his resignation along with other presidential appointees on March 10. However, upon consideration of additional factors and consultation within the executive branch, the Attorney General has decided to appoint Mr. Huber on an interim basis to lead the district during this transitional period.


