SUMMARY OF INCIDENT: An arrest warrant shall be attached when applicable excluding Juvenile/Child warrants. license as Daniel Perreault (DOB 11/16/71). Perreault stated that he did not recall the incident and he appeared to be intoxicated. Perreault was subsequently placed under arrest and transported to Troop C where he was processed according to departmental procedures. He was charged with Risk of Injury to a Minor in violation of C.G.S. 53-21, Sexual Assault in the Fourth Degree of a Minor in violation of C.G.S. 53a-73a, and Breach of Peace in the Second Degree in violation of C.G.S. 53a-181. Perreault was issued a \$20,000 cash/surety bond and was scheduled to appear at Rockville Superior Court on 08/25/21 at 0900 hours.
