I have already sent this response separately to Donald Bierer via email at the address MDHHS-FOIA@michigan.gov, and received a response from Ruth O'Connor, who is apparently also part of the legal affairs department, who told me she would look into this matter.

However, I wanted to also send a response here so that I can ensure my response to this denial is included in the public record, in the event that I need to contact an attorney about this matter, which seems likely given the circumstances.

I would like a prompt explanation as to why Mr. Bierer logged into the MDHHS FOIA system and denied this request after it had already been fully granted as to nonexempt records (see invoice number INV21-H011657-1 -- which appears to have been deleted from the system but should still be available in your records, if your FOIA records are being kept properly). If you no longer have a copy of this invoice, I will be happy to provide you with it.

In his denial, Mr. Bierer claimed that the agency does not have access to the requested records. However, because I have seen Robert Gordon's emails in the records of previously completed FOIA requests on the MDHHS "My Records Center" website (which were obviously processed by MDHHS), I am highly confident that the MDHHS does, in fact, have access to the requested records.

I was also quoted a fee of \$4,150.13 for a search of similar information to that requested in this FOIA request (but also including actual documents and not just a list of email addresses and names) under an invoice for MDHHS FOIA request H011656-052521. That request was also fully granted as to nonexempt records. That fee and invoice (which was fully granted as to nonexempt records and did not indicate a lack of access to Mr. Gordon's emails), coupled with the emails included in the aforementioned completed FOIA request, would seem to indicate that your agency does, in fact, have access to the requested records.

Thank you for your interest in public records of the Michigan Department of Health and Human Services (hereinafter "Department").

Records Requested: To Whom It May Concern:

Under the Freedom of Information Act, I request that the following documents and information be provided to me:

- The names and email address of all CDC and HHS contacts that MDHHS Director Robert Gordon sent emails to between the dates of 11/1/2019 and 1/22/2021.

Although I am unsure of all of Mr. Gordon's email addresses, you might want to start the search with GordonR3@michigan.gov.

There are probably other email address associated with Mr. Gordon, so it would be ideal for you to reach out to the MDHHS director's office staff to confirm all of the email addresses he used in the past year prior to conducting the records search.

When searching for emails to the CDC and/or HHS, it would be a good idea to start with domains that include cdc.gov and hhs.gov. There may be other domains associated with the email addresses of these agencies, so you should contact the CDC and HHS about this possibility prior to conducting your search.
