Hello Mr. Bierer,

Can you please explain why you logged into the system and rejected my FOIA request after it was granted?

Because I have already reviewed some of Robert Gordon's emails in the records of a previously completed FOIA request found on the MDHHS "My Records Center" website, on the frequently requested records page (requests that were obviously processed by MDHHS), I am confident that MDHHS does, in fact, have access to the requested records.

If in doubt, see MDHHS FOIA request H010401-030421, dated 3/5/2021, file "JudicialWatch10401.zip", which you can view/download here:

The above-mentioned completed request contains emails originating from Mr. Gordon's unredacted email address, which indicates that your agency does have access to his email account and, therefore, to the records included in my request.

As mentioned in my initial email, I was also quoted a fee of \$4,150.13 for similar information to that which is requested in this FOIA request (but which also included actual documents and not just a list of email addresses and names) under request H011656-052521. That fee and invoice (which was fully granted as to nonexempt records and did not indicate a lack of access to Mr. Gordon's email records), coupled with the emails included in the aforementioned completed FOIA request, would seem to indicate that your agency does, in fact, have access to the requested records.

Please explain.
