This letter is the Initial Agency Decision to your February 26, 2021, Freedom of Information Act (FOIA), 5 U.S.C. § 552 request. You submitted your request to the United States Department of Veterans Affairs, Office of General Counsel.

On February 26, 2021, you submitted a FOIA request to the Office of General Counsel where you requested a copy of "OGC Regional Counsel Attorney's Karen Lynn Mulcahy's copy of the following attachment she submitted with the 10/4/16 Request for No Engagement Memorandum on me. Attachment A: November 21, 2013 – Order of Dismissal from EEOC Administrative Judge, William Rodriguez in EEOC Case No. 2001-0516-2013101717, that only myself and Ms. Mulcahy would have access to."

In conducting a search for information possibly responsive to your very specific request, which included a search of the Office of General Counsel's internal database, your name was utilized as the key term for the search. Upon conducting the search of the internal database, I was unbale to locate "No Engagement Letter Attachment A". Therefore, I am providing a "no records" response.

After conducting a reasonable search for records, I have concluded that the Office of General Counsel does not have records responsive to your request. Courts have determined that reasonableness of an agency's search can depend on whether the agency properly determined where responsive records were likely to be found and searched those locations. [See lacoe v. IRS, No. 98-C-0466, 1999 WL 675322, at *4 (E.D. Wis. July 23, 1999) (recognizing that agency "diligently searched for the records requested in those places where [agency] expected they could be located")]. Record search inquiries were made to the appropriate office. This search was conducted by utilizing the search criteria as defined in your request. At the conclusion of the search, a "no records" response was provided for responsive records to your request.

Consequently, I am denying your request due to the Office of General Counsel not having documents that are responsive to your request.
