Entity Name and Type

The name and type of filing entity being formed are: National Constitutional Law Union Inc., a Wyoming nonprofit corporation (hereinafter "Corporation"). The Corporation is a public benefit corporation.

VIII. Additional Article:

Purpose

Corporation is organized as a social welfare organization within the meaning of Section 501(c)(4) of the

Internal Revenue Code of 1986 (the "Code") and the regulations promulgated thereunder. Corporation is organized to promote social welfare through legal and other advocacy for fair treatment of people and organizations with respect to their civil and Constitutional rights as it relates to conduct by both private and public actors that implicate these rights and the preservation of the American values for which they stand and by which they are animated.

IX. Additional Article:

Organizational Structure

Corporation will have a sole member with the sole power to select Corporation's board of directors, set compensation for directors, approve/amend the bylaws and take fundamental action. The member will be a Wyoming LLC named NCLU Member LLC or similar name.

X. Additional Article:

Action Without a Meeting by Members, Directors or Committees

Any action required by the WNCA to be taken at a meeting of the member or directors of Corporation or any action that may be taken at a meeting of the member or directors or of any committee may be taken without a meeting if a consent in writing, setting forth the action to be taken, is signed by a sufficient number of members, directors, or committee members as would be necessary to take that action at a meeting at which all of the members, directors, or members of the committee were present and voted.

XI. Additional Article:

Power to Amend Bylaws Reserved by Member

The power to amend the bylaws is reserved exclusively to the member.

XII. Additional Article:

To the extent permitted by Section 82.541 of the WNCA and other applicable law, Corporation shall advance or reimburse expenses to and indemnify any present and former directors, officers, employees, and agents of Corporation and persons serving or formerly serving at the request of Corporation as directors, officers, partners, venturers, proprietors, trustees, employees, agents, or similar functionaries of another foreign or domestic corporation, employee benefit plan, other enterprise or entity against judgments, penalties (including excise and similar taxes), fines, settlements, and reasonable expenses actually incurred by the person in any threatened, pending, or completed action, suit or proceeding, whether civil, criminal, administrative, arbitral or investigative, any appeal in such action, suit or proceeding, and any inquiry or investigation that could lead to such an action suit or proceeding, because the person is or was acting in one of the capacities set forth above.

XIII. Additional Article:

Member Consent Required for Fundamental Action

The consent of the member shall be required and sufficient to approve a fundamental action.

XIV. Additional Article:

Supplemental Provisions or Information

This certificate of formation becomes effective when the document is filed by the secretary of state.
