I would like to propose we use this TED talk "The Danger of a Single Story." (https://www.ted.com/talks/chimamanda_ngozi_adichie_the_danger_of_a_single_story/transcript?language=en) for our general membership meeting on April 27th.

This video is 18.5 minutes long and the narrator (best-selling author Chimamanda Ngozi Adichie) uses humor and lived experience to explain implicit bias that many of us, including Adichie, have but may not realize. We watched this video for our NCCJ Diversity 101 meeting last week, and it generated good discussion as well as enlightened many of us about the implicit bias in our interactions with others. It doesn't point fingers or shame folks--rather it sheds light on the way our brains work and that bias is part of the human experience.

For our meeting, we could show the video and then have breakout sessions for small group discussion, returning to a larger group discussion at the end (like we did the first meeting).

OR we could invite folks for a panel discussion rather than the breakout sessions with time for Q&A at the end. For the panel discussion, we could possibly invite members of our community to share their experiences of moving to or from other countries or perhaps professors (sociologists, psychologists, economists, historians, etc) at local universities who could discuss bias and its effects on communities.

I wanted to send this idea before our meeting tomorrow night since we need to start planning if we will have speakers/guest panelists at our meeting. To keep our meeting short, we can also discuss this idea through this email thread.
