Dear Mr. Garcia-Malene:

This firm represents the Informed Consent Action Network (“ICAN”). On behalf of ICAN, please provide the following records to [foia@sirillp.com](mailto:foia@sirillp.com) in electronic form:

**At a July 20, 2021 Senate hearing at which Dr. Anthony Fauci (“Dr. Fauci”) appeared and had an exchange with Senator Rand Paul (“Senator Paul”) regarding a paper titled *A SARS-like cluster of circulating bat coronaviruses shows potential for human emergence* (the “paper”),<sup>1</sup> Dr. Fauci stated: “This paper that you are referring to was judged by qualified staff up and down the chain as not being gain-of-function.”<sup>2</sup>**

**Please provide any and all documents reflecting the judgment and/or conclusions by the “qualified staff” to which Dr. Fauci was referring which concluded that the paper is “not ... gain-of-function.”**

### **Expedited Processing**

ICAN requests expedited processing for this request. FOIA provides for “expedited processing of requests for records” upon a showing of “compelling need.” 5 U.S.C.

§ 552(a)(6)(E)(i)(II). When the person requesting information is “primarily engaged in disseminating information, urgency to inform the public concerning actual or alleged Federal Government activity” constitutes a “compelling need” for expedited processing. 5 U.S.C. § 552(a)(6)(E)(v)(II).

ICAN is a non-profit organization that advocates for informed consent. ICAN’s mission is to raise public awareness about public health and safety and to provide the public with information to give informed consent regarding related health interventions and precautions. As part of its mission, ICAN disseminates information to an audience of more than 5 million people. Therefore, ICAN is “primarily engaged in disseminating information to the general public.” Further, as explained below, there is an “urgency to inform the public concerning actual or alleged Federal Government activity.” Accordingly, expedited processing of this request is warranted.

Dr. Fauci is the Director of The National Institute of Allergy and Infectious Diseases (“**NIAID**”). NIAID is an institute within NIH. The NIH claims that one of its goals is “to exemplify and promote the highest level of scientific integrity, public accountability, and social responsibility in the conduct of science.”<sup>3</sup>

Dr. Fauci, as Director of NIAID, is one of the most prominent public health officials in the country.<sup>4</sup> He has played and continues to play a critical role in the country’s response to the SARS-CoV-2 pandemic, frequently appearing across all mainstream media outlets to discuss issues regarding the pandemic.<sup>5</sup> His appearances and statements regarding the pandemic, including his agency’s role in the potential etiology and funding of SARS-CoV-2,<sup>6</sup> is of ongoing, immediate, and intense public interest in the media, the scientific community, and the public at large.

During a Senate hearing on July 20, 2021, Senator Paul accused Dr. Fauci of lying when he testified at a prior Congressional hearing<sup>7</sup> that the NIH never funded gain-of-function<sup>8</sup> research at the Wuhan Institute of Virology (the “**Wuhan Lab**”). Senator Paul held up the paper, which made plain that NIH had funded research at the Wuhan Lab that Senator Paul claims meets the definition of gain-of-function. Instead of admitting his prior statement was inaccurate, Dr. Fauci doubled down by stating that the “paper that you are referring to was judged by qualified staff up and down the chain as not being gain-of-function.” Dr. Fauci also told Senator Paul that he did “not know what [he was] talking about.”

Like all of Dr. Fauci’s comments relating to the pandemic, his comments to Senator Paul at the above-referenced congressional hearings regarding the Wuhan Lab, gain-of-function research and the 2015 Paper received media coverage across the largest mainstream media platforms, including CNN,<sup>9</sup> Fox News,<sup>10</sup> Forbes,<sup>11</sup> Business Insider,<sup>12</sup> NBC News,<sup>13</sup> Yahoo News,<sup>14</sup> Washington Examiner,<sup>15</sup> Newsweek,<sup>16</sup> BBC News,<sup>17</sup> and others.<sup>18</sup> In fact, the story is still being discussed today.<sup>19</sup>

The coronavirus pandemic has dominated the media for the last 18 months, and there is no indication that the pandemic will end anytime soon.<sup>20</sup> As such, all aspects of the pandemic, including the government’s response to and the origins of SARS-CoV-2, are a matter of substantial and ongoing public interest. The public’s interest in and need to understand the origins of SARS-

CoV-2 are intensified by allegations that the United States government may have funded gain-of-function research at the Wuhan Lab, which research may have led to the origin of SARS-CoV-2 and the death of more than 600,000 Americans. Given the fact that SARS-CoV-2 was first detected in Wuhan,<sup>21</sup> the current unfolding story regarding the U.S. government's funding of the Wuhan Lab is of critical public importance. ICAN seeks to disseminate the requested information to the public as expeditiously as possible.

ICAN certifies that the information in this request is true and correct to the best of ICAN's knowledge and belief.

Fees and charges for this search are to be waived pursuant to 5 U.S.C. § 552 (a)(4)(A)(iii) since ICAN is a not-for-profit 501(c)(3) organization and its mission is to raise public awareness about public health safety and provide the public with information to give informed consent regarding related health interventions. As part of its mission, ICAN investigates and disseminates information regarding public health safety issues, including through their website, and through press events and releases. ICAN is seeking the information in this FOIA request to allow it to contribute to its mission. The information requested in this FOIA request will not contribute to any commercial activities.

Please note that the FOIA provides that if only portions of a requested file are exempted from release, the remainder must still be released. We, therefore, request that we be provided with all non-exempt portions which are reasonably segregable. We further request that you describe any deleted or withheld material in detail and specify the statutory basis for the denial as well as your reasons for believing that the alleged statutory justification applies. Please also separately state your reasons for not invoking your discretionary powers to release the requested documents in the public interest. Such statements may help to avoid unnecessary appeal and litigation. ICAN of course reserves all rights to appeal the withholding or deletion of any information.

Access to the requested records should be granted within twenty (20) business days from the date of your receipt of this letter. Failure to respond in a timely manner shall be viewed as a denial of this request and ICAN may immediately file an administrative appeal.
