NARRATIVE:

On 6/23/21 at approximately 1904 hours, I was dispatched to a telephonic call for service reference a missing person.

I observed the call notes which showed that the reporting party, David [REDACTED] lives in South Carolina and that he had not heard from his son, Daniel [REDACTED] since this morning when he was at a job site in Buckeye.

I called Daniel's cell phone multiple times, the phone rang but I received no answer.

I then called Daniel's work, Matrix New World. I spoke with Georgia at the front desk and let her know about my investigation. Georgia was very concerned and said that she would start calling some supervisors and that they would be calling me.

I then spoke with David, by telephone. David said that his daughter had been to Daniel's apartment and that Daniel was not there and neither was his vehicle, which was described as a blue Jeep Renegade.

David also said that they had been receiving information from a co worker of Daniel's. He advised that Daniel had been to the job site in Buckeye but that he had left in the morning and had not come back.

I then spoke with Kevin [REDACTED] who is a supervisor with the company. He advised that Ken [REDACTED] with the company Weber, was the person that had met with Daniel.

I spoke with Ken on the phone. Ken advised that Daniel arrived at the site at around 0900 and that it was raining. Ken said that Daniel was saying things that did not make sense like asking if Ken wanted to go rest and then asked if he wanted to go to Phoenix to rest. Ken advised that Daniel was not making sense with the things that he was saying and that he was talking about things that did not make sense. Ken said that Daniel was there for approximately 15 minutes and that he suddenly left.

Ken said that he was concerned because of Daniel's behavior and spoke with Steve [REDACTED] who is the project manager, and let Steve know what had happened. Ken said that he continued working and that he was receiving updates throughout the day from Steve.

Ken said that at approximately 1500 hours he was made aware that Daniel had not been located and had not responded to texts or calls from work or family. Ken said that he then started to drive in the desert to find Daniel. Ken said that the road to their site runs north/south and that if you head south it comes to a "T" intersection and that if you turn east you go to Sun Valley Pkwy, where they had come from. Ken said that he could see Daniel's tire marks and that they turned westbound that the intersection which leads an extremely large desert area. Ken said that he drove down the road trying to locate Daniel but was unable to.

I updated David on my findings to that point. I let him know that I was going to circulate the area of the desert to try and find Daniel. I also let him know that Daniel was going to be put in NCIC as missing person.

Myself and Officer Thatcher spent hours trying to locate the vehicle in the area but were unable to locate Daniel.

Daniel was entered into NCIC as missing.

On 06/24/21 at approximately 0100 hours, I tried calling the phone again but there was no answer. This report is open until Daniel is located.

I have nothing further to report at this time.

NARRATIVE:

INITIAL INFORMATION I RECEIVED:

ON 06/24/2021, AT APPROXIMATELY 0600 HOURS, UPON LOGGING INTO THE BUCKEYE PD RECORD SYSTEM AT THE START OF MY SHIFT, I OBSERVED AN ALERT MESSAGE ON MY MOBILE HE MESSAGE ADVISED THAT A SUBJECT NAMED DANIEL CORNELIUS [REDACTED] IS LISTED AS A MISSING PERSON. THE MESSAGE PROVIDED [REDACTED] D SAID THAT DANIEL WAS LAST SEEN DRIVING A LIGHT BLUE, 2017 JEEP RENEGADE, BEARING AZ LICENSE PLATE [REDACTED] THE MESSAGE INCLUDED THE BUCKEYE PD DEPARTMENTAL REPORT NUMBER (DR#) WHICH IS 210623079.

AFTER OBSERVING THE SAID INFORMATION, I REVIEWED THE SAID REPORT, INCLUDING THE CALL NOTES. THE CASE OFFICER FOR THE INCIDENT WAS BUCKEYE PD OFFICER CREWSE. FROM REVIEWING THIS INFORMATION, I BECAME AWARE THAT BUCKEYE PD RECEIVED THE CALL FOR SERVICE ON 06/23/2021, AT APPROXIMATELY 1904 HOURS BY DANIEL'S FATHER, IDENTIFIED AS DAVID [REDACTED] DAVID HAD REPORTED TO DISPATCH HE HAS NOT HEARD FROM DANIEL SINCE 06/22/2021 AND THAT DANIEL WAS SUPPOSED TO BE AT HIS JOB AT THE TIME HE (DAVID) WAS MAKING THE REPORT (06/23/2021). DAVID

REPORTED DANIEL'S EMPLOYER IS "MATRIX GROUND WATER" AND THAT DANIEL'S JOB SITE WAS LOCATED AT AN UNKNOWN SPOT IN BUCKEYE, WEST OF THE WHITE TANK MOUNTAINS. DAVID REPORTED DANIEL HAS NO KNOWN MEDICAL ISSUES BUT HAD BEEN "ACTING STRANGE." NO DETAILS WERE PROVIDED INTO WHAT WAS "STRANGE" ABOUT DANIEL'S ACTIONS. DAVID REPORTED DANIEL DRIVES A LIGHT BLUE, 2017 JEEP RENEGADE.

UPON REVIEW OF THE SAID INFORMATION, I WAS AWARE THAT UPON CONCLUSION OF OFFICER CREWES'S INVESTIGATION, DANIEL WAS NOT ABLE TO BE LOCATED. DANIEL WAS THEN ENTERED INTO THE [REDACTED] AS MISSING.

ADDITIONALLY, I BECAME AWARE THAT DANIEL WAS LAST SEEN BY HIS CO-WORKER, IDENTIFIED AS KENNETH WILLARD P [REDACTED] DRIVING AWAY FROM HIS (DANIEL'S) JOB SITE. OFFICER CREWSE DOCUMENTED IN HIS REPORT THAT HE SPOKE TO KENNETH AND OBTAINED THE LOCATION OF THE JOB SITE. THE JOB SITE WAS LOCATED ABOUT 1 MILE WEST OF N SUN VALLEY PKWY AND ABOUT 2000 FT NORTH OF W CACTUS RD. FURTHERMORE,

UPON REVIEW OF OFFICER CREWSE'S REPORT, I BECAME AWARE THAT KENNETH REPORTED ACCESS TO THE JOB SITE WAS VIA A DIRT ROAD WHICH STARTS ON THE WEST SIDE OF N SUN VALLEY PKWY, AT CACTUS RD. FROM THERE, THERE IS A DIRT ROAD WHICH CONTINUES WEST FOR ABOUT 1 MILE THEN SPLITS UP INTO A DIRT ROAD THAT GOES NORTH AND A DIRT ROAD THAT CONTINUES WEST. KENNETH ADVISED AT THE SPLIT IN THE DIRT ROAD YOU GO NORTH FOR ABOUT 2000 FT AND YOU WILL BE AT THE SITE.

UPON REVIEW OF OFFICER CREWSE'S REPORT, I BECAME AWARE THAT KENNETH BELIEVED DANIEL WAS ACTING ODD AT THE JOB SITE AND THAT HE LAST SAW DANIEL DRIVE AWAY FROM THE JOB SITE, GOING SOUTH. ADDITIONALLY, KENNETH REPORTED HE WAS NOT SURE IF DANIEL MADE IT TO THE SAID SPLIT IN THE ROADWAY ON THE DIRT TRAIL. KENNETH ADVISED AFTER SOMETIME, HE BEGAN LOOKING AROUND THE AREA AND AT THE SPLIT IN THE ROADWAY, HE (KENNETH) FOUND WHAT LOOKED LIKE FRESH TIRE TRACKS WHICH WENT WEST AT THE SPLIT IN THE ROADWAY. OFFICER CREWSE DOCUMENTED IN HIS REPORT THAT NUMEROUS ATTEMPTS TO CONTACT DANIEL BUT RECEIVED NEGATIVE CONTACT. FURTHERMORE, HE DOCUMENTED HE AND BUCKEYE PD OFFICER THATCHER SEARCHED THE AREA FOR DANIEL BUT DID NOT LOCATE DANIEL OR HIS JEEP RENEGADE.

ACTIONS TAKEN BY ME:

AFTER REVIEWING THE SAID REPORT, I CONDUCTED FOLLOW-UP TO THE INCIDENT TO TRY AND LOCATE DANIEL.

CALLING DANIEL'S PHONE:

AT APPROXIMATELY 0737 HOURS, I CALLED DANIEL'S LISTED PHONE NUMBER. WHEN I CALLED, THE CALL WENT STRAIGHT TO VOICEMAIL AND I DID NOT LEAVE A VOICEMAIL. DANIEL'S PHONE WAS ALSO ATTEMPTED TO BE CALLED BY BUCKEYE PD OFFICER RADLOFF AT APPROXIMATELY 1145 HOURS BUT THE CALL WENT STRAIGHT TO VOICEMAIL.

CONTACT WITH DAVID:

AFTER I ATTEMPTED CONTACT WITH DANIEL BY PHONE, I CALLED DAVID. DAVID ANSWERED AND HE AND TALKED ABOUT THE SITUATION. I INFORMED DAVID OF WHO I WAS AND THAT I WAS CONTINUING TO INVESTIGATE THE SITUATION REGARDING DANIEL GOING MISSING. DAVID WAS ASKED IF HE HAS SINCE HEARD FROM DANIEL OR IF HE KNEW OF DANIEL'S

WHEREABOUTS. DAVID ADVISED HE HAD NOT HEARD FROM DANIEL AND DIDN'T KNOW WHERE DANIEL WAS AT.

I ASKED DAVID IF HE KNEW OF ANY LOCATIONS WHERE DANIEL WOULD GO. DAVID SAID HE DIDN'T KNOW OF ANY SPECIFIC LOCATIONS. I ASKED DAVID IF DANIEL HAD ANY FAMILY OR FRIEND'S IN ARIZONA. DAVID ADVISED HE (DAVID) LIVES IN SOUTH CAROLINA AND THAT DANIEL'S MOTHER LIVES THERE TOO. HE SAID DANIEL'S SISTER LIVES IN CALIFORNIA BUT HE DIDN'T KNOW HER SPECIFIC ADDRESS IN CALIFORNIA. DAVID SAID DANIEL LIVES ALONE [REDACTED] DANIEL'S OTHER SISTER, IDENTIFIED AS DAVISHA LAFAYETTE [REDACTED] WAS THE ONLY FAMILY MEMBER WHICH LIVES IN ARIZONA. DAVID SAID HE HAS SINCE BEEN IN CONTACT WITH DAVISHA, AS WELL AS THE REST OF THEIR FAMILY BUT NO ONE HAS HEARD FROM DANIEL OR KNEW DANIEL'S WHEREABOUTS. DAVID PROVIDED ME WITH DAVISHA'S CONTACT INFORMATION AS I WAS NOT AWARE OF IT AT THE TIME.

I ASKED DAVID IF HE WAS AWARE OF DANIEL HAVING ANY MEDICAL AND OR MENTAL HEALTH ISSUES. DAVID SAID HE WAS NOT AWARE OF DANIEL HAVING ANY MEDICAL OR MENTAL HEALTH ISSUE(S.) DAVID STATED THAT DANIEL HAD BEEN ACTING ODD LATELY. I ASKED DAVID IF HE CAN EXPLAIN WHAT HE MEANT BY THIS. DAVID STATED WITHIN THE LAST FEW WEEK'S, DANIEL HAD TOLD HIM HE HAD MET A WOMEN AND THAT HE WAS IN LOVE WITH HER. DAVID SAID DANIEL DIDN'T APPEAR TO KNOW ANYTHING ABOUT THE WOMEN AND THAT HE THOUGHT IT WAS ODD HE WAS IN LOVE WITH HER. DAVID DID NOT PROVIDE ANY OTHER EXAMPLES OF WHY HE BELIEVED DANIEL WAS ACTING ODD SO I ASKED DAVID IF HE HAD EVER OBSERVED DANIEL DOING AND OR SAYING ANYTHING THAT WOULD SUGGEST HE (DANIEL) WANTED TO HURT AND OR KILL HIMSELF. DAVID ADVISED HE HAD NOT OBSERVED ANYTHING LIKE THAT. I THEN ASKED DAVID IF HE HAD HEARD ANY INFORMATION FROM ANYONE ELSE ABOUT DANIEL WANTING TO HURT AND OR KILL HIMSELF. DAVID SAID HE HAS NOT HEARD ANYTHING LIKE THAT FROM ANYONE ELSE.

ULTIMATELY, DAVID REPORTED NO INFORMATION THAT SUGGESTED DANIEL WAS SUICIDAL OR THAT DANIEL WANTED TO HURT HIMSELF.

I ASKED DAVID IF DANIEL USES ANY DRUGS SUCH AS MARIJUANA, COCAINE, METHAMPHETAMINE, ETC. DAVID SAID HE WAS ONLY AWARE OF DANIEL USING MARIJUANA.

I ASKED DAVID IF DANIEL HAD ANY SOCIAL MEDIA ACCOUNTS AND IF HE DID, HAS HE (DAVID) CHECKED THEM TO SEE IF DANIEL HAS POSTED ANY PHOTOS OR INFORMATION ON THE ACCOUNTS SINCE HE WENT MISSING. DAVID TOLD ME DANIEL DOES HAVE AN INSTAGRAM ACCOUNT AND A FACEBOOK ACCOUNT. DAVID CHECKED THEM WHILE HE WAS ON THE PHONE WITH ME AND ADVISED HE DID NOT SEE ANY NEW INFORMATION ON THE ACCOUNTS. DAVID SAID DANIEL'S PHOTOS ON HIS INSTAGRAM ACCOUNT APPEARED TO HAVE BEEN REMOVED SINCE HE HAS GONE MISSING. DAVID SAID THE PHOTOS WERE ON DANIEL'S INSTAGRAM ACCOUNT PRIOR TO HIM GOING MISSING.

DAVID PROVIDED ME WITH DANIEL'S ACCOUNT NAMES FOR FACEBOOK AND FOR INSTAGRAM. HE ALSO DESCRIBED THE IMAGE/PHOTO USED BY DANIEL FOR EACH ACCOUNT. THEY ARE AS FOLLOWS:

I ASKED DAVID IF HE HAD EVER MET THE WOMEN WHICH DANIEL HAD RECENTLY TOLD HIM ABOUT. DAVID SAID NO. I ASKED DAVID IF HE KNEW HER NAME OR HAD ANY INFORMATION ABOUT HER. DAVID SAID HER NAME IS "KATELYN" AND THAT HE WAS ABLE TO LOCATE HER INSTAGRAM ACCOUNT. HER ACCOUNT INFORMATION WAS REPORTED AS THE FOLLOWING:

I ASKED DAVID IF HE HAD ANY OTHER CONCERNS FOR DANIEL. DAVID ADVISED THIS SITUATION WAS JUST NOT LIKE DANIEL TO DO. DAVID ADVISED THAT DANIEL HAS NEVER DONE ANYTHING LIKE THIS BEFORE, ESPECIALLY NOT NOTIFYING ANYONE ABOUT WHAT WAS GOING ON.

I INFORMED DAVID I WOULD CONTACT HIM LATER WITH THE OUTCOME OF MY INVESTIGATION. I TOLD DAVID THAT HE NEEDED TO REPORT TO POLICE ANY INFORMATION REGARDING DANIEL'S WHEREABOUTS AND OR ANY CONTACT FROM DANIEL. DAVID SAID HE WOULD AND WE DISCONNECTED.

CONTACT WITH DAVISHA:

AFTER SPEAKING TO DAVID, I CALLED DAVISHA. DAVISHA ANSWERED AND SHE AND I TALKED ABOUT THE SITUATION. I FIRST INFORMED DAVISHA OF WHO I WAS AND THAT I WAS CONTINUING TO INVESTIGATE THE SITUATION REGARDING DANIEL GOING MISSING. DAVISHA WAS AWARE OF DANIEL MISSING AND SAID SHE HAS BEEN IN CONTACT WITH HER FAMILY BUT NO ONE HAS HEARD FROM DANIEL OR WAS AWARE OF HIS WHEREABOUTS. DAVISHA WAS DIRECTLY ASKED IF SHE HAS SINCE HEARD FROM DANIEL OR IF SHE KNEW OF DANIEL'S WHEREABOUTS. DAVISHA SAID SHE HAS NOT HEARD FROM DANIEL AND DID NOT KNOW WHERE HE WAS AT.

I ASKED DAVISHA IF SHE KNEW OF ANY LOCATIONS WHERE DANIEL WOULD GO. DAVISHA SAID SHE WAS UNAWARE OF ANY SPECIFIC LOCATIONS. I ASKED HER IF DANIEL HAD ANY FAMILY OR FRIEND'S IN ARIZONA AND INFORMED HER OF DAVID'S REPORT OF FAMILY AND FRIEND'S THAT HE (DAVID) REPORTED TO ME. DAVISHA ADVISED SHE WAS NOT AWARE OF ANY OTHER FAMILY OR FRIENDS TO CONTACT, OTHER THEN WHAT HAD BEEN ALREADY REPORTED BY DAVID. DAVISHA CONFIRMED THAT DANIEL LIVES ALONE IN TEMPE, AZ AND THAT SHE LIVES IN PHOENIX. DAVISHA CONFIRMED HER ADDRESS WITH ME. DAVISHA SAID DANIEL USE TO LIVE IN PHOENIX BUT HAS BEEN LIVING AT HIS CURRENT ADDRESS IN TEMPE FOR THE LAST YEAR. DURING MY CONVERSATION WITH DAVISHA, SHE CONFIRMED THAT DANIEL WORKS FOR [REDACTED] AND HAS BEEN AT THAT JOB FOR ABOUT A YEAR.

I ASKED DAVISHA IF SHE WAS AWARE OF DANIEL HAVING ANY MEDICAL AND OR MENTAL HEALTH ISSUES. DAVISHA SAID SHE WAS NOT AWARE OF DANIEL HAVING ANY MEDICAL OR MENTAL HEALTH ISSUE(S.)

I INFORMED DAVISHA THAT DAVID AND KENNETH REPORTED DANIEL WAS ACTING ODD TO THEM AND THE INFORMATION THEY REPORTED ABOUT THIS. I ASKED DAVISHA IF SHE HAD ANY KNOWLEDGE OF DANIEL ACTING ODD LATELY. DAVISHA SAID ONCE, DANIEL CAME OVER ONCE TO HER APARTMENT AND WOULD JUST SIT THERE FOR ABOUT 30 MINUTES AND WOULDN'T SAY ANYTHING. SHE SAID SHE TRIED TO TALK TO HIM BUT HE WOULD JUST SIT THERE AND NOT RESPOND. DAVISHA SAID HE THEN WALKED OUT OF THE APARTMENT.

DAVISHA ALSO MENTIONED THAT DANIEL HAS BEEN TALKING ABOUT MEETING A WOMEN RECENTLY AND THAT HE WAS IN LOVE WITH THE WOMEN. SHE SAID DANIEL TOLD HER THAT THIS WOMEN TOLD HIM ABOUT AN AUDIO PODCAST TO LISTEN TOO AND THAT UPON LISTENING TO IT, IT CHANGED THE WAY HE LOOKS AT LIFE. DAVISHA SAID DANIEL TOLD HER THE

PODCAST SHOWED HIM HOW TO VIEW THINGS IN THE WORLD IN A POSITIVE ENERGY AND TO AVOID NEGATIVE ENERGY. DAVISHA SAID HE TOLD HER HE WAS IN LOVE WITH THIS WOMEN AND ULTIMATELY MADE IT SOUND AS IF THEY WERE IN A RELATIONSHIP TOGETHER. I ASKED DAVISHA IF THE FEMALE'S NAME WAS "KATELYN" AND SHE SAID SHE BELIEVED SO. I ASKED DAVISHA IF SHE HAD ANY CONTACT INFORMATION FOR HER. DAVISHA SAID SHE DIDN'T BUT BELIEVED DANIEL TOLD HER ADDRESS WAS IN LAVEEN, AZ.

DAVISHA DIDN'T REPORT ANY OTHER INFORMATION REGARDING DANIEL ACTING ODD. DUE TO THIS, I ASKED DAVISHA IF SHE HAD ANY KNOWLEDGE OF DANIEL DOING AND OR SAYING ANYTHING THAT WOULD SUGGEST HE (DANIEL) WANTED TO HURT AND OR KILL HIMSELF. DAVISHA SAID SHE HAS NOT OBSERVED ANYTHING LIKE THAT. I THEN ASKED DAVISHA IF HE HAD HEARD ANY INFORMATION FROM ANYONE ELSE ABOUT DANIEL WANTING TO HURT AND OR KILL HIMSELF. DAVISHA SAID SHE HAS NOT HEARD ANYTHING LIKE THAT FROM ANYONE ELSE. ULTIMATELY, DAVISHA REPORTED NO INFORMATION THAT SUGGESTED DANIEL WAS SUICIDAL OR THAT DANIEL WANTED TO HURT HIMSELF.

I ASKED DAVISHA IF SHE WAS AWARE OF DANIEL USING ANY DRUGS SUCH AS MARIJUANA, COCAINE, METHAMPHETAMINE, ETC. DAVISHA SAID SHE WAS ONLY AWARE OF DANIEL USING MARIJUANA AND DRINKING ALCOHOL.

I INFORMED DAVISHA OF DAVID'S REPORT REGARDING DANIEL'S SOCIAL MEDIA ACCOUNTS. I ASKED HER IF SHE WAS AWARE OF DANIEL POSTING OR PUTTING ANY PICTURES AND OR PHOTOS ON HIS ACCOUNTS SINCE HE (DANIEL) WENT MISSING. DAVISHA SAID SHE WAS NOT AWARE OF ANY NEW PHOTOS AND OR INFORMATION POSTED ON DANIEL'S ACCOUNTS. DAVISHA DID CONFIRM THAT IT APPEARED THAT DANIEL'S PHOTOS WERE ALL TAKEN OFF OF HIS INSTAGRAM ACCOUNT.

I ASKED DAVISHA IF SHE HAD ANY OTHER CONCERNS FOR DANIEL. DAVISHA ADVISED THIS SITUATION WAS JUST NOT LIKE DANIEL TO DO. DAVISHA SAID ONE TIME DANIEL DROVE OUT TO CALIFORNIA TO SEE THEIR SISTER AND DIDN'T TELL ANYONE HE WAS DOING THAT. DAVISHA SAID HOWEVER, DANIEL LEAVING AND NOT ANSWERING HIS PHONE, NOT TALKING TO ANY OF HIS EMPLOYEE'S OR ANYONE ELSE WAS NOT SOMETHING DANIEL WOULD DO. I ASKED DAVISHA WHEN DAVID DROVE OUT TO CALIFORNIA TO SEE THEIR SISTER. DAVISHA SHE SAID IT WAS AROUND 05/30/2021.

I INFORMED DAVISHA I WOULD CONTACT HER LATER WITH THE OUTCOME OF MY INVESTIGATION. I TOLD HER THAT SHE NEEDED TO REPORT TO POLICE ANY INFORMATION REGARDING DANIEL'S WHEREABOUTS AND OR ANY CONTACT FROM DANIEL. DAVISHA SAID SHE WOULD AND WE DISCONNECTED.

CONTACT WITH DANIEL'S EMPLOYEE'S FOR [REDACTED] GLOBAL WATER:

SPEAKING TO DAVISHA, I WAS ABLE TO S [REDACTED] HE EMPLOYEE'S FOR [REDACTED] GLOBAL WATER, IDENTIFIED AS KEVIN [REDACTED] 1983. I INFORMED KEVIN OF WHO I WAS AND THAT I WAS CONDUCTING FOLLOW UP IN REFERENCE TO DANIEL BEING A MISSING PERSON.

KEVIN ADVISED HE WAS AWARE OF DANIEL MISSING FROM THE JOB SITE AND THAT HE WAS ONE OF DANIEL'S SUPERVISORS. KEVIN SAID DANIEL DOES IN FACT WORK FOR [REDACTED] GLOBAL WATER AND HAS BEEN EMPLOYEE WITH THEM FOR ABOUT 1 YEAR. KEVIN [REDACTED] WAS NOT WITH DANIEL AT THE JOB SITE YESTERDAY (06/23/2021) BUT THAT KENNETH WAS AND KENNETH TOLD HIM WHAT HAPPENED. THIS WAS THE SAME KENNETH AS PREVIOUSLY REPORTED.

KEVIN ADVISED SINCE DANIEL HAS BEEN MISSING, HE HAS NOT HEARD FROM DANIEL AND THAT NO ONE IN THE COMPANY HAS RECEIVED CONTACT FROM HIM. KEVIN SAID THIS WAS

UNLIKE DANIEL AS HE HAD NEVER DONE SOMETHING LIKE THIS BEFORE WHILE WORKING FOR THE COMPANY. KEVIN SAID DANIEL DID NOT SHOW UP TO WORK TODAY (06/24/2021) EVEN THOUGH HIS SHIFT STARTED EARLIER TODAY (06/24/2021).

I ASKED KEVIN IF HE COULD SEND ME THE COORDINATES TO THE JOB SITE LOCATION WHERE KENNETH AND DANIEL WERE AT ON 06/23/2021. KEVIN ADVISED HE WOULD. I THEN PROVIDED KEVIN WITH MY CONTACT INFORMATION. I INFORMED KEVIN I WOULD CONTACT HIM BACK WITH THE OUTCOME MY INVESTIGATION. I TOLD KEVIN TO CALL POLICE IF DANIEL CONTACTED HIM OR IF DANIEL'S WHEREABOUTS WERE KNOWN. KEVIN SAID HE WOULD.

A SHORT TIME AFTER ENDING MY CONTACT WITH KEVIN, I RECEIVED AN IMAGE FROM KEVIN ON MY WORK EMAIL. UPON REVIEW OF THE IMAGE, IT WAS AN IMAGE OF A SCREEN SHOT FROM A CELL PHONE, SHOWING THE GOOGLE MAPS APPLICATION. THE IMAGE OF THE MAP WAS IN "SATELLITE VIEW" AND IT SHOWED THE AREA OF SUN VALLEY PKWY AND CACTUS RD IN BUCKEYE, AZ. THE IMAGE OF THE MAP AREA HAD RED COLORED PEN MARKS SHOWING NOTES OF WHERE THE JOB SITE WAS LOCATED.

KEVIN ALSO SENT ME A DIRECT TEXT MESSAGE TO MY WORK CELL PHONE. THE TEXT MESSAGE WAS A DIRECT LINK TO A "DROPPED PIN" LOCATION VIA THE GOOGLE MAPS APPLICATION. I CLICKED ON THE LINK AND IT TOOK ME TO [REDACTED] LOCATION, TO THE LOCATION OF THE FOLLOWING COORDINATES: [REDACTED]

THIS LOCATION IS ABOUT 1 MILE WEST OF SUN VALLEY PKWY, AND ABOUT 1 MILE NORTH OF W CACTUS RD. THIS LOCATION APPEARED TO BE THE JOB SITE AS DESCRIBED.

AFTER SPEAKING TO KEVIN, I CONTACTED KENNETH BY PHONE. KENNETH ANSWERED THE PHONE WHEN I CALLED. I INFORMED HIM OF WHO I WAS AND THAT I WAS CONDUCTING FOLLOW UP TO DANIEL BEING A MISSING PERSON. I ASKED KENNETH IF HE HAD HEARD FROM DANIEL SINCE HE WAS MISSING OR IF HE KNEW DANIEL'S WHEREABOUTS. KENNETH SAID HE DIDN'T KNOW WHERE HE WAS AND HAS NOT HEARD FROM HIM.

I ASKED KENNETH IF HE COULD RE-EXPLAIN TO ME WHAT HAPPENED THE DAY DANIEL WENT MISSING. KENNETH SAID HE (KENNETH) WORKS FOR ANOTHER COMPANY THAT WORKS ALONG WITH [REDACTED] GLOBAL WATER. KENNETH SAID THE DAY OF THE INCIDENT (06/23/2021) WAS THE FIRST TIME HE MET DANIEL. KENNETH SAID THEY DROVE OUT TO THE JOB SITE, HE IN HIS VEHICLE AND DANIEL IN HIS JEEP. KENNETH EXPLAINED TO ME OVER THE PHONE THE LOCATION OF HOW THEY GOT INTO THE LOCATION. THIS MATCHED THE IMAGE AS SEEN ON GOOGLE MAPS AS DESCRIBED ABOVE. KENNETH SAID THEY GOT TO THE JOB SITE AT APPROXIMATELY 0930 HOURS.

KENNETH WHEN THEY GOT TO THE JOB SITE, AT TIMES HE NOTICED DANIEL APPEARED TO STARE OFF INTO THE DISTANCE OR WOULD JUST BE STARING AT NOTHING IN PARTICULAR. KENNETH SAID DANIEL WOULD TALK TO HIM AT TIMES BUT IT WAS REGARDING TOPICS THAT WERE NOT RELATED TO THE WORK THEY WERE THERE TO DO. KENNETH SAID THIS WAS ODD TO HIM (KENNETH). ACCORDING TO KENNETH, HE RECALLS DANIEL ASKING HIM, "DO YOU WANT TO GO HOME? DO YOU WANT TO GO BACK TO PHOENIX?" KENNETH SAID AT THAT TIME IT APPEARED IT WAS GOING TO RAIN. KENNETH SAID HE TOLD DANIEL HE WOULD CHECK THE WEATHER APPLICATION ON HIS CELL PHONE. KENNETH STATED AS HE (KENNETH) BEGAN TO LOOK AT A WEATHER APPLICATION ON HIS CELL PHONE, AT ABOUT 0945 HOURS, HE SAW DANIEL WAVE TO HIM AS IF HE WAS WAVING GOODBYE. KENNETH SAID DANIEL DIDN'T SAY ANYTHING, WALKED OVER TO HIS JEEP AND DROVE AWAY FROM THE AREA. KENNETH SAID DANIEL WAS LAST SEEN DRIVING SOUTH ON THE DIRT ROAD FROM THE JOB SITE.

KENNETH EXPLAINED THAT IF DANIEL CONTINUED SOUTH DOWN THE DIRT ROAD, HE WOULD OF COME TO A SPOT WHERE THE ROAD SPLITS TO THE WEST AND TO THE EAST. HE SAID AFTER DANIEL DIDN'T COME BACK TO THE AREA, HE WENT LOOKING FOR DANIEL. KENNETH SAID AT THE SPLIT IN THE ROADWAY, HE SAW SOME FRESH TIRE TRACKS THAT WENT WEST.

KENNETH SAID IT HAD RAINED WHILE THEY WERE OUT THERE SO HE BELIEVED THE RAIN WASHED AWAY ALL THE TIRE TRACKS AND THE NEW TRACKS WAS FROM DANIEL'S VEHICLE. KENNETH SAID AT ONE POINT, HE WENT TO A PART OF HIGH GROUND TO SCAN THE AREA FOR DANIEL BUT ULTIMATELY COULDN'T FIND HIM.

KENNETH TOLD ME AT SOME POINT, AFTER DANIEL LEFT THE JOB SITE (KENNETH) CONTACTED HIS BOSS "STEVE [REDACTED] INFORMING HIM OF WHAT WAS GOING ON. KENNETH STATED HE LATER RECEIVED WORD FROM STEVE AND OTHER EMPLOYEES THAT DANIEL DID NOT CONTACT ANYONE IN THE COMPANY SINCE HE LEFT THE JOB SITE AND THAT NO ONE KNEW WHERE HE (DANIEL) WAS AT.

KENNETH ULTIMATELY REPORTED NO BEHAVIOR OR STATEMENTS FROM DANIEL THAT SUGGESTED HE WAS HALLUCINATING, THAT HE WAS INCOHERENT, AND OR WAS HAVING SOME KIND OF MENTAL HEALTH ISSUE. ADDITIONALLY, KENNETH ADVISED DANIEL DID NOT MAKE ANY DIRECT OR INDIRECT SUICIDAL STATEMENTS OR ACTIONS.

BEFORE ENDING MY CONTACT WITH KENNETH, I INFORMED HIM HE NEEDS TO REPORT TO POLICE ANY INFORMATION HE OBTAINS REGARDING DANIEL'S WHEREABOUTS OR IF DANIEL CONTACTS HIM. KENNETH SAID HE WOULD.

INVESTIGATION INTO "KATELYN":

AFTER SPEAKING TO KENNETH, I CHECKED THE NAME "KATELYN [REDACTED] THROUGH THE NCIC/ACIC, MVD AND BUCKEYE PD RECO RECORDS IN THE BUCKEYE PD AND OR [REDACTED] SYSTEM, I WAS ABLE TO LOCATE A FEMALE NAMED KATELYN ANN [REDACTED] KATELYN'S PHYSICAL CHARACTERISTICS MATCHED THE FEMALE AS ACCOUNT "KATELYN. [REDACTED]

FURTHERMORE, KATELYN'S ADDRESS LISTED IN THE [REDACTED] SHOWED IN LAVEEN, AZ. BELIEVING THIS TO BE THE SUBJECT CONNECT [REDACTED] HAD PHOENIX PD RESPOND TO KATELYN'S ADDRESS TO ATTEMPT CONTACT WITH HER. PHOENIX PD OFFICER SANCHEZ #8162 CALLED ME BACK A SHORT TIME LATER AND ADVISED ME HE WAS ABLE TO MAKE CONTACT WITH KATELYN AT HER HOME. OFFICER SANCHEZ ADVISED ME THAT KATELYN WAS NOT WITH DANIEL AND DID NOT KNOW DANIEL'S WHEREABOUTS. OFFICER SANCHEZ PROVIDED ME WITH KATELYN'S NUMBER AND SAID THAT KATELYN WAS AVAILABLE FOR CONTACT IF NEEDED.

AFTER SPEAKING TO OFFICER SANCHEZ, I CALLED KATELYN AND SHE ANSWERED THE PHONE. I INFORMED KATELYN OF WHO I WAS AND ADVISED HER OF THE SITUATION REGARDING DANIEL GOING MISSING. I INFORMED KATELYN THAT SHE WAS NOT IN TROUBLE AND THAT NEITHER WAS DANIEL. I TOLD KATELYN I WAS ONLY CALLING TO ASK HER SOME QUESTIONS TO SEE HOW SHE KNEW DANIEL AND IF SHE KNEW ANY INFORMATION THAT COULD ASSIST POLICE IN LOCATING HIM.

KATELYN SAID SHE UNDERSTOOD WAS WILLING TO TALK TO ME ABOUT THE SITUATION. KATELYN ADVISED SHE DID NOT KNOW WHERE DANIEL WAS LOCATED AND THAT SHE HAD LAST HEARD FROM DANIEL VIA A TEXT MESSAGE ON 06/22/2021.

KATELYN EXPLAINED THAT SHE AND DANIEL ARE NOT IN A RELATIONSHIP AND THAT SHE HAS ONLY KNOWN HIM SINCE 06/12/2021. ACCORDING TO KATELYN, ON THAT SAID DAY, HER AND HER FEMALE FRIEND WERE AT HER HOME (KATELYN'S HOME) AND THAT THEY ORDERED FOOD THROUGH A SERVICE CALLED "INSTACART." KATELYN EXPLAINED INSTACART WAS A FOOD ORDERING SERVICE SIMILAR TO "GRUBHUB" AND "UBER." I WAS AWARE THAT THESE FOOD SERVICES ALLOW A CUSTOMER/USER TO ORDER FOOD FROM A SELECTION OF PLACES AND UPON ORDERING THE FOOD, THE EMPLOYEE WORKING FOR THE FOOD DELIVERY SERVICE WILL

PICK UP THE FOOD AND WILL DELIVER IT TO ANY LOCATION THE CUSTOMER SPECIFIES. KATELYN SAID DANIEL WAS THE PERSON WHO DELIVERED THEIR FOOD THAT NIGHT.

KATELYN SAID DANIEL WAS VERY NICE AND SHE AND HER FEMALE FRIEND ASKED DANIEL IF HE WANTED TO HANG OUT WITH THEM AT THAT TIME. KATELYN SAID SHE AND HER FEMALE FRIEND "WERE DRUNK" AND THAT LOOKING BACK ON IT, SHE SHOULDN'T HAVE INVITED A STRANGER INTO HER HOME. KATELYN SAID SHE BELIEVED DANIEL WAS HARMLESS THOUGH AS HE HAD ONLY ONE ARM AND WAS SHORT IN HEIGHT.

KATELYN ADVISED DANIEL AND HER EXCHANGED PHONE NUMBERS THAT NIGHT AND SHE SENT HIM A PODCAST THAT HE SHOULD LISTEN TO. KATELYN ADVISED NOTHING ELSE HAPPENED THAT NIGHT WHICH WAS ODD, ABNORMAL AND OR CRIMINAL. KATELYN SAID THAT NIGHT, DANIEL HAD A CANOPY WHICH HE HAD IN HIS VEHICLE WHICH HE LEFT AT HER HOME ACCIDENTALLY. KATELYN ADVISED THAT A FEW DAYS AFTER THAT NIGHT (06/12/2021), DANIEL SENT HER A TEXT MESSAGE THAT HE HAD ACCIDENTALLY LEFT THE CANOPY AND ASKED HER WHEN IT WAS OKAY FOR HIM TO COME GET IT. KATELYN SAID SHE SENT A TEXT MESSAGE BACK TO DANIEL SAYING HE COULD COME BY ANYTIME TO GET IT.

KATELYN ADVISED DANIEL SENT HER ANOTHER TEXT MESSAGE SAYING HE COULD COME BY RIGHT THEN OR TOMORROW AFTERNOON. SHE SAID HE THEN SENT HER A TEXT MESSAGE ASKING FOR DIRECTIONS TO HER HOME. KATELYN SAID SHE NEVER RESPONDED BACK TO DANIEL AS SHE WAS OUT OF TOWN AT THE TIME. SHE SAID WHILE SHE WAS OUT OF TOWN, SHE OBSERVED DANIEL ON HER HOME SECURITY CAMERA'S GO UP TO HER DOOR, ATTEMPTING TO MAKE CONTACT, THEN LEAVING THE AREA. KATELYN SAID SHE FELT THAT DANIEL SHOULD OF ASKED FOR PERMISSION TO COME OVER TO HER HOME BEFORE JUST SHOWING UP THERE. KATELYN TOLD ME SHE ALSO NEVER PROVIDED DANIEL WITH HER ADDRESS OR DIRECTIONS TO HER HOME SO SHE SAID HE EITHER USED THE INSTACART FOOD ORDER INFORMATION TO OBTAIN HER ADDRESS OR REMEMBERED HOW TO GET TO HER HOME.

KATELYN SAID ON 06/16/2021, SHE SENT DANIEL A TEXT MESSAGE ADVISING THAT SHE HAD SEEN HIM ON HER SECURITY CAMERA'S BUT THAT SHE WASN'T HOME. KATELYN SAID SHE TOLD DANIEL WHEN SHE CAME BACK TO TOWN, SHE WILL MAKE ARRANGEMENTS FOR HIM TO GET THE CANOPY.

KATELYN SAID DANIEL THEN BEGAN TO BECOME VERY "CREEPY" SENDING HER A TEXT MESSAGE OF A HEART EMOJI AND SENDING HER A TEXT MESSAGE SAYING THAT HE LOVES HER. KATELYN SAID ONE DAY AFTER THIS MESSAGE, HE SENT HER A TEXT MESSAGE THAT HE WAS OUTSIDE OF HER HOME. KATELYN SAID THIS MADE HER VERY CONCERNED. ACCORDING TO KATELYN, SHE WAS UNSURE WHY DANIEL WOULD FALL IN LOVE WITH HER OR BE IN LOVE HER BECAUSE ACCORDING TO KATELYN, SHE NEVER DID OR SAID ANYTHING THAT WOULD MAKE DANIEL THINK SHE WANTED THAT KIND OF RELATIONSHIP. KATELYN SAID WHAT MADE HER MORE WORRIED WAS DANIEL COMING OVER TO HER HOME UNANNOUNCED, EVEN AFTER BEING TOLD NOT TO. KATELYN SAID SHE SENT DANIEL A MESSAGE TELLING HIM SHE DID NOT FEEL COMFORTABLE ABOUT HIM COMING TO HER HOME UNANNOUNCED AND TO ULTIMATELY STOP TALKING TO HER. KATELYN SAID SENT DANIEL HER LAST CONTACT FROM DANIEL WAS A TEXT MESSAGE FROM HIM ON 06/22/2021, AROUND 1500 HOURS, WHERE HE SAID SHE WOULDN'T SEE HIM ANYMORE. KATELYN SAID SHE HAS SINCE NOT HEARD FROM DANIEL.

KATELYN SAID SHE WILL SCREEN SHOT THE TEXT MESSAGES AND WILL SEND THEM TO ME. I ASKED HER TO UPLOADED THE SCREEN SHOTS INTO EVIDENCE.COM VIA THE AXON CITIZEN CAPTURE LINK WHICH I SENT HER.

I INFORMED KATELYN ABOUT THE INJUNCTION AGAINST HARASSMENT PROCESS AND THE AZPOINT WEBSITE. I INFORMED HER SHE SHOULD MAKE A REPORT WITH PHOENIX PD BUT THAT I WOULD DOCUMENT WHAT SHE TOLD ME IN MY REPORT. I PROVIDED HER WITH THE REPORT NUMBER AND MY CONTACT INFORMATION. I TOLD HER TO CALL POLICE IF SHE HEARD FROM DANIEL OR KNEW ANYTHING REGARDING HIS WHEREABOUTS.

AFTER SPEAKING TO KATELYN, I LATER RECEIVED NOTIFICATION VIA EVIDENCE.COM THAT KATELYN UPLOADED 4 IMAGES. UPON REVIEW OF THEM, IT APPEARED THAT THEY WERE SCREEN SHOTS TAKEN FROM A PHONE WHICH APPEARS TO SHOW TEXT MESSAGE COMMUNICATION BETWEEN HER AND DANIEL. THE FOLLOWING ARE THE TEXT MESSAGES BETWEEN KATELYN AND DANIEL AND THE DATES/TIMES FOR THEM.

KATELYN: (KATELYN SENDS A LINK) "podcasts.apple.com"

Sun, Jun 13, 2:29 AM

DANIEL: "Hey"

Mon, Jun 14, 7:19 PM

DANIEL: "Hey I accidentally left my canopy outside your house. Is it still there? If so, is it okay if I pick it up?"

DANIEL: "Also the podcast was great!"

Tue, Jun 15, 1:37 PM

KATELYN: "Yes you can pick it up whenever!!"

Tue, Jun 15, 8:30 PM

DANIEL: "Thanks. How do I get there again? I can come now or tomorrow afternoon to grab it."

Wed, Jun 16, 2:06 PM

KATELYN: "Hi! I saw you on the camera..I'm in flagstaff and will be home later tonight. If you want I can put it out front by the chairs before I head out for work tomorrow morning?"

TEMPE PD SENT OUT TO DANIEL'S HOME:

ON 06/24/2021, I HAD BUCKEYE PD DISPATCH CONTACT TEMPE PD AND REQUESTED THEY CHECK DANIEL'S HOME FOR HIM AND OR HIS VEHICLE. I LATER RECEIVED INFORMATION FROM BUCKEYE PD DISPATCH THAT TEMPE PD WENT OUT TO THE HOME BUT WERE UNABLE TO MAKE CONTACT WITH ANYONE THERE. ADDITIONALLY, THEY WERE UNABLE TO LOCATE DANIEL'S VEHICLE. DISPATCH REPORTED THE TEMPE OFFICER ADVISED THEY COULD SEE ABOUT 80 PERCENT OF THE INTERIOR OF DANIEL'S HOME VIA A WINDOW BUT THAT THEY COULDN'T SEE ANY SIGNS OF ANYONE BEING HOME.

TEMPE PD ULTIMATELY HAD NO OTHER INFORMATION TO PROVIDE.

CONTACT WITH LUKE JOSEPH [REDACTED]

AT THE LATER END OF MY SHIFT, I RECEIVED CONTACT FROM DAVISHA BY PHONE. DAVISHA SAID SHE WAS ABLE TO OBTAIN INFORMATION FROM A FORMER COLLEGE ROOMMATE OF DANIEL'S NAMED "MARCUS" THAT ONE OF DANIEL'S FRIEND'S NAMED "LUKE [REDACTED]" HAD RECENTLY FLOWN INTO AZ TO SEE DANIEL. DAVISHA SAID SHE OBTAINED A PHONE NUMBER FOR "LUKE" WHICH SHE PROVIDED TO ME. I ASKED DAVISHA IF MARCUS HAD ANY FURTHER INFORMATION REGARDING DANIEL'S WHEREABOUTS OR IF HE HAD HEARD FROM DANIEL. DAVISHA SAID MARCUS DID NOT KNOW WHERE DANIEL WAS AT AND HAD NOT HEARD FROM HIM. DAVISHA ULTIMATELY HAD NO FURTHER INFORMATION TO REPORT SO WE ENDED OUR CONVERSATION.

AFTER OBTAINING THIS INFORMATION FROM DAVISHA, I CALLED "LUKE" BY PHONE. "LUKE" ANSWERED THE CALL AND FULLY IDENTIFIED HIMSELF AS LUKE JOSEPH GRIECO DOB 10/03/1996. I INFORMED LUKE OF WHO I WAS AND THAT I WAS CALLING HIM IN REFERENCE TO DANIEL BEING A MISSING PERSON. WHEN I INFORMED LUKE OF THIS HE SAID HE WAS NOT AWARE THAT DANIEL WENT MISSING. I ASKED LUKE IF HE WAS WITH DANIEL OR IF HE KNEW WHERE DANIEL WAS AT. LUKE SAID HE WAS NOT WITH DANIEL AND THAT HE DIDN'T KNOW WHERE HE WAS AT. LUKE EXPLAINED THAT HE HAD FLEW INTO ARIZONA TO VISIT DANIEL OVER THE PAST WEEKEND AND HE STAYED WITH DANIEL AT HIS HOME. LUKE SAID ON 06/20/2021, HE (LUKE) FLEW BACK TO NEW YORK WHERE HE (LUKE) LIVES. I ASKED LUKE WHEN WAS THE LAST TIME HE HAD HEARD FROM DANIEL. LUKE SAID ON 06/22/2021, AROUND EVENING TIME, HE SENT DANIEL A MESSAGE ON INSTAGRAM AND DANIEL LIKED HIS MESSAGE.

I TALKED TO LUKE ABOUT THE ALLEGATIONS OF DANIEL REPORTEDLY ACTING ODD OR TALKING IN AN ABNORMAL WAY. I ASKED LUKE IF HE OBSERVED DANIEL DO OR SAY ANYTHING THAT WAS ABNORMAL TO HIM (LUKE). LUKE SAID HE DIDN'T OBSERVE ANY ODD ACTIONS OR STATEMENTS FROM DANIEL.

I ASKED LUKE IF DANIEL HAS EVER MADE ANY DIRECT OR VAGUE STATEMENTS OR IF DANIEL MADE ANY ACTIONS THAT SUGGESTED HE (DANIEL) WAS GOING TO OR WANTED TO HURT OR KILL HIMSELF. LUKE SAID HE HAS NEVER HEARD DANIEL SAY OR DO ANYTHING BEFORE LIKE THAT. HOWEVER, LUKE SAID HE DOES RECALL DANIEL TELLING HIM (LUKE) THAT HE WAS GLAD HE WAS IN TOWN TO VISIT BECAUSE HE (DANIEL) "HAD BEEN FEELING DEPRESSED LATELY." LUKE SAID DANIEL SAID THIS TO HIM WHILE THEY WERE AT A BAR. LUKE ADVISED DANIEL HOWEVER DIDN'T TELL HIM WHAT HE WAS DEPRESSED ABOUT OR SAY

ANYTHING ELSE REGARDING THAT. LUKE ULTIMATELY COULDN'T PROVIDE ANY OTHER INFORMATION SUGGESTING DANIEL WAS SUICIDAL AND OR WAS ACTING ODD.

BEFORE ENDING MY CONTACT WITH LUKE, I INFORMED HIM HE NEEDS TO REPORT TO POLICE ANY INFORMATION HE OBTAINS REGARDING DANIEL'S WHEREABOUTS OR IF DANIEL CONTACTS HIM. LUKE SAID HE WOULD.

ATTEMPT TO LOCATE DANIEL THROUGH HIS PHONE/VEHICLE AND THROUGH TLO OFFICER:

DURING MY FOLLOW-UP ON 06/23/2021, I OBTAINED INFORMATION FROM DAVID THAT DANIEL POSSIBLY HAS EITHER THE "ON-STAR" SYSTEM OR THE "UCONNECT" SYSTEM IN HIS VEHICLE WHICH COULD POSSIBLY ALLOW FOR DANIEL'S VEHICLE TO BE LOCATED.

UPON OBTAINING THIS INFORMATION, I CONTACTED THE "ON-STAR" SYSTEM CUSTOMER SERVICE PHONE NUMBER. I WAS ABLE TO SPEAK TO ONE OF THE "ON-STAR" SYSTEM EMPLOYEE'S WHO ADVISED THAT DANIEL'S VEHICLE, A 2017 JEEP RENEGADE, WOULD NOT HAVE THIS SYSTEM IN IT BECAUSE THE SAID COMPANY DOES NOT PUT THAT SYSTEM IN 2017 JEEP RENEGADES.

AFTER OBTAINING THAT INFORMATION I CALLED THE CUSTOMER SERVICE NUMBER FOR THE "UCONNECT" SYSTEM AND WAS ABLE TO SPEAK TO AN EMPLOYEE FOR THE COMPANY. THE EMPLOYEE FOR THE "UCONNECT" SYSTEM WAS PROVIDED INFORMATION TO SITUATION AND INFORMATION TO DANIEL'S VEHICLE. THE "UCONNECT" SYSTEM EMPLOYEE ADVISED IT DID APPEAR THAT THIS VEHICLE WAS IN THEIR DATABASE BUT THAT DANIEL HAD NEVER CREATED AN ACCOUNT UNDER THE "UCONNECT" SYSTEM. THE "UCONNECT" SYSTEM EMPLOYEE WAS ASKED THAT IF I WERE TO CREATE AN ACCOUNT FOR THE VEHICLE, COULD IT'S LOCATION BE TRACKED. THE "UCONNECT" SYSTEM EMPLOYEE SAID IT COULD, UNLESS THERE WAS OTHER CIRCUMSTANCES THAT HAD OCCURRED, SUCH AS THE VEHICLE NOT HAVING ANY ELECTRICITY FROM THE BATTERY OR IF SOMEONE HAS TAMPERED WITH THE VEHICLE. I ADVISED MY IMMEDIATE SUPERVISOR OF THIS INFORMATION AND WITH HIS APPROVAL, SIGNED UP FOR THE "UCONNECT" SYSTEM ACCOUNT SO DANIEL OR HIS VEHICLE COULD BE LOCATED.

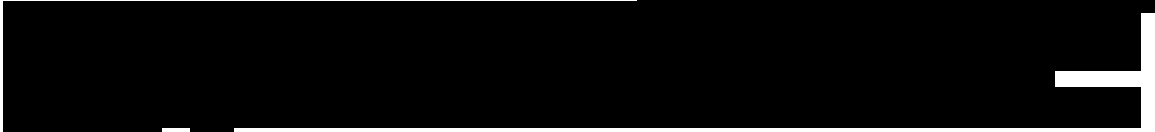

NO FURTHER INFORMATION WAS REPORTED TO ME IN THE EMAIL SHOWING THE VEHICLE'S LOCATION. THIS EMAIL WAS SCREEN SHOT AND UPLOADED INTO EVIDENCE.COM.

AS WELL AS ATTEMPTING TO LOCATE DANIEL AND HIS VEHICLE, BUCKEYE PD DISPATCH CONTACTED DANIEL'S CELL PHONE PROVIDER TO ATTEMPT TO LOCATE HIM THROUGH HIS CELL PHONE. DISPATCH WOULD LATER REPORT TO ME AT THE END OF MY SHIFT OF 06/24/2021,

SEVERAL ATTEMPTS TO LOCATE DANIEL THROUGH HIS CELL PHONE WAS MADE BUT TO NO AVAIL. DISPATCH ADVISED NO INFORMATION TO DANIEL'S LOCATION WAS KNOWN AND NO INFORMATION TO HIS LAST KNOWN LOCATION WAS KNOWN.

CHECKING AREA FOR DANIEL:

ON 06/24/2021, I CHECKED THE AREA OF N 315TH AVE, A FEW MILES NORTH OF W HIGHLAND DR. THIS AREA IS A FEW MILES SOUTH OF THE JOB SITE. IN THAT AREA, I CHECKED FOR DANIEL, HIS VEHICLE OR ANY SIGNS OF BOTH. I WAS ULTIMATELY UNABLE TO LOCATE ANYTHING.

ACTIONS TAKEN BEFORE END OF SHIFT 06/24/2021

BEFORE ENDING MY SHIFT ON 06/24/2021, DAVID, DAVISHA AND KEVIN WERE CONTACTED BY PHONE AND GIVEN THE OUTCOME OF THE EFFORTS MADE IN MY INVESTIGATION TO DANIEL BEING MISSING. THEY WERE ALL INFORMED TO CALL POLICE IF DANIEL'S WHEREABOUTS WERE KNOWN OR IF DANIEL CONTACTED ANYONE OF THEM. IT SHOULD BE NOTED THAT DAVID, DAVISHA AND KEVIN WERE ADVISED THAT A HELICOPTER WAS REQUESTED THROUGH MY IMMEDIATE SUPERVISOR TO ATTEMPT TO CHECK THE AREA FOR DANIEL BUT WAS DECLINED. THEY WERE INFORMED THAT I WOULD LOOK INTO THE MATTER ON 06/25/2021 UPON MY RETURN TO WORK. ADDITIONALLY, I TOLD THEM THAT THE OFFICER WHICH COMES ON SHIFT, PRIOR TO ME GOING OFF SHIFT, WILL BE BRIEFED ABOUT EVERYTHING THAT WAS GOING ON.

AFTER SPEAKING TO THE SAID PARTIES, I CONTACTED THE ON-COMING SHIFT OFFICER, BUCKEYE PD OFFICER ASHTON. I INFORMED HER OF ALL PERTINENT INFORMATION FOR THIS CASE.

FOLLOW UP TAKEN ON 06/25/2021

ON 06/25/2021, UPON THE START OF MY SHIFT, I WAS INFORMED BY SGT. FLETCHER, MY IMMEDIATE SUPERVISOR, THAT DANIEL WAS STILL REPORTEDLY MISSING AS HE HAD BEEN BRIEFED BY THE BUCKEYE PD SUPERVISOR WHICH WORKS THE GRAVEYARD SHIFT. I ASKED SGT. FLETCHER FOR DIRECTION ON WHAT FURTHER ACTIONS NEEDED TO BE DONE DUE TO DANIEL STILL MISSING. SGT. FLETCHER ADVISED TO DOCUMENT ALL INFORMATION THAT I HAD OBTAINED IN MY INVESTIGATION AND TO DOCUMENT MY ACTIONS UP TO THAT TIME. HE ADVISED THE CASE WOULD BE FORWARDED TO BUCKEYE PD DETECTIVES FOR FOLLOW UP.

HELICOPTER SEARCH AND RE-CHECK OF JOB SITE AREA BY BUCKEYE PD:

LATER IN MY SHIFT ON 06/25/2021, I RECEIVED WORD FROM SGT. FLETCHER THAT DANIEL'S AUNT HAD CALLED BUCKEYE PD TO TALK TO A SUPERVISOR ABOUT HER CONCERNS

REGARDING DANIEL BEING MISSING. SGT. FLETCHER ADVISED HE CONTACTED DANIEL'S AUNT AND UPON SPEAKING TO HER ABOUT THE SITUATION, THE DECISION TO REQUEST FOR A HELICOPTER WILL BE MADE. A SHORT TIME AFTER OBTAINING THIS INFORMATION, I RECEIVED WORD FROM SGT. FLETCHER THAT PHOENIX FIREBIRD HELICOPTER WOULD BE HEADING TO THE JOB SITE LOCATION TO CHECK THE SURROUNDING AREA FOR DANIEL AND DANIEL'S VEHICLE. WHILE THE HELICOPTER CHECKED THE AREA, BUCKEYE PD OFFICER BROWN AND BUCKEYE PD SERGEANT C. HALE CHECKED THE DESERT AREA AS WELL. ULTIMATELY DANIEL AND HIS VEHICLE WERE NOT LOCATED.

ULTIMATELY [REDACTED] NUMEROUS ATTEMPTS TO GET THIS TO WORK, DANIEL'S VEHICLE LOCATION WAS UNABLE TO BE LOCATED THROUGH THE "[REDACTED] SYSTEM. I WAS INFORMED BY THE "[REDACTED] SYSTEM EMPLOYEE THAT THE RE [REDACTED] VEHICLE LOCATION WAS NOT ABLE TO [REDACTED] WAS EITHER FROM SOMEONE TAMPERING WITH THE SYSTEM, THE "[REDACTED] SYSTEM APPLICATION NOT BEING PROPERLY UPDATED IN DANIEL'S VEHICLE OR T [REDACTED] L'S VEHICLE BATTERY HAD NO CHARGE WHICH MEANS HIS VEHICLE BATTERY WAS DEAD. THE "[REDACTED] SYSTEM EMPLOYEE SPECIFIED THAT DANIEL'S VEHICLE COULD BE TRACKED EVEN IF HIS ENGINE WAS OFF.

RE-CONTACTED BY KEVIN AT END OF SHIFT ON 06/25/2021:

KEVIN CALLED ME DURING MY SHIFT ON 06/25/2021, BUT I WAS NOT ABLE TO ANSWER HIS CALL UNTIL LATER AT THE END OF SHIFT. WHEN I CALLED KEVIN BACK, HE ANSWERED AND HE ASKED ME FOR AN UPDATE ON THE CASE. I INFORMED HIM OF THE CURRENT SITUATION AND ASKED HIM IF HE HAD ANY NEW INFORMATION TO REPORT. KEVIN SAID HE DID NOT. I INFORMED KEVIN THAT DUE TO DANIEL BEING AT WORK AT THE TIME OF HIM MISSING, I WOULD BELIEVE SOMEONE IN LAW ENFORCEMENT WOULD CONTACT EITHER HIM OR SOMEONE IN DANIEL'S EMPLOYER TO REPORT ANY NEW INFORMATION REGARDING CONTACT WITH DANIEL OR HIS CONDITION. KEVIN SAID HE UNDERSTOOD AND WAS SATISFIED WITH THE ACTIONS TAKEN THUS FAR BY POLICE. BEFORE ENDING MY CONTACT WITH KEVIN, HE AGAIN ADVISED HE WOULD REPORT TO POLICE ANY NEW INFORMATION THAT HE RECEIVES REGARDING DANIEL.

CONCLUSION:

AS OF 06/26/2021, AT 1111 HOURS, DANIEL IS MISSING AND HIS WHEREABOUTS ARE NOT KNOWN. THIS CONCLUDES THIS REPORT AT THIS TIME. A SUPPLEMENTAL REPORT WILL BE COMPLETED UPON ANY NEW INFORMATION THAT I RECEIVE REGARDING THIS CASE.

IT SHOULD BE NOTED THAT MY AXON 3 BODY CAMERA WAS RECORDING DURING CONTACTS WITH PARTIES IN THIS CASE. ALL BODY CAMERA FOOTAGE FROM MY BODY CAMERA WAS UPLOADED INTO EVIDENCE.COM.

INITIAL CASE REVIEW:

ON Saturday, 06/26/2021 THIS CASE WAS ASSIGNED TO ME FOR FOLLOW UP INVESTIGATION. I REVIEWED THE REPORT THUS FAR AND LEARNED THAT ON 06/23/2021 DANIEL [REDACTED] ARRIVED TO A JOB SITE OFF SUN VALLEY PARKWAY WHERE HE MET WITH CO WORKER KENNETH. KENNETH TOLD OFFICERS THAT DANIEL WAS ACTING STRANGE AND LEFT THE SITE WITHOUT SAYING ANYTHING. HE WAS CONCERNED BECAUSE HE BELIEVES THAT DANIEL TURNED DOWN THE ROAD THAT LED FATHER INTO THE DESERT, AND NOT TOWARDS THE MAIN ROAD. DANIEL WAS REPORTED MISSING BY HIS FAMILY IN SOUTH CAROLINA AS THEY HAD NOT HEARD FROM HIM SINCE THAT MORNING. THE INITIAL PATROL LEVEL INVESTIGATION REVEALED THAT DANIEL HAD MADE STATEMENTS TO A GIRL NAMED KATELYN INDICATING SHE MAY NEVER SEE HIM AGAIN AFTER SHE ASKED HIM TO LEAVE HER ALONE. THERE WAS NO INDICATION THAT DANIEL WAS SUICIDAL OR THAT HE HAD ANY PLANS TO LEAVE THE AREA.

OFFICER HALEY CONDUCTED EXTENSIVE AND WELL DOCUMENTED FOLLOW UP AND MADE EFFORTS TO LOCATE DANIEL AND HIS VEHICLE USING THE [REDACTED] FEATURE THAT SOME JEEPS ARE EQUIPPED WITH.

CONTACT WITH KENNETH:

I MADE CONTACT WITH CO WORKER KENNETH. KENNETH HAD PREVIOUSLY BEEN INTERVIEWED BY THE CASE OFFICER. I WANTED TO KNOW IF KENNETH RECALLED WHAT DANIEL WAS WEARING AND HE DID NOT REMEMBER. HE DID RECALL THAT DANIEL WAS WEARING HIS SAFETY VEST WHEN HE ARRIVED AND WHEN HE DROVE OFF. HE ALSO NOTED THAT DANIEL'S SHOES WERE NOT TIED. KENNETH SAID THAT HE HAD NEVER WORKED WITH DANIEL BEFORE. HE SAID THAT WHEN THEY ARRIVED, THEY HAD TO WAIT FOR A STORM CELL TO PASS. KENNETH SAID THAT DURING THAT TIME, DANIEL WAS LOOKING AROUND AND SEEMED OFF. HE STARTED ASKING KENNETH IF HE WANTED TO GO TO PHOENIX TO REST WHICH CONFUSED KENNETH. AFTER ABOUT 15 MINUTES, KENNETH SAID DANIEL GOT IN HIS JEEP AND DROVE OFF WITHOUT SAYING ANYTHING MORE TO HIM. KENNETH ADVISED THAT HE DROVE THE AREA TO SEE WHERE DANIEL WENT AND INFORMED ME THAT SINCE IT HAD RAINED, HE COULD SEE DANIEL'S TIRE TRACK PRETTY CLEARLY AT LEAST FOR A PORTION OF THE ROAD LEADING AWAY FROM THE SITE. HE ADVISED THAT DANIEL'S TRACKS TURNED WEST DOWN THE DIRT ROAD LEADING OUT INTO THE DESERT AREA. KENNETH STATED THAT HE DROVE AROUND FOR A PERIOD OF TIME TRYING TO SEE WHERE DANIEL MIGHT HAVE GONE BUT WAS NOT ABLE TO LOCATE HIM. KENNETH EXPLAINED THAT THIS WAS THE FIRST TIME HE HAD WORKED WITH DANIEL AND EXPRESSED CONCERN THAT HE HAD NOT BEEN HEARD FROM SINCE THAT DAY.

FIRST CONTACT WITH DANIEL'S FATHER DAVID:

I MADE CONTACT WITH DAVID [REDACTED] DANIEL'S FATHER. DAVID ADVISED HE WOULD BE COMING TO ARIZONA TO HELP [REDACTED] DANIEL. DAVID EXPRESSED GENUINE CONCERN AND EXPLAINED THAT IT IS NOT LIKE DANIEL TO TAKE OFF IN A MANNER SUCH AS THIS. DAVID WAS NOT AWARE OF ANY OF HIS FRIENDS IN THE AREA. HE SAID THAT DANIEL HAD MOVED TO ARIZONA RELATIVELY RECENTLY. THE CALL WAS ON SPEAKER PHONE WITH DANIEL'S SISTER AS WELL. I ASKED THEM ABOUT DAVID'S FRIENDS A [REDACTED] HE MAY HAVE GONE. DAVID MENTIONED A FRIEND OF DANIEL'S NAMED ANTONIO [REDACTED] WHO IS A 23-34 YEAR OLD MALE, AND PROVIDED THE PHONE NUMBER [REDACTED]. THIS IS A FRIEND OF DANIEL'S WHO OFFERED HIM AN APARTMENT I [REDACTED] LAST MONTH, DANIEL EXPRESSED INTEREST IN GOING BUT DID NOT HAVE A PLAN THAT ANYONE KNEW OF.

DANIEL'S SISTER SAID THAT IN MAY, DANIEL TOOK A SPONTANEOUS TRIP TO SAN FRANCISCO WITHOUT TELLING ANYONE. WHILE ON HIS WAY HE CONTACTED HIS OTHER SISTER IN FREMONT FOR A PLACE TO STAY FOR THE NIGHT. THIS CURRENT SITUATION IS DIFFERENT BECAUSE HE HAS NOT BEEN IN CONTACT WITH ANYONE FOR SEVERAL DAYS.

DAVID ADVISED THERE ARE NO KNOWN MEDICAL ISSUES OR MENTAL HEALTH ISSUES ALTHOUGH IT APPEARS DANIEL'S BEHAVIOR IN THE WEEK OR TWO PRIOR TO THIS INCIDENT HAS BEEN UNUSUAL.

I WAS ALSO ADVISED THAT DANIEL'S INSTAGRAM ACCOUNT [REDACTED] APPEARS TO HAVE HAD ALL OF THE POSTS DELETED BUT HIS FAMILY SAYS THAT [REDACTED] A DAY OR TWO BEFORE HE WENT MISSING. [REDACTED]

DAVID SAID THAT DANIEL USES [REDACTED] FOR HIS BANKING AND HAS A [REDACTED] CREDIT CARD WHICH HE JUST GOT. ACCOUNT NUMBERS ARE UNKNOWN BUT HE IS PRETTY SURE THESE ARE THE ONLY ACCOUNTS DANIEL HAS.

DAVID LATER ADVISED THAT DANIEL ALSO HAS A [REDACTED] ACCOUNT BUT THEY DO NOT HAVE ACCESS.

I ADVISED DAVID TO CONTACT AN ATTORNEY TO SEE IF THERE WAS A POSSIBILITY HE CAN OBTAIN POWER OF ATTORNEY THROUGH CIVIL COURTS WHICH MAY ALLOW HIM TO OBTAIN PHONE AND BANK RECORDS TO ASSIST IN LOCATING DANIEL.

CONTACT WITH [REDACTED]

I THEN OBTAINED CALL DETAIL RECORDS (CDR'S) AND A CONTINUOUS PING ON DANIEL'S PHONE. UPON REVIEW, I FOUND THAT THE CDR'S WERE ONLY FROM 6/24 AFTER THE PHONE WAS OFF. ALL OF THE INFORMATION I WAS ABLE TO SEE ON THIS INITIAL DISCLOSURE APPEARED TO BE UNANSWERED INCOMING CALLS AND MESSAGES AFTER DANIEL HAD GONE MISSING.

I RE-CONTACTED T MOBILE ON 06/27/2021 AND UPDATED THE EXIGENT FORM, EXPLAINING TO T-MOBILE THAT I BELIEVED DANIEL WAS POSSIBLY IN DANGER. T MOBILE AGREED TO PROVIDE CALL DETAIL RECORDS DATING BACK TO 06/22/2021 BUT ADVISED THAT ANY ADDITIONAL DATA WOULD REQUIRE A SEARCH WARRANT.

CONTACT WITH FRIEND ANTONIO:

ON 06/27/21 I MADE CONTACT WITH ANTONIO. ANTONIO TALKED TO DANIEL ON THE PHONE FOR 17 MINUTES ON 06/16. DANIEL SEEMED MORE HYPER THAN USUAL AND WAS TALKING

ABOUT TWO GIRLS HE MET WHILE DELIVERING ALCOHOL FOR [REDACTED] DANIEL TOLD HIM HE HOOKED UP WITH ONE OF THE GIRLS. DANIEL DIDN'T HAVE FRIENDS HERE YET AND WAS VERY SOCIAL AND COULD BE GULLIBLE. HE TOLD ME ABOUT A POST THAT DANIEL MADE ON FB ON 06/20 WITH A SUN EMOJI AND THE WORDS "IN 4". THE PICTURE WAS WITH LUKE WHO HAD BEEN VISITING DANIEL UNTIL 06/20/2021.

ANTONIO LATE [REDACTED] ED THAT DANIEL HAD TALKED TO ANOTHER FRIEND NAMED RUBEN [REDACTED] WHO LIVED IN FLORIDA. HIS NUMBER IS [REDACTED]

CONTACT WITH FRIEND LUKE:

I CALLED AND SPOKE WITH LUKE WHOM OFFICERS HAD ALREADY CONTACTED PREVIOUSLY. LUKE WAS VISITING DANIEL UP UNTIL 06/20/2021. LUKE WAS VISITING BECAUSE HE IS THINKING ABOUT MOVING OUT TO PHOENIX. THE POST ON FACEBOOK WAS AT THE BAR AND HAD HIM IN IT AND HE WAS REFERRING TO SUNS IN 4, RELATED TO THE PHOENIX SUNS BASKETBALL PLAYOFFS AND HE WAS NOT AWARE OF DANIEL PLANNING TO LEAVE ANYWHERE. LUKE DID NOT MENTION ANY BEHAVIOR THAT SEEMED UNUSUAL.

CONTACT WITH FRIEND RUBEN:

I CALLED RUBEN AND HE ADVISED HE SPOKE WITH DANIEL ON 06/22/2021 AT ABOUT 1525 FLORIDA TIME AND THEY SPOKE FOR ABOUT 5 MINUTES. HE SAID HE WAS ASKING DANIEL ABOUT VACATION SPOTS IN ARIZONA AND CALIFORNIA BUT DANIEL SEEMED DOWN AND LIKE SOMETHING WAS ON HIS MIND. RUBEN SAID THE CONVERSATION WAS SHORT AND HE DID NOT KNOW WHAT WAS WRONG. DANIEL DID NOT MAKE ANY STATEMENTS ABOUT HURTING HIMSELF BUT RUBEN SAID THAT DANIEL JUST SEEMED "OFF".

RUBEN SAID DANIEL DOES LIKE TO HIKE AND EXPLORE AND IT IS NOT UNUSUAL FOR HIM TO TAKE OFF AND EXPLORE BUT IT IS UNUSUAL FOR HIM TO NOT STAY IN CONTACT AND EVERYONE IS CONCERNED FOR HIM. RUBEN DID NOT HAVE ANY ADDITIONAL INFORMATION TO ADD.

UPDATED T-MOBILE DATA:

ON 06/27/2021 I RECEIVED UPDATED RECORDS FROM T-MOBILE. THE RECORDS ONLY SHOW 5 OUTGOING TEXT MESSAGES BEFORE DANIEL WENT MISSING. THE RECORDS ONLY SHOW THAT A MESSAGE WAS SENT, BUT DO NOT REVEAL THE CONTENT OF THE MESSAGE OR CALL.

THE LAST TEXT WAS AT 0810 ON 06/23 TO CO WORKER KENNETH WHO WAS THE LAST PERSON TO SEE DANIEL.

A TEXT TO KATELYN ON 06/22/2021 AT 1507 WAS NOTED BY OFFICER HALEY AND CONFIRMED TIME 1507 ON CDR'S.

OFFICER HALEY'S REPORT QUOTED THE LAST TEXT DANIEL SENT TO KATELYN ON 06/22/2021.

"DANIEL: The world can get better, but I'll have to take all the time I /can or we can, whatever to name it. I'll either see you again or never see you again."

THERE WERE TWO TEXT MESSAGES OUTGOING TO STEPHEN [REDACTED] (COMPANY BOSS) ON

CONTACT WITH APARTMENT MANAGER:

ON 07/06/2021 DETECTIVE FAVELA AND I MADE CONTACT WITH TIFFANY WHO IS THE MANAGER AT DANIEL'S APARTMENT COMPLEX. I FILLED HER IN ON SOME BASIC INFORMATION ABOUT DANIEL'S DISAPPEARANCE. TIFFANY STATED THAT DANIEL'S FAMILY HAD BEEN THERE BUT SHE WAS NOT ABLE TO PROVIDE ENTRY TO HIS APARTMENT TO THEM. SHE SAID THAT BUCKEYE POLICE DEPARTMENT HAD SENT TEMPE POLICE OFFICERS OUT TO CHECK HIS APARTMENT WHEN DANIEL WENT MISSING BUT THEY DID NOT MAKE ENTRY, ONLY KNOCKED ON THE DOOR AND RECEIVED NO ANSWER. SHE ADVISED THAT DANIEL'S EMPLOYER PAID HIS RENT THIS MONTH. TIFFANY ALLOWED US TO ENTER THE APARTMENT TO PERFORM A WELFARE CHECK. DANIEL WAS NOT LOCATED IN THE APARTMENT. THE COMMON AREAS OF THE APARTMENT APPEARED TO BE WELL KEPT AND CLEAN, AND NO VALUABLES APPEARED TO BE MISSING. THERE WAS NO INDICATION OF FOUL PLAY AND NO INDICATION THAT DANIEL HAD PACKED AND PLANNED A TRIP. DANIEL DID NOT APPEAR TO TAKE HIS COMPUTERS OR VALUABLE ITEMS. DANIEL'S BEDROOM WAS MESSY WITH CLOTHES AND MISCELLANEOUS ITEMS ON THE FLOOR. I ALSO OBSERVED WHAT APPEARED TO BE MARIJUANA BLUNTS LEFT ON COUNTERS AND IN VARIOUS PLACES IN THE APARTMENT. DETECTIVES EXITED THE APARTMENT AND TIFFANY SECURED THE DOORS AND WINDOWS.

DESERT CHECKS:

PREVIOUS TO MY INVOLVEMENT, BUCKEYE POLICE DEPARTMENT COORDINATED AN AERIAL SEARCH BY HELICOPTER WITH NEGATIVE RESULTS. MULTIPLE PATROL OFFICERS ALSO CIRCULATED THE DESERT AREA IN 4X4 VEHICLES LOOKING FOR DANIEL OVER MULTIPLE DAYS.

ON 07/06/2021 MYSELF AND DETECTIVE FAVELA SEARCHED THE AREA BY GROUND VEHICLE FOR SEVERAL HOURS. WE WERE NOT ABLE TO LOCATE DANIEL OR HIS VEHICLE BUT I DID OBSERVE MULTIPLE MOUNTAIN AREAS WHERE DANIEL MAY HAVE WANTED TO EXPLORE. ONCE OFF OF THE SERVICE ROADS OR TRAILS, MUCH OF THE DESERT AREA BECOMES CHALLENGING TO TRAVERSE WITHOUT THE APPROPRIATE OFF ROAD VEHICLE.

ON 07/07/2021 I PLACED SEVERAL FLYERS ALONG THE GATED ENTRANCES TO THE DESERT AREA ALONG SUN VALLEY PARKWAY WHERE DANIEL WAS LAST SEEN IN HOPES THAT WORKERS, LAND OWNERS AND THOSE ENTERING THE AREA FOR OTHER PURPOSES MAY BE AWARE OF DANIEL AND HIS VEHICLE.

I THEN WENT TO BUCKEYE AIRPORT AND PLACED FLYERS WITH MAPS OF DANIEL'S LAST KNOWN LOCATION IN THE PILOTS LOUNGE SO THAT THOSE FLYING IN THE AREA CAN BE ON THE LOOKOUT AS WELL. WHILE THERE, I CONTACTED MICHAEL [REDACTED] OF BUCKEYE A&P SERVICES ALONG WITH A FEW OTHER PILOTS IN HIS PRESENCE [REDACTED] ISED THEM OF THE SEARCH EFFORTS AND SHOWED THEM THE FLYER AND MAPS. I ALSO E-MAILED MICHAEL A COPY OF THE FLYER AND MAP TO CIRCULATE TO OTHER PILOTS IN THE AREA.

CIVIL AIR PATROL SEARCH AND RESCUE EFFORTS:

ON 07/07/2021 I REACHED OUT TO THE CIVIL AIR PATROL COMMANDER FOR THE UNIT BASED OUT OF GLENDALE AIRPORT. I WAS AWARE THAT CAP MAY ASSIST WITH SEARCH AND RESCUE EFFORTS. MY E-MAIL WAS FORWARDED TO MAJOR DALLAS LANE OF THE US AIR FORCE AUXILIARY/CAP. MAJOR LANE IS THE ARIZONA WING SEARCH AND RESCUE OFFICER.

I WAS ABLE TO SPEAK WITH MAJOR LANE ON THE PHONE AND HE ADVISED THAT HE WAS GETTING THINGS WORKING WITH THE AIR FORCE AND THEY WOULD ASSIST US IN THE SEARCH FOR DANIEL. MAJOR LANE ADVISED THAT SINCE DANIEL HAD A VEHICLE AND A LAST KNOWN LOCATION, THERE WAS A GOOD POSSIBILITY THAT THEY WOULD BE ABLE TO LOCATE DANIEL IF HE WAS IN THE AREA.

MAJOR LANE ADVISED THAT THEY WOULD USE THEIR TRAINED CAP VOLUNTEERS ON THE GROUND AND IN THE AIR FOR THE SEARCH AND WOULD REQUIRE A BUCKEYE POLICE DEPARTMENT REPRESENTATIVE TO ACCOMPANY THEM. MAJOR LANE SAID THAT HE WOULD WORK ON GETTING A MISSION PLANNED BUT IT MAY TAKE A DAY OR TWO TO PREPARE.

ON 07/09/2021 AT 0545 HOURS I MET WITH DANIEL'S FATHER DAVID OUT AT SUN VALLEY PARKWAY AND CACTUS RD. THE SEARCH AND RESCUE GROUP FROM CIVIL AIR PATROL WAS EN-ROUTE AND THEIR FIRST AIRCRAFT WAS SET TO LEAVE DEER VALLEY AIRPORT AT 0600 HOURS. I ADVISED DAVID THAT HE WOULD NOT BE ABLE TO ACCOMPANY US FOR THIS SEARCH PER CIVIL AIR PATROL'S PROCEDURES. I ALSO INFORMED HIM THAT IN THE UNFORTUNATE EVENT THAT THIS TURNED INTO A CRIMINAL INVESTIGATION, I NEEDED TO MAINTAIN THE INTEGRITY OF THE SEARCH. DAVID UNDERSTOOD AND STAYED NEAR THE ROADWAY DURING A PORTION OF THE SEARCH OPERATION.

THE SEARCH OPERATION RAN FROM 0600 HOURS UNTIL ABOUT 1200 HOURS. TWO AIRCRAFT COMPLETED 4 SEARCHES. A MAP OF THE AREA SEARCHED HAS BEEN ATTACHED TO THIS CASE [REDACTED]

MAJOR LANE MET WITH HIS CREW LATER THAT EVENING TO REVIEW THE DATA AND DECIDED TO SEND ANOTHER PLANE OUT ON 07/10/2021 TO FOLLOW UP ON SOME AREAS THEY WANTED

TO SEARCH FURTHER. MAJOR LANE ADVISED THAT THE AIRCRAFT FLEW FOR A FEW HOURS, DOUBLE CHECKING SEVERAL AREAS BUT WERE NOT ABLE TO LOCATE ANY SIGNS OF DANIEL OR HIS VEHICLE.

IT IS IMPORTANT TO NOTE THAT THE SEARCH BOUNDARIES ARE CLOSELY RELATED TO ROADS OR TRAILS WHERE IF DANIEL HAD REACHED THESE POINTS, HE COULD HAVE GONE IN ANY DIRECTION.

MAJOR LANE ADVISED THAT THEY WOULD GLADLY ASSIST WITH FURTHER SEARCHES IF NEW INFORMATION BECAME AVAILABLE.

FOLLOW UP AT CIRCLE K IN GOODYEAR:

BUCKEYE POLICE DEPARTMENT RECEIVED A CALL FROM A CITIZEN WHO SAW THE MISSING PERSONS FLYER. THE CITIZEN REPORTED THAT SHE BELIEVED DANIEL WAS WORKING AT THE CIRCLE K LOCATED AT THE SOUTHWEST CORNER OF PEBBLE CREEK PARKWAY AND W MCDOWELL RD. ON 07/06/2021 I MADE CONTACT WITH A CLERK WHO ADVISED THEY HAD A MALE SUBJECT NAMED "MALACHAI" WHO WAS SIMILAR TO DANIEL THAT WAS WORKING THERE. SHE SAID MALACHAI HAD BEEN THERE A COUPLE MONTHS BUT DIDN'T HAVE A VEHICLE AND DIDN'T HAVE HIS PHONE NUMBER OR ANY OTHER IDENTIFIABLE INFORMATION. SHE ADVISED HE WAS MISSING AN ARM AND HE LOOKED SIMILAR TO DANIEL. SHE ALSO ADVISED THAT MALACHAI WOULD BE AT WORK AFTER 10AM ON 07/07/2021.

ON 07/07/2021 AT ABOUT 1130 HOURS I CONDUCTED FOLLOW UP AT THE CIRCLE K. I OBSERVED MALACHAI WORKING. MALACHAI DID NOT RESEMBLE DANIEL IN THE FACE AND HE WAS MISSING THE OPPOSITE ARM. I VISUALLY CONFIRMED THIS WAS NOT DANIEL. I ALSO DID NOT SEE DANIEL'S VEHICLE IN THE PARKING LOT.

FOLLOW UP AT VALLEY WISE BEHAVIORAL HEALTH:

ON 07/09/2021 WHILE I WAS OUT ON THE SEARCH OPERATION, DISPATCH RECEIVED A CALL FROM AN ANONYMOUS CITIZEN WHO ADVISED THAT SHE MIGHT HAVE SEEN DANIEL BEING BROUGHT IN TO VALLEY WISE BEHAVIORAL HEALTH, [REDACTED]

I MADE PHONE CALLS TO THE FACILITY BUT DUE TO PRIVACY LAWS, WAS NOT ABLE TO GET ANY INFORMATION OVER THE PHONE. PHOENIX POLICE DEPARTMENT DISPATCHED A PATROL OFFICER TO THE FACILITY WHO ADVISED THAT DANIEL HAD NOT BEEN A PATIENT THERE.

DETECTIVE FAVELA CONTACTED PHOENIX POLICE OFFICER TERRY LAAKER WHO IS A COMMUNITY ACTION OFFICER IN THE AREA. OFFICER LAAKER CONDUCTED EXTENSIVE FOLLOW UP WITH THE FACILITY AND CONFIRMED WITH ABSOLUTE CERTAINTY THAT THE SUBJECT WAS NOT DANIEL, AND DANIEL HAD NOT BEEN AT THE FACILITY UNDER HIS NAME OR ANY OTHER NAME.

I THEN CONTACTED CIT OFFICER COSGROVE AND REQUESTED HE ASSIST WITH CHECKING ALL OF THE LOCAL MENTAL HEALTH FACILITIES AGAIN. OFFICER COSGROVE WORKED WITH HIS CONTACTS AND DETERMINED THAT DANIEL WAS NOT LISTED AS A PATIENT AT ANY OF THE LOCAL MENTAL HEALTH FACILITIES.

FOLLOW UP WITH [REDACTED]

ON 07/11/2021 I RE-CONTACTED [REDACTED] BY E-MAIL. I EXPRESSED TO THEM THAT DANIEL WAS STILL [REDACTED] NOT A CRIMINAL INVESTIGATION, I WOULD NOT LIKELY BE ABLE TO OBTAIN WARRANTS. I EXPRESSED CONCERN FOR DANIEL'S ABILITY TO SURVIVE IN THE DESERT AT THIS POINT. I ALSO ADVISED [REDACTED] THAT DANIEL'S SISTER WAS THE ACCOUNT HOLDER AND SHE WOULD GIVE CONSENT TO OBTAIN ANY HISTORICAL LOCATION DATA RELATED TO DANIEL GOING MISSING. I RECEIVED A PHONE CALL FROM [REDACTED] SECURITY TEAM ABOUT AN HOUR LATER. THE REP ADVISED THAT HE GOT APPROVAL TO RUN SEARCHES DATING BACK TO 06/21/2021. HE ADVISED THAT THERE WAS NO LOCATION DATA. HE EXPLAINED THAT THINGS LIKE CONNECTING TO WIFI COULD HAVE CAUSED HIM NOT TO USE CELL TOWERS IF CALLS WERE MADE AND HE FURTHER ADVISED THAT TEXT MESSAGES WOULDN'T ALWAYS SHOW LOCATION DATA BASED ON THE WAY DATA IS Routed THROUGH THEIR NETWORK. HE ALSO ADVISED THEY WANTED TO CHECK TO SEE IF DANIEL'S PHONE SHOWED UP ON ANY TEST SIGNALS SENT OUT BY [REDACTED] AFTER HIS DISAPPEARANCE AND IT DID NOT.

AT THIS POINT, [REDACTED] HAS NOT BEEN ABLE TO PROVIDE ANY LOCATION DATA FOR DANIEL'S PHONE RELATED TO 06/23/2021.

SINCE DANIEL'S CASE HAS RECEIVED NATIONAL MEDIA ATTENTION AND SEVERAL PEOPLE HAVE EXPRESSED INTEREST IN ASSISTING WITH SEARCH EFFORTS, I DECIDED TO RELEASE TO THE PUBLIC INFORMATION ABOUT WHERE WE HAVE SEARCHED. I CONTACTED SGT Z. ASTRUP WHO HANDLES PIO RELEASES AND PROVIDED HIM WITH DETAILS ABOUT WHAT OUR AGENCY HAS DONE AND PROVIDED HIM WITH THE SEARCH MAPS TO BE RELEASED AS WELL. ALL OF THE INFORMATION WAS RELEASED TO THE MEDIA AND ON THE POLICE DEPARTMENT'S SOCIAL MEDIA PAGES TO RAISE PUBLIC AWARENESS IN HOPES THAT DANIEL WOULD BE LOCATED.

 BANK INFORMATION:

ON 07/15/2021 I SPOKE WITH DAVID [REDACTED] BY PHONE. HE ADVISED THAT DANIEL'S BROTHER WAS ABLE TO ACCESS DANIEL'S [REDACTED] ACCOUNT AND NOTED A PURCHASE ON 06/23/2021 AT A SHELL SERVICE STATION IN BUCKEYE. DAVID SENT ME A SCREEN SHOT BUT IT DID NOT PROVIDE TIME AND SPECIFIC LOCATION INFORMATION. THERE ARE THREE SHELL STATIONS IN BUCKEYE, ONE OF WHICH IS CLOSE TO THE JOB SITE. I REACHED OUT TO DAVID AGAIN ON 07/16/2021 TO SEE IF HE WAS ABLE TO GET ADDITIONAL DETAILS SO THAT I COULD SEND AN OFFICER TO SECURE VIDEO. HE ADVISED HE WAS WAITING ON HIS OTHER SON TO SEND THE INFORMATION WHICH WOULD BE WITHIN A FEW HOURS.

ON 07/18/2021 I RECEIVED A MESSAGE FROM DAVID WITH SCREEN SHOTS OF DANIEL'S [REDACTED] AND [REDACTED] ACCOUNTS.

FACEBOOK POST:

ON 07/16/2021 IT WAS BROUGHT TO MY ATTENTION THAT A PERSON MADE A POST TO FACEBOOK INDICATING THAT A VEHICLE SIMILAR TO DANIEL'S WAS SEEN NEAR JACKRABBIT AND ELLIOT ROAD IN BUCKEYE. I CHECKED FACEBOOK AND LOCATED THE POST UNDER THE MISSING PERSONS FLYER. THE POSTER WAS LISTED AS 'TIGER [REDACTED] WHOM I DISCOVERED WAS TONY [REDACTED] WITH CONTACT INFORMATION IN BPD'S DATABASE.

I CONTACTED TONY BY TELEPHONE AND HE ADVISED HIS WIFE SAW A VEHICLE PARKED IN THE DESERT NEAR SOME BUSHES OFF OF JACKRABBIT ROAD BEFORE ELLIOT. HE WAS NOT SURE WHICH DIRECTION SHE WAS TRAVELING. TONY FORWARDED TO ME THE PICTURE HIS WIFE TOOK WHICH WAS TOO BLURRY TO PROPERTY IDENTIFY. I DID NOTICE IMMEDIATELY THAT THE WHEELS ON THE VEHICLE IN THE PHOTO WERE GRAY, WHILE THE WHEELS ON DANIEL'S JEEP ARE BLACK. I THEN CONTACTED BUCKEYE DISPATCH AND PROVIDED THE INFORMATION. I REQUESTED THAT A PATROL OFFICER CHECK THE AREA BEFORE IT GOT DARK IF A UNIT IS AVAILABLE OR TO CONTACT MCSO FOR A DEPUTY TO DO AN AREA CHECK. DANIEL'S VEHICLE WAS NOT LOCATED.

DANIEL'S VEHICLE LOCATED:

I ADVISED DISPATCH TO SEND A BEAT OFFICER TO THE AREA TO MEET WITH THE REPORTING PARTY AND STANDBY FOR DETECTIVES.

SGT HANNAMAN AND I THEN COORDINATED ADDITIONAL RESOURCES TO INCLUDE OFF HIGHWAY VEHICLES AND A MOBILE COMMAND TRAILER.

I THEN RESPONDED TO THE AREA AND MET WITH [REDACTED] AND HIS PARTNER SHANNON. WE MET OFF OF SUN VALLEY PARKWAY BETWEEN MILE 113 AND 114 ON THE WEST SIDE OF THE ROAD. WE THEN TOOK THE DIRT ROAD TO THE POWER LINE ROAD WHICH WAS MARKED WITH AN ORANGE FLAG AND HEADED NORTH. FROM THERE WE TRAVELED TO ANOTHER INTERSECTION AND TURNED WEST TOWARDS [REDACTED] CORRAL AREA. HE THEN LED ME DOWN ANOTHER DIRT ROAD TO A MOUNTAIN A [REDACTED] WERE UTILIZED TO GET TO THE TOP. I THEN OBSERVED DANIEL'S 2017 [REDACTED] INE, ON ITS PASSENGER SIDE. THE GPS COORDINATES WERE NOTED [REDACTED]. THE VEHICLE WAS FACING NORTH WEST. THE VEHICLE HAD SIGNIFICANT DAMAGE AND APPEARED TO HAVE HAD A FRONT IMPACT WITH THE DIRT AND ROLLED BEFORE RESTING ON THE PASSENGER SIDE. ONE PIECE OF THE JEEPS BLACK REMOVABLE ROOF WAS ON THE GROUND PARTIALLY WEDGED UNDER THE FRONT OF THE JEEP. I COULD SEE THE [REDACTED] OUTLINE OF WHAT APPEARED TO BE A WALLET IN THE POCKET OF THE JEANS. I WALKED THE [REDACTED]

SAME PATH TO THE VEHICLE WHICH [REDACTED] HAD WALKED AND DID NOT OBSERVE ANY PERSONS INSIDE THE VEHICLE. THE [REDACTED] WAS RELATIVELY CLEAN ON THE OUTSIDE BUT THERE HAD BEEN 3 OR MORE BIG RAINS IN THIS AREA SINCE DANIEL WENT MISSING. THERE WAS EVIDENCE OF RAIN DAMAGE ON THE INSIDE OF THE JEEP AND A HARD HAT INSIDE FILLED WITH RAIN WATER. I LOCATED DANIEL'S SAMSUNG GALAXY S10 CELL PHONE, THE VEHICLE AND APARTMENT KEYS, AND A BACKPACK WITH DANIEL'S WORK LAPTOP AND OTHER DOCUMENTS INSIDE. THERE WERE ALSO OTHER MISCELLANEOUS ITEMS INSIDE THE CAR LIKE CLOTHING, A BASKETBALL, UNOPENED WATER BOTTLES, AND OTHER ITEMS. I DID NOT OBSERVE ANY BLOOD OR OTHER EVIDENCE OF AN INJURY DESPITE THE SUBSTANTIAL DAMAGE TO THE VEHICLE.

I CHECKED THE AREA AND DID NOT OBSERVE ANY INDICATION THAT DANIEL SPENT A CONSIDERABLE AMOUNT OF TIME AT THE VEHICLE. THERE WERE NO EMPTY WATER BOTTLES OR OTHER ITEMS OTHER THAN DANIEL'S CLOTHING IN THE AREA.

THERE WERE NO TRACKS IMMEDIATELY SURROUNDING THE VEHICLE THAT WEREN'T MADE BY THE CALLER OR DETECTIVES.

I CHECKED THE TOP OF THE HILL TO THE EAST OF THE VEHICLE AND LOCATED SOME TRACKS THAT RAN TO THE EAST AND APPEARED TO HAVE BEEN RAINED ON SINCE THEY WERE LEFT AND WERE HARD TO SEE. AFTER SOME FURTHER INVESTIGATION, DETECTIVES BELIEVE THAT DANIEL'S VEHICLE LEFT THE DIRT ROADWAY WHERE IT ENDED SOUTH OF HIS JOB SITE NEAR AN OPEN DIRT AREA AND PROCEEDED UP THE HILL SIDE. IT APPEARED THAT HE DROVE OVER SEVERAL BUSHES BEFORE ENDING UP IN THE RAVINE. THE VEHICLE WAS STILL IN DRIVE WHEN IT WAS FOUND.

THE AREA WAS PHOTOGRAPHED AND PROCESSED BY BPD'S CRIME SCENE MANAGER AND THOSE PHOTOS UPLOADED TO EVIDENCE.COM.

DANIEL'S CELL PHONE WAS DEAD, AND I REMOVED IT AND THE KEYS ALONG WITH HIS BACKPACK FROM THE VEHICLE. I THEN LOCATED HIS WALLET WITH ID'S AND MULTIPLE DEBIT AND CREDIT CARDS INSIDE THE JEANS. THERE WAS NO CASH IN THE WALLET.

DETECTIVES WITH BPD'S MAJOR CRIMES UNIT AND GENERAL INVESTIGATIONS ARRIVED ON SCENE ALONG WITH CHIEF HALL, ASST CHIEF SANDERS, AND MULTIPLE PATROL OFFICERS.

DEPUTY CLANCY WITH MCSO AND HIS PARTNER FROM THE SEARCH AND RESCUE GROUP ARRIVED WITH TRUCKS AND AN OFF ROAD VEHICLES.

CHIEF HALL ARRANGED FOR A RADIO CHANNEL TO LINK THE VARIOUS AGENCIES AND DPS RANGER HELICOPTER WAS DISPATCHED TO CONDUCT A LOW ALTITUDE, THOROUGH SEARCH OF THE AREA. OFFICER PRICE ALSO ARRIVED WITH BPD'S DRONE AND TOOK AERIAL PHOTOS.

BPD AND MCSO PERSONNEL WERE IN THE AREA APPROXIMATELY 18 HOURS AND SEARCHED THE AREA BY FOOT AND OFF ROAD VEHICLE. MCSO POSSE MEMBERS ARRIVED AROUND 2000 HOURS WITH APPROXIMATELY 6-7 CADAVER AND TRACKING DOGS AND SET UP A 4 QUADRANT SEARCH FOR DANIEL. THE DOGS AND THEIR HANDLERS SEARCHED FOR APPROXIMATELY 5 HOURS WITH NO RESULTS.

IT SHOULD BE NOTED THAT DETECTIVES AND OTHER SEARCHERS ENCOUNTERED 1 MOUNTAIN LION IN THE AREA BUT DID NOT FIND ANY EVIDENCE THAT INDICATED DANIEL HAD BEEN ATTACKED OR ENCOUNTERED THE ANIMAL.

PRIOR TO NIGHTFALL, DANIEL'S CLOTHING WAS COLLECTED FROM THE GROUND, AND HIS WALLET, PHONE AND BACKPACK WITH LAPTOP WERE ALSO COLLECTED AND TAKEN TO BUCKEYE POLICE DEPARTMENT FOR SAFEKEEPING.

EZ-TOWING ARRIVED WITH A 4X4 TRUCK TO RECOVER THE VEHICLE. THE VEHICLE WAS THEN

TRANSPORTED TO BUCKEYE POLICE DEPARTMENT PROPERTY AND EVIDENCE IMPOUND UNTIL DANIEL'S FAMILY COULD BE NOTIFIED.

AT MR [REDACTED] REQUEST, I ARRANGED FOR A TARP TO BE PLACED ON THE VEHICLE TO PRESERVE [REDACTED] CONTINUED EXPOSURE TO RAIN AND DIRT.

CONTACT WITH DAVID [REDACTED]

ON 07/20/2021 I CONTACTED DAVID AND ADVISED HIM WE HAD LOCATED DANIEL'S VEHICLE. HE AGREED TO MEET WITH ME AT BUCKEYE POLICE DEPARTMENT LATER THAT DAY FOR A FULL BRIEF.

MR [REDACTED] ARRIVED AND WE DISCUSSED THE CIRCUMSTANCES SURROUNDING DANIEL'S VEHICLE BEING LOCATED AND THE SEARCH EFFORT. DAVID WAS VISIBLY UPSET BY OUR FINDINGS, BUT THANKFUL FOR OUR CONTINUED EFFORTS TO FIND DANIEL. I ADVISED DAVID THAT I WOULD LIKE TO LOOK AT THE CRASH COMPUTER IN DANIEL'S JEEP AND IN DANIEL'S PHONE TO SEE IF EITHER ITEM WOULD YIELD INFORMATION ABOUT WHAT HAPPENED AND WHERE DANIEL MAY HAVE GONE. DAVID AGREED AND WANTED US TO DO WHATEVER WE NEED TO DO.

I EXPLAINED TO DAVID THAT THERE ARE MANY POSSIBILITIES AND WE WILL CONTINUE TO INVESTIGATE AND FOLLOW UP ON ANY LEADS OR NEW INFORMATION. I THEN TOOK DAVID TO SEE DANIEL'S JEEP.

CRASH DATA:

ON 07/21/2021 OFFICER PRICE WAS ABLE TO DOWNLOAD THE CRASH DATA FROM THE VEHICLE'S BLACK BOX. HE ADVISED ME THAT JEEP DID NOT RECORD THE DATE AND TIME OF THE CRASH EVENT BUT SAID THAT THE VEHICLE WAS GOING ABOUT 30 MPH AT THE TIME THE AIRBAGS DEPLOYED.

PRIVATE INVESTIGATOR [REDACTED] ALSO CONDUCTED AN INVESTIGATION INTO THE VEHICLE ONCE THEY TOOK POSSESSION OF IT. I LATER RECEIVED THE "iVE" VEHICLE DOWNLOAD FROM THE JEEPS INFOTAINMENT SYSTEM FROM PI [REDACTED] AND HIS ASSOCIATES.

FURTHER REVIEW OF THE CDR REPORT IS 32 PAGES LONG. THE REPORT INDICATES THAT THE IGNITION CYCLE AT THE TIME OF THE DOWNLOAD WAS 6,850. THE DRIVE SEATBELT WAS BUCKLED AT THE TIME OF THE CRASH. THE IGNITION CYCLE AT THE TIME OF THE CRASH WAS 6,805. THIS INDICATES THAT THE IGNITION WAS CYCLED 44 TIMES AFTER THE CRASH EVENT, INCLUDING THE CYCLE BY OFFICER PRICE FOR THE DOWNLOAD. THE ODOMETER READING AT THE TIME OF THE CRASH EVENT WAS 58,154. THE REPORT INDICATED THE AIRBAG LIGHT WAS NOT ILLUMINATED AT THE TIME OF THE CRASH.

I THEN REVIEWED THE DATA FROM THE iVE REPORT FROM THE INFOTAINMENT SYSTEM WHICH WAS DOWNLOADED BY PI [REDACTED] AND HIS ASSOCIATES. I OBSERVED DATA RELATED TO 06/23/2021. THE TIMES IN THE REPORT ARE IN UTC TIME AND ARE CONVERTED TO ARIZONA TIME IN THIS REPORT.

0626 HOURS ODOMETER IS 58,055
0701 HOURS ODOMETER IS 58,091.99

GOOGLE INDICATES THAT THE DISTANCE FROM DANIEL'S RESIDENCE TO THE SHELL STATION AT 1520 N VERRADO WAY IS APPROXIMATELY 37 MILES WITH A 35-40 MINUTE DRIVE. THE TIME AND DISTANCE BETWEEN THESE ODOMETER READINGS IS CONSISTENT WITH DANIEL'S

DRIVING FROM HOME TO THE SHELL STATION. ADDITIONALLY, DATA RECOVERED FROM THE SHELL STATION INDICATES THAT DANIEL WAS AT THE SHELL STATION BETWEEN 0700 AND 0703 HOURS ON 06/23/2021

0722 HOURS ODOMETER IS 58,093.24

THIS IS A DISTANCE OF APPROXIMATELY 1.25 MILES. A PHOTO IN DANIEL'S CELL PHONE PLACES HIM AT A JOB SITE ON VERRADO WAY SOUTH OF I10 AFTE THE SHELL STATION. THE COORDINATES ATTACHED TO THE IMAGE DATA ARE [REDACTED]). GOOGLE INDICATES THIS IS APPROXIMATELY 1.1 MILES BUT MAY VARY IN EXACT PATH TAKEN. THIS IS CONSISTENT WITH DANIEL LEAVING THE SHELL STATION AND GOING TO THE SITE ON VERRADO WAY WHERE HE TOOK PHOTOS OF WORK LOGS. IT IS UNKNOWN WHAT TIME DANIEL LEFT THE SITE ON VERRADO.

AFTER REVIEWING THE DATA OVER THE COURSE OF SEVERAL DAYS I BEGAN RESEARCHING HIGH LEVEL ACCIDENT RECONSTRUCTION EXPERTS FOR POSSIBLE ASSISTANCE IN REVIEWING THE DATA AND THE SCENE. ON 09/13/2021 I WAS ABLE TO GET IN TOUCH WITH AN [REDACTED] AND SHARED WITH HIM DANIEL'S STORY. I AM CURRENTLY [REDACTED] AND WILL UPDATE THIS REPORT ONCE THAT REVIEW IS COMPLETED.

DANIEL'S CELL PHONE:

ON 07/21/2021 I WAS ABLE TO COMPLETED A FULL FILE SYSTEM EXTRACTION FROM DANIEL'S PHONE. AT THE TIME OF THIS REPORT, THE DATA IS STILL UNDER REVIEW AND THIS PORTION OF THE REPORT WILL BE UPDATED AS THAT IS COMPLETED. MY INITIAL OBSERVATIONS SHOW THAT DANIEL TOOK TWO PHOTOS OF WORK RELATED LOGS AND EQUIPMENT

ON 06/23/2021 AT ABOUT 0710 HOURS. THE META DATA IN THE IMAGES PROVIDED GPS COORDINATES SHOWING THEY WERE TAKEN AT A WELL SITE NEAR VERRADO ROAD, SOUTH OF INTERSTATE 10 IN BUCKEYE. IT IS BELIEVED DANIEL STOPPED AT THIS JOB SITE BEFORE THEN MOVING TO THE SITE OFF OF SUN VALLEY PARKWAY. I LOCATED THE CONVERSATION BETWEEN DANIEL AND KATELYN IN THE TRASH FOLDER AND FOUND IT WAS CONSISTENT WITH THE STATEMENT KATELYN GAVE TO POLICE IN OFFICER HALEY'S SUPPLEMENT. DANIEL HAD BEEN SHOWING UP AT KATELYN'S RESIDENCE UNANNOUNCED AND AFTER DISCUSSING THE ISSUE, KATELYN POLITELY ASKED DANIEL TO LEAVE HER ALONE.

ON 06/22/2021 JUST AFTER 3PM, DANIEL TELLS KATELYN:

"The world can get better, but I'll have to take all the time I can or we can, whatever to name it. I'll either see you again or never see you again."

I ALSO OBSERVED TEXT CONVERSATIONS BETWEEN DANIEL AND HIS SISTER DAVISHA FROM 06/22/2021 WHERE DANIEL TELLS HER HE HAS AN EMERGENCY, AND THEN DOES NOT RESPOND TO DAVISHA'S REPEATED CALLS AND TEXTS WHICH IS CONSISTENT WITH DAVISHA'S DESCRIPTION OF DANIEL'S BEHAVIOR ON 06/22/2021.

(CELL PHONE DATA IS STILL UNDER REVIEW AND THIS REPORT WILL BE UPDATED WHEN COMPLETED)

PROCESSING OF JEEP FOR POSSIBLE EVIDENCE:

ON 07/22/2021 CRIME SCENE MANAGER PRUSICK AND DETECTIVE SGT HANNAMAN CONDUCTED FURTHER INVESTIGATION OF DANIEL'S 2017 JEEP RENEGADE. THE VEHICLE WAS DUSTED FOR FINGERPRINTS AND SWABBED FOR DNA EVIDENCE. DURING THE INITIAL PROCESSING OF THE VEHICLE AT THE SCENE AND THIS SECONDARY PROCESSING FOR EVIDENCE, THERE WERE NO NOTES OR OTHER ITEMS IN THE VEHICLE INDICATIVE OF WHERE DANIEL MIGHT BE.

FOLLOW UP AT [REDACTED]:

AS PREVIOUSLY MENTIONED, DANIEL'S BANK RECORD INDICATED THAT A CHARGE POSTED TO HIS BANK ACCOUNT IN THE AMOUNT OF \$17.88 ON 06/24/2021. THE STORE WAS LISTED ON [REDACTED] IS ABOUT 4.3 MILES FROM DANIEL'S APARTMENT AND RIGHT OFF THE FREEWAY.

DANIEL'S SISTER DAVISHA HAD PREVIOUSLY STATED TO ME THAT DANIEL TOLD HER HE WENT TO WAFFLE HOUSE ON 06/22/2021. THIS WAS IN THE AFTERNOON AND DURING THE TIME WHEN HE HAD LEFT HIS APARTMENT AFTER TEXTING DAVISHA HE HAD AN EMERGENCY. DAVISHA EXPLAINED TO ME THAT WHEN DANIEL RETURNED TO HIS APARTMENT THAT EVENING AROUND 1930 HOURS HE WAS WEARING BLUE JEANS AND HIS NAVY BLUE [REDACTED] WORLD POLO SHIRT.

IN MY EXPERIENCE, THE "POSTED" DATE IS NOT ALWAYS THE DATE WHEN THE CARD WAS USED AS IT CAN SOMETIMES TAKE A COUPLE OF DAYS TO POST TO THE ACCOUNT. THE SCREEN SHOT PROVIDED TO ME OF THE BANK RECORD DID NOT SHOW A SPECIFIC TIME.

ON 07/28/2021 AT ABOUT 15 [REDACTED] RS I WENT TO THE WAFFLE HOUSE AND MADE CONTACT WITH THE MANAGER MATTHEW [REDACTED]. MATTHEW ALLOWED ME IN THE BACK TO REVIEW SURVEILLANCE VIDEO. MATTHEW'S SYSTEM DID NOT RETAIN THE TRANSACTION INFORMATION FOR DANIEL'S PURCHASE.

UPON REVIEWING VIDEO, I OBSERVED DANIEL ARRIVE AT WAFFLE HOUSE ON 06/22/2021 AT ABOUT 1802 HOURS WEARING THE CLOTHES THAT DAVISHA HAD DESCRIBED. DANIEL WAS ALONE AND ARRIVED ON FOOT. DANIEL SAT NEAR THE JUKEBOX UNTIL ABOUT 1827 WHEN HE WAS THEN SEATED IN A BOOTH BY SERVER MADYSON [REDACTED]. DANIEL WAS ALONE THE ENTIRE TIME. AFTER EATING HIS FOOD, DANIEL WENT TO THE REGISTER AND PAID HIS BILL. HE THEN RETURNED TO HIS BOOTH AND PACKAGED HIS FOOD IN A TO-GO BOX. AT ABOUT 1910 HOURS DANIEL LEAVES THE RESTAURANT WITH HIS FOOD AND WALKS OUT OF VIEW OF PARKING LOT CAMERAS ON THE SIDEWALK.

I CHECKED THE MORNING HOURS OF 06/23/2021 AND UP UNTIL NOON ON 06/24/2021 AND DID NOT LOCATE ANY MORE VIDEO WITH DANIEL. I TOOK PHOTOGRAPHS OF THE VIDEO SCREEN BUT WAS ADVISED BY THE MANAGER THAT I WOULD NEED TO CONTACT THEIR MAIN SECURITY DEPARTMENT IN GEORGIA TO OBTAIN THE ACTUAL VIDEO RECORD. THE NUMBER GIVEN TO ME WAS [REDACTED]. ONCE THE VIDEO IS OBTAINED, I WILL UPLOAD IT TO EVIDENCE.COM. AS OF 06/24/2021 I HAVE NOT RECEIVED A COPY OF THE VIDEO BUT WAS ABLE TO UPLOAD SCREEN SHOTS TO EVIDENCE.COM.

INTERVIEW WITH MADYSON AT [REDACTED]

I THEN SPOKE WITH MADYSON. I EXPLAINED TO HER WHO I WAS AND THAT I WAS INVESTIGATING A MISSING PERSON. I SHOWED HER THE FLYER WITH DANIEL'S PHOTOGRAPH AND SHE RECOGNIZED HIM. I THEN SHOWED HER THE SURVEILLANCE VIDEO AND SHE REMEMBERED THAT DAY. I ASKED MADYSON TO TELL ME WHAT SHE REMEMBERED. MADYSON ADVISED THAT SHE REMEMBERED DANIEL WAS "SKIDDISH" AND WHEN SHE TRIED TO ENGAGE HIM IN CONVERSATION, HE DID NOT TALK TO HER. I ASKED HER IF HE WAS SKIDDISH LIKE A NERVOUS GUY TALKING TO A GIRL OR SOMETHING ELSE. MADYSON COULD NOT EXPLAIN IT, BUT SAID THAT HE JUST SEEMED "OUT OF IT" AND "OFF". MADYSON ALSO ADVISED THAT SHE HAD SEEN HIM IN THE RESTAURANT ON PREVIOUS OCCASIONS. WHILE SHE DIDN'T KNOW HIM, SHE WAS ABLE TO SAY THAT HIS DEMEANOR ON 06/22/2021 WAS DIFFERENT. SHE DID NOT HAVE ANYTHING ADDITIONAL TO ADD.

PRIVATE INVESTIGATOR JEFF [REDACTED]

I WAS ADVISED THAT DAVID [REDACTED] WAS USING A PRIVATE INVESTIGATOR TO ASSIST WITH LOCATING DANIEL. ON 06/21/2021 PI [REDACTED] CAME TO BUCKEYE POLICE DEPARTMENT. I HAD BEEN ADVISED THAT HE WISHED TO OBTAIN A COPY OF THE CRASH DATA WHICH WE DOWNLOADED FROM THE JEEP. SINCE I WAS NOT AVAILABLE, DETECTIVE CHAMPION MET WITH PI [REDACTED]. I RECEIVED A PHONE CALL FROM DETECTIVE CHAMPION AND HE ADVISED THAT PI [REDACTED] WANTED TO CONDUCT THEIR OWN FORENSIC DOWNLOAD OF THE VEHICLE AND ADDITIONAL DOWNLOADS WHICH WOULD POSSIBLY CAUSE DAMAGE TO THE VEHICLE. I SPOKE WITH SUPERVISORS AND DETECTIVE CHAMPION TO COORDINATE WITH MR. [REDACTED] AND PI [REDACTED] TO HAVE THE VEHICLE RELEASED TO THEIR CUSTODY AT WHICH POINT THEY CAN COMPLETE THEIR INVESTIGATION AT A PLACE OUTSIDE OF OUR EVIDENCE FACILITY.

THE VEHICLE WAS LATER RELEASED TO PI [REDACTED] AND MR. [REDACTED] SEE DETECTIVE CHAMPION'S SUPPLEMENT.

FOLLOW UP WITH DAVID [REDACTED]

I SPOKE WITH MR. [REDACTED] BRIEFLY THROUGH TEXT ON 08/03/2021. I HAD PREVIOUSLY GIVEN MR. [REDACTED] THE REPORT UP TO THAT DATE BUT HAD NOT YET BEEN ABLE TO

PROVIDE HIM WITH A PACKAGE OF THE SCENE PHOTOS. CHIEF HALL AUTHORIZED THE RELEASE OF THE SCENE PHOTO'S WHICH WE CURRENTLY HAVE STORED IN EVIDENCE.COM

WHILE SPEAKING WITH MR. [REDACTED] I ASKED AGAIN ABOUT THE DETAILED RECORDS WHICH MAY PROVIDE INSIGHT TO D [REDACTED] AST KNOWN LOCATIONS BOTH BEFORE AND AFTER LEAVING THE JOB SITE. MR [REDACTED] ADVISED HE WOULD REMIND HIS DAUGHTER TO SEND ME THAT INFORMATION.

ON 08/04/2021 I PLACED THE IMAGES AND AN UPDATED COPY OF THIS REPORT ON A USB DRIVE AND ADVISED MR. [REDACTED] IT WAS READY FOR PICKUP.

CONTACT WITH DAVISHA REGARDING BANK RECORDS:

ON 08/09/2021 AT 0800 HOURS I SENT A TEXT MESSAGE TO DAVISHA ADVISING THAT HER FATHER (MR. [REDACTED] SAID SHE WAS WORKING ON GETTING BANK RECORDS. AT ABOUT 1130 HOURS I [REDACTED] ND LEFT HER A VOICE MESSAGE REGARDING THE BANK RECORDS.

LATER IN THE DAY, DAVISHA E-MAILED ME WITH [REDACTED] AND [REDACTED] BANK STATEMENTS FROM DANIEL'S ACCOUNT.

UPON REVIEWING THE BANK RECORDS, I NOTED A COUPLE TRANSACTIONS DATED 06/23/2021 THAT REQUIRED FOLLOW UP.

IN THE [REDACTED] STATEMENT, THERE WAS A CHARGE ON 06/23/2021 FOR \$3.83 AT A [REDACTED] STATION IN BUCKEYE.

THERE WAS ALSO A CHARGE TO [REDACTED] IN THE AMOUNT OF \$10.48 DATED 6/23/2021.

[REDACTED] SERVICE STATION CHARGE:

THE BANK STATEMENTS DID NOT IDENTIFY WHICH STORE OR WHAT TIME THE TRANSACTION OCCURRED. SINCE DANIEL WAS KNOWN TO HAVE BEEN AT A WELL SIT [REDACTED] RRADO WAY SHORTLY AFTER 0700 HOURS ON 06/23/2021 I CONTACTED STEPHEN [REDACTED] THE MANAGER AT THE SHELL/CORNER STORE LOCATED AT [REDACTED]. STEPHEN LOCATED VIDEO SURVEILLANCE WHICH APPEARED TO BE DAN [REDACTED] IN TO PUMP NUMBER 4 AND PUMPING \$3.83 WORTH OF FUEL. THE VIDEO QUALITY WAS POOR. DANIEL PULLED INTO THE PUMP AT 0700 HOURS AND LEFT SOUTHBOUND ONTO VERRADO WAY AT ABOUT 0703 HOURS.

ATTEMPT TO OBTAIN INFORMATION FROM [REDACTED]

I REACHED OUT TO [REDACTED] THROUGH THEIR LAW ENFORCEMENT PORTAL REGARDING THE CHARGE THAT POSTED TO DANIEL'S ACCOUNT ON 06/23/2021. [REDACTED] WOULD NOT PROVIDE INFORMATION FROM THAT REQUEST AND I INTEND TO M [REDACTED] ADDITIONAL ATTEMPTS TO FIND OUT WHEN THAT TRIP OCCURRED.

IT IS UNKNOWN IF THE [REDACTED] TRIP WAS ON 06/23/2021 BUT IT MAY BE POSSIBLE THAT THE TRIP OCCURRED ON 06/22/2021. IN PREVIOUS CONVERSATIONS WITH DAVISHA, SHE MENTIONED [REDACTED] L MAY HAVE TAKEN AN [REDACTED] BACK TO HIS APARTMENT AFTER GETTING FOOD AT [REDACTED] ON 06/22/2021.

CONTACT WITH JEFF [REDACTED]

ON 08/12/2021 I CONTACTED PRIVATE INVESTIGATOR JEFF [REDACTED] BY TELEPHONE. I HAD NOT YET SPOKEN WITH HIM. I INTRODUCED MYSELF AS THE [REDACTED] DETECTIVE AND ADVISED THAT I WAS TOLD HE HAD INFORMATION THAT WOULD CHANGE THIS FROM A MISSING PERSON TO A CRIMINAL INVESTIGATION.

JEFF ADVISED THAT DURING A SEARCH OF THE DESERT AREA, NEAR THE ROADWAY THAT LEADS BACK TO SUN VALLEY PARKWAY FROM THE JOB SITE, THEY LOCATED A SOCK WHICH WAS SUN FADED AND HAD BEEN IN THE DESERT FOR A PERIOD OF TIME. JEFF ADVISED THAT THE SOCK MATCHED THE SOCKS FOUND BY DANIEL'S CAR AND ALL OF THE SOCKS MATCHED THOSE FOUND IN DANIEL'S APARTMENT.

JEFF TOLD ME THAT HE IS A VEHICULAR CRIMES INVESTIGATOR SO HOMICIDE INVESTIGATION IS NOT HIS FOCUS. HE SAID THAT HE REVIEWED THE VEHICLE DOWNLOAD AND DOES NOT BELIEVE THAT THE CAR COULD HAVE BEEN DOING 28MPH FOR UP TO 5 SECONDS BEFORE THE CRASH. JEFF SAID THAT HIS BASIS FOR THIS OPINION WAS THAT HE ATTEMPTED TO GET HIS OFF ROAD VEHICLE UP TO THAT SPEED AND COULD NOT. JEFF WAS ALSO NOT AWARE OF THE PATH WE BELIEVED DANIEL HAD TAKEN. HE ALSO NOTED THAT THE START BUTTON WAS PUSHED SEVERAL TIMES AFTER THE CRASH EVENT. JEFF MENTIONED SOME RED PAINT TRANSFER AND ALLEGES THAT THE VEHICLE HAD BEEN IN A PREVIOUS ACCIDENT AND WAS SUBSEQUENTLY DUMPED IN THE RAVINE. JEFF DID NOT PROVIDE ANY ADDITIONAL INFORMATION BUT SAID THAT HE WOULD BRING ALL OF HIS DATA AT AN UPCOMING MEETING.

JEFF ALSO MENTIONED HIS CONTACT WITH A MAN NAMED ROGER FROM [REDACTED] [REDACTED] A CO WORKER OF DANIEL. [REDACTED] SAID THAT ROGER HAD BEEN PRESENT AT ONE OF THE SEARCHES AND DAVID [REDACTED] ADVISED JEFF THAT ROGER HAD WANTED TO TELL THEM SOMETHING AND APPEARED DISTRAUGHT BY WHAT HE WANTED TO TELL THEM. JEFF EXPLAINED THAT WHEN HE TALKED TO ROGER, HE TOLD HIM HE WANTED TO TALK TO HIM FURTHER. JEFF ALLEGES THAT'S WHEN ROGER HAD AN "OH SHIT" LOOK AND TURNED PALE. JEFF SAYS THAT ROGER AVOIDED HIM FOR THE REMAINDER OF THEIR TIME AT THE SEARCH. JEFF SAID THAT DAVISHA TOLD HIM THAT ROGER MIGHT HAVE BEEN A ROOM MATE OF DANIEL'S AT SOME POINT. INITIALLY, I RECALLED SEEING ROGER IN THIS INVESTIGATION BUT REALIZED THAT I SAW HIM IN DANIEL'S CELL PHONE AND HE WAS NOT KNOWN OR IDENTIFIED IN THIS INVESTIGATION.

IT SHOULD BE NOTED THAT AT NO TIME DID ANYONE FROM DANIEL [REDACTED] FAMILY OR GROUP OF FRIENDS MENTION ANYONE NAMED ROGER, OR THAT THEY H [REDACTED] NS ABOUT HIS BEHAVIOR OR STATEMENTS.

ON 09/14/2021 I RE-CONTACTED PI [REDACTED] BY PHONE. [REDACTED] HAD PREVIOUSLY TOLD NEWS REPORTERS THAT DANIEL'S JEEP HAD TRAVELLED 11 MILES AFTER THE CRASH EVENT. HE ALSO MADE STATEMENTS ABOUT THE CRASH SCENE BEING STAGED AND THE DAMAGE BEING INCONSISTENT WITH THE SCENE WHERE WE FOUND THE JEEP. AFTER HAVING REVIEWED THE CRASH REPORTS DOWNLOADED FROM THE VEHICLE, I COULD NOT LOCATE AN [REDACTED] THAT INDICATED THE VEHICLE HAD BEEN DRIVEN 11 MILES AFTER THE CRASH. [REDACTED] SAID THAT AFTER THEY TOOK POSSESSION OF THE VEHICLE, THEY POWERED IT UP AND OBSERVED THAT THE ODOMETER DISPLAY ON THE DASH WAS 11 MILES HIGHER THAN THE CDR REPORT INDICATED THE ODOMETER WAS AT THE TIME OF THE CRASH.

I TALKED TO [REDACTED] ABOUT THE SCENE, AND ASKED IF THE VEHICLE CRASHED ON IT'S SIDE WITH THE [REDACTED] LS OFF THE GROUND, COULD THE VEHICLE HAVE STILL BEEN RUNNING WITH WHEELS SPINNING AND COULD THAT ACCOUNT FOR A DISCREPANCY. HE SAID THAT WAS POSSIBLE. I ASKED [REDACTED] IF THE TOW TRUCK PULLED THE VEHICLE OUT OF THE DITCH AND DOWN TO THE DIR [REDACTED] WITH ITS WHEELS ON THE GROUND COULD ACCOUNT FOR A DISCREPANCY. HE SAID THAT WAS ALSO POSSIBLE. I THEN TALKED TO [REDACTED] ABOUT HIS THEORY THAT THE DAMAGE DIDN'T MATCH THE SCENE. I EXPLAINED TO [REDACTED] OBSERVATIONS AT THE SCENE INDICATED I BELIEVED THE VEHICLE WENT INTO THE RAVINE,

ROGER TALKED ABOUT THE MONTH OF June AND EXPLAINED THAT HE WAS DEALING WITH THE PASSING OF HIS FATHER. ROGER WAS OUT OF STATE ROUGHLY FROM June 16TH TO June 20TH TENDING TO HIS FATHERS SITUATION. ROGER WAS CHOKED UP AT TIMES TALKING ABOUT HIS FATHER AND THE SUDDENNESS OF HIS ILLNESS.

ROGER CAME INTO THE OFFICE ON 06/21/2021 AND SEES DANIEL AT THE OFFICE WHICH WAS UNUSUAL SINCE HE COMES IN SO RARELY. ROGER SAID THAT DANIEL LOOKED VERY DIFFERENT AND SAID THAT HE HAD CUT HIS HAIR OFF WHICH SHOCKED HIM SINCE DANIEL WANTED TO GROW HIS HAIR OUT. ROGER SAID THAT WHEN HE TALKED TO DANIEL, HIS REACTION TO HIM WAS VERY DRY. HE ASKED DANIEL IF EVERYTHING IS OKAY, AND HE DIDN'T HAVE MUCH TO SAY WHICH WAS ALSO UNUSUAL. ROGER SAID "SOMETHING'S UP WITH DANIEL, SOMETHING'S NOT RIGHT, I NEED TO TALK TO HIM".

ROGER ASKED DANIEL IF HE WANTED TO GET BREAKFAST TO WHICH DANIEL SAID NO. ROGER WENT BACK TO HIS DESK TO WORK AND THEN DANIEL TEXT HIM ASKING IF HE WANTED TO GET BREAKFAST (CONSISTENT WITH MESSAGES IN DANIEL'S PHONE EXTRACTION)

HE SAID THAT HE AND DANIEL TAKE ROGER'S TRUCK TO GET BREAKFAST AT CHICK FIL A. ROGER SAID THAT HE ASKED DANIEL AGAIN IF HE WAS OKAY BUT DANIEL DIDN'T TELL HIM YET WHAT WAS BOTHERING HIM. WHEN THEY GOT TO CHICK FIL A, ROGER ASKED DANIEL WHAT HE WANTED AND DANIEL TOLD HIM "WHATEVER YOU'RE GETTING". ROGER SAID THIS WAS ALSO ODD BECAUSE DANIEL USUALLY WANTED THE SPICY CHICKEN NUGGETS.

AFTER GETTING FOOD, ROGER ASKED DANIEL IF THERE WAS A PROBLEM WITH A GIRL. THE ANSWER EVOLVED TO THERE WAS A GIRL THAT HE KNEW BUT THE GIRL DIDN'T KNOW HE EXISTED.

DANIEL CONTINUED TO ASK ODD QUESTIONS WHICH DIDN'T MAKE A LOT OF SENSE TO HIM.

ROGER RECEIVED A CALL FROM HIS SISTER DURING THEIR DRIVE TALKING ABOUT THEIR FATHERS STATUS. WHEN THE CALL WAS OVER, DANIEL ASKED ROGER IF HE BELIEVED IN MIRACLES AND THEN DANIEL TOLD HIM MAYBE HE SHOULD START BELIEVING IN MIRACLES.

ROGER SAID THAT DANIEL THEN MENTIONED SOMETHING ABOUT GOD OR RELIGION. ROGER SAID HE WAS TAKEN BACK BY DANIEL'S QUESTIONING BECAUSE DANIEL HAD NEVER REALLY EXPRESSED ANY RELIGIOUS VIEWS TO HIM.

DANIEL ASKED ROGER IF HE TRUSTS HIM, AND WHEN ROGER SAID YES, DANIEL CHALLENGED HIM ABOUT WHETHER HE TRUSTED HIM BUT ROGER SAID YEAH I TRUST YOU BECAUSE WERE FRIENDS. DANIEL THEN SAID WHAT IF WE WEREN'T FRIENDS.

DANIEL THEN SAID SOMETHING TO ROGER ABOUT GETTING RID OF HIS EGO BECAUSE EGO IS BAD. ROGER TOLD DANIEL HE SAW HIM AS CONFIDENT BUT NOT EGOTISTICAL. DANIEL THEN SAID "WELL I HAVE TO GET RID OF MY STORY". ROGER WAS CONFUSED BY THIS SINCE DANIEL WAS PROUD OF WHO HE WAS AND WHERE HE CAME FROM.

THE CONVERSATION ENDED AND THEY WENT BACK TO WORK.

ROGER SAID THAT WHEN THEY WERE BACK AT THE OFFICE, HE SAW DANIEL WALK BY WEARING HIS MIAMI HEAT HAT WHICH DANIEL LOVED. DANIEL TOLD HIM HE SHOULD PROBABLY GET RID OF IT AND ROGER TOLD HIM THAT WAS SILLY AND TO KEEP IT.

A SHORT TIME LATER, DANIEL LEFT THE OFFICE CARRYING A BOX AND DID NOT SAY BYE TO ROGER.

WHEN ROGER COMES INTO THE OFFICE ON 06/22/2021 DANIEL IS THERE AGAIN AND DANIEL ASKS ROGER TO GO TO BREAKFAST. THEY LEFT THE OFFICE IN DANIEL'S JEEP AND HE DESCRIBED THE DIRT AND TOOLS IN THERE THAT HAD TO BE MOVED TO THE BACK.

ROGER SAID THEY DROVE AROUND AND DANIEL ACKNOWLEDGED THAT THERE WAS A GIRL BUT DIDN'T GIVE UP MUCH INFO. DANIEL ASKED ROGER "WHAT IF THERE WAS A GIRL YOU LIKED BUT YOU COULDN'T HAVE?" ROGER GAVE DANIEL ADVICE THAT IF HE WANTED TO ASK A GIRL OUT TO GO FOR IT. DANIEL THEN TALKED MORE ABOUT THE EGO AND SIMILAR QUESTIONS TO THE DAY BEFORE. ROGER EXPLAINED THAT DANIEL DIDN'T REALLY GIVE UP WHAT WAS BOTHERING HIM. HE SAID THAT IT SEEMED LIKE DANIEL THOUGHT HE HAD TO COMPLETELY CHANGE HIMSELF TO BE WITH WHOEVER THIS GIRL WAS.

WHEN THEY WENT BACK INTO THE OFFICE, DANIEL STAYED FOR ABOUT 15 MINUTES AND LEFT WITHOUT TALKING TO ROGER ANYMORE.

ROGER TRANSITIONS TO DEALING WITH HIS FATHERS PASSING AND HIS STRUGGLES WITH THAT. ON Wednesday 06/23/2021 ROGER OVERHEARS A COMMENT IN THE OFFICE ABOUT DANIEL HAVING LEFT THE JOB SITE. ROGER SAID SOMETIMES FIELD GUYS WILL LEAVE TO RUN TO THE STORE, OR GO TO THE BATHROOM AND SOMETIMES THE SITES ARE REMOTE SO IT COULD BE AN HOUR OR MORE FOR THEM TO RETURN. BECAUSE OF THIS, ROGER WASN'T CONCERNED. A LITTLE AFTER LUNCH HE WAS TALKING TO A BOSS WHO EXPLAINED THAT DANIEL WENT TO THE FIRST JOB SITE AND THEN THE SECOND SITE AND HASN'T BEEN SEEN SINCE HE LEFT THERE. ROGER ASKED IF ANYONE HAD CALLED DANIEL AND THEN OFFERED TO GO BY HIS APARTMENT. ROGER SAID HE WENT TO DANIEL'S APARTMENT AND SAW HIS CAR WASN'T THERE AND THE DOOR WAS LOCKED. ROGER SAID HE THEN TOLD THE BOSS THAT HE KNEW WHERE DAVISHA LIVED AND HE MAY BE OVER THERE. ROGER WENT TO DAVISHA'S HOUSE. DANIEL WAS NOT THERE. DAVISHA'S BOYFRIEND RENE AND IT SEEMED LIKE DANIEL HAD THE SAME ODD CONVERSATIONS WITH DAVISHA AND RENE. ROGER TOLD THE BOSS TO GET AHOLD OF DANIEL'S EMERGENCY CONTACT BECAUSE DAVISHA DIDN'T KNOW WHERE HE WAS EITHER. ROGER LEFT SOME TIME LATER AND CHECKED DANIEL'S APARTMENT AGAIN WITH NO CHANGE. ROGER SAID HE ALSO CHECKED DANIEL'S APARTMENT ON THE MORNING OF THE 24TH AND SAW NO CHANGE.

I TALKED TO ROGER ABOUT DANIEL'S APARTMENT. THE WAY I OBSERVED THE APARTMENT SEEMED TO BE NORMAL FOR DANIEL. ROGER WAS AWARE THAT DANIEL SMOKED MARIJUANA BUT WAS NOT AWARE OF ANY OTHER DRUGS OR MEDICATIONS.

THE COMPLETED AUDIO RECORDED INTERVIEW WAS UPLOADED TO EVIDENCE.COM.

On 07/19/2021 at approximately 1027 hours, I was contacted by Sgt. Hannaman #3731. He advised me that a rancher with property off the west side of Sun Valley Parkway located a vehicle belonging to a missing person (210623079) who was reported missing on June 23, 2021. He asked that I respond to photograph the vehicle, be available processing should any be needed, and assist in searching for Daniel [REDACTED] with other Buckeye Police Department employees.

At approximately 1130 hours, I arrived to the ranch area which had been set up as a meeting point. Det. Biffin, Det. Woliver, and Sgt. Hannaman were already on scene. Upon the arrival of other members of the Buckeye Police Department, we all drove into the desert and parked before taking an off road vehicle to the location of the vehicle.

At approximately 1314 hours, I arrived to the area where the vehicle was located. Det. Biffin provided me with the GPS coordinates of the vehicle for documentation. The weather was clear, sunny, and approximately 105 degrees Fahrenheit.

The vehicle was found in a gap/wash area that was in between two hills. The vehicle was found on a downward slope in desert landscaping (consisting of rocks, shrubbery, and cactus). The vehicle came to rest on the passenger side. The front of the vehicle was pointing in the southwestern direction. The vehicle was a grey Jeep Renegade bearing Arizona License plate # [REDACTED]. The vehicle sustained extensive damage, was missing part of the sun/moonroof, had a shattered windshield, and a shattered out driver's door window. It appeared that all of the airbags within the vehicle were deployed. The headlights were set to "AUTO" and the shifter to the vehicle was in drive. It appeared the seatbelt was being worn during the collision as it was unbuckled but locked in an outstretched position. Inside the vehicle was a set of keys, a cell phone, a school identification card issued to Daniel [REDACTED], a backpack with a laptop, tow straps, a case of water, clothing, a hard hat which was upside down and contained water, and various other personal belongings.

Scattered up the western side of the hill were two (2) socks, two (2) boots, jeans, shorts, shirt, and an orange reflective vest. In the pants was a wallet with an Arizona Driver's License ([REDACTED]) belonging to Daniel Cornelius [REDACTED]. Other items belonging to Daniel [REDACTED] were also amongst the wallet contents.

The clothing, backpack, cell phone, wallet, and keys were collected for safekeeping and stored in the evidence lab until family was able to collect the

items.

The surrounding areas of the vehicle were searched both on foot and with off road vehicle(s). Daniel was not located at this time.

I left the scene at approximately 1800 hours.

ONCE I FINISHED THE DRONE PHOTOS I WAS ASKED TO DO A VISUAL SEARCH OF THE AREA USING THE DRONE TO CHECK FOR ANY SIGN OF SOMEONE IN THE AREA AS THE VEHICLE WAS UNOCCUPIED. I SEARCHED OUT TO APPROXIMATELY 1500 FEET FROM MY LAUNCH POINT IN ALL DIRECTIONS CHECKING ANY RAVINE I CAME ACROSS. I ALSO ATTEMPTED TO CHECK UNDER LARGER TREES ALTHOUGH THE THICKNESS OF THE FOLIAGE PREVENTED ME FROM BEING ABLE TO SEE UNDER A GOOD PORTION OF THE CANOPY.

I FLEW THE AREA FOR OVER AN HOUR AND A HALF UNTIL ALL OF MY BATTERIES WERE DEPLETED. I WAS UNABLE TO RECHARGE THEM AS WE WERE IN THE DESERT AWAY FROM ANY OTHER VEHICLES.

AS I COULD SEE THAT THE VEHICLE HAD ROLLED OVER TO IT'S FINAL RESTING POINT I EXPLAINED TO DETECTIVE BIFFIN THAT IF NEEDED I COULD ATTEMPT TO DOWNLOAD THE AIRBAG CONTROL MODULE TO SEE IF IT RECORDED ANY CRASH DATA THAT WOULD INDICATE A DATE OR TIME OF THE COLLISION. I TOLD HIM THAT IF HE WANTED IT DONE THAT IF THE VEHICLE WAS REMOVED FROM ITS LOCATION THAT THE IGNITION SHOULD NOT BE PRESSED OR THE VEHICLE TURNED ON. I WAS CONTACTED ON 07/21/21 BY DETECTIVE BIFFIN WHO ADVISED REQUESTED THAT I DOWNLOAD THE DATA FROM THE VEHICLE.

ON 07/21/21 I RESPONDED TO THE BUCKEYE PD PROPERTY AND EVIDENCE FENCED LOT WHERE THE VEHICLE WAS CURRENTLY STORED. I OBTAINED THE KEYS FROM CRIME SCENE MANAGER PRUSICK. I ATTACHED JUMPER CABLES TO THE VEHICLE AS THE BATTERY WAS DEAD. ONCE I HAD THE BOSCH CDR TOOL SET UP AND SHOWING AS COMMUNICATING I PRESSED THE IGNITION BUTTON WHILE THE KEY FOB WAS IN THE VEHICLE WITHOUT PRESSING THE BRAKE PEDAL SO THE VEHICLE TURNED ON POWER BUT DID NOT ATTEMPT TO START THE ENGINE. ONCE THE VEHICLE POWER WAS ON I INPUT THE FINAL INFORMATION INTO THE SOFTWARE AND REQUESTED IT DOWNLOAD THE AIRBAG CONTROL MODULE. ONCE IT HAD SUCCESSFULLY DOWNLOADED THE INFORMATION I PRESSED THE IGNITION BUTTON AGAIN WHICH SHUT THE VEHICLE OFF. I THEN DISCONNECTED THE CDR TOOL FROM THE VEHICLE AND SAVED THE DOWNLOAD TO A BLANK THUMB DRIVE I PROVIDED IN THE FORMAT IT AUTOMATICALLY SAVES IN AND IN PDF FORMAT. I ALSO PRINTED OUT THE PDF VERSION TO PROVIDE TO DETECTIVE BIFFIN. BOTH THE THUMB DRIVE AND PRINT OUT WERE TURNED OVER TO DETECTIVE BIFFIN.

IT WAS ALSO REQUESTED THAT I REVIEW THE DATA DOWNLOADED FROM THE VEHICLE. A REVIEW OF THE DATA DID NOT SHOW ANYTHING THAT WOULD INDICATE A DATE AND TIME OF

THE CRASH INCIDENT. THE REPORT ALSO INDICATED THAT THE DRIVERS SEATBELT WAS BUCKLED. THE VEHICLE WAS NOT CONFIGURED AT THE TIME OF EVENT TO DETECT FRONT PASSENGERS BUT DID INDICATE THAT THE FRONT PASSENGER SEATBELT WAS NOT BUCKLED. LOOKING AT THE PRE-CRASH DATA FROM WHAT THE REPORT INDICATED WAS THE MOST RECENT EVENT IT SHOWED THAT IN THE 5 SECONDS PRIOR TO THE EVENT THE VEHICLE WAS GOING AT MAXIMUM 33 MPH AT 0.8 SECONDS PRIOR TO THE CRASH. THE DATA SHOWED THAT FOR THE FIVE SECONDS PRE-CRASH THE THROTTLE FLUCTUATED FROM AT MAX 78% TO AS LOW AS 22%. IT SHOWED THAT THE BRAKES WERE NEVER APPLIED AND THE LAST DOCUMENTED SPEED AT 0.1 SECONDS PRE-CRASH WAS 30 MPH.
