



That the Defendant, LENNIN ARTURO ROBLESARRA, ISAIAS LORENZO SANTOS, in Minnehaha County, State of South Dakota, on or about the 19th day of October, 2021, did commit the public offense of Use or Possession of Drug Paraphernalia (SDCL 22-42A-3) in that the defendant did, knowing the drug related nature of the object, use or possess with intent to use, drug paraphernalia to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, contain, conceal, inject, ingest, inhale or otherwise introduce into the human body any controlled substance or marijuana, DUFFEL BAGS, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of South Dakota, and prays that the Defendant may be arrested and dealt with according to the law.
