Dear Mr. Linhorst:

This is in response to your Freedom of Information/Privacy Acts (FOIPA) request.

The FOIA provides for access to government records where the records sought are "reasonably described" [Title 5, United States Code, Section 552(a)(3)(A)]. Your compound request does not comport with the requirements of 28 CFR § 16.3(b), as it does not provide enough detail to enable personnel to locate records "with a reasonable amount of effort." Your compound request is overly broad in scope and seeks information in vague and undefined terms. Accordingly, your request is closed.

If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
