Dear Ms. Hidde:

This letter is fourth interim response to your Freedom of Information Act (5 U.S.C. § 552) requests dated May 21, 2018. In your request, you sought material relating to several records as they relate to records released to Petrillo & Powell, Fred Schulte as well as records regarding Government Accountability Office (GAO), Risk Adjustment Payments System (RAPS), Medicare Advantage Organizations (MAO) and copies of other related matters in your requests for the timeframe of January 1, 2007 through the date of your requests.

Our agency initiated a search for records falling within the scope of your request, and located 851 pages of responsive documents. I have determined to release 685 pages to you, in their entirety, and deny you access to portions of two (2) of the released pages pursuant to Exemption (b)(4) of the FOIA (5 U.S.C.§ 552(b)(4)). Also, I have determined to deny you access to portions of one of the one (1) of the released pages pages pursuant to Exemption (b)(5)). Furthermore, I have determined to deny you access to 163 pages, in their entirety, pursuant to Exemption (b)(5) of the FOIA (5 U.S.C.§ 552(b)(5)).

Exemption (b)(4) protects information which constitutes "trade secrets and commercial or financial information obtained from a person [that is] privileged or confidential." Commercial or financial matters are "confidential" for the purpose of this exemption if such voluntarily provided information is of a kind that would customarily not be released to the public by the person from whom the information was obtained, or if such required submissions are likely to: impair the government's ability to obtain necessary information in the future; cause substantial

harm to the competitive position of the person from whom the information was obtained; or impair the effectiveness of a government program.

Exemption (b)(5) permits the withholding of "inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency." Among the several bases upon which records may be withheld under this exemption, the deliberative process privilege applies to the materials withheld in this case. The privilege protects internal communications that are pre-decisional and contain staff advice, opinions and recommendations that are part of the agency's deliberative decision-making process

The CMS office will need additional time to process additional documents to determine which portions of those records therefore may be released in response to your requests. An interim of additional non-exempt documents or portions of documents will be forwarded to you upon completion of that review every 60 days.
