I am writing to follow up with both DHS and ICE regarding the status of Earthjustice's FOIA request to DHS, number 2019-HQFO-01115, which was transferred to ICE and assigned case number 2020-ICFO-01444. We submitted the FOIA request to DHS on July 26, 2019, and on August 9, 2019, DHS transferred the request to ICE. To date, we have not received a determination in response to our FOIA request from either agency. We are requesting a final determination as soon as possible. - FOIA Request No. 2019-01126-FOIA-OS to the Department of Health and Human Services, dated July 26, 2019; transferred to the Administration for Children and Families on July 29, 2019 with the same request number, and on June 29, 2020, given the Request No. 20-F-0202;
- FOIA Request No. 2019-HQFO-01115 to the Department of Homeland Security, dated July 26, 2019; transferred to Immigration and Customs Enforcement on August 9, 2019 and given the Request No. 2020-ICFO-01444;
- FOIA Request No. 882562 to the Department of Labor, dated July 26, 2019.

WeCount! transfers to AFSC the ability and right to pursue any administrative or legal options and methods at its disposal under the law in relation to these FOIA requests, and WeCount! surrenders any claims it may have with regard to these FOIA requests.
