I, Investigator C. Markiewicz

attest to the following and state:

On 10/22/2021, at approximately 1549 hours, **G.B.** contacted MATCOM and reported she found her father, **Brian BOHMAN**, unconscious with blood all over him. G.B. reported there had only been three adults and her infant daughter in the residence prior to her finding her father. She stated she was upstairs in her separate apartment and her father was downstairs in his apartment with **Garrett Livingston**, who had been staying there and helping around the property.

G.B. reported hearing yelling between Brian and Garrett downstairs then one of the men yell, to the effect of, "no, stop, get away from me", then it went silent. Approximately three minutes later she saw Garrett walk up the driveway wearing jeans and a flannel jacket. G.B. added that Garrett is aggressive and violent and that's why she waited upstairs with a knife and bear spray until she saw him walking away from the house before going downstairs. G.B. went downstairs to check on her father and found him covered in blood, not breathing with a laceration across his neck, so she called 911.

While responding to the scene Troopers saw a male matching the description of the suspect walking near the driveway on New Hope Road. Troopers confronted the male, later identified as Garrett, who dropped a bloody knife and hammer onto the ground and was detained. Garrett identified himself to Troopers and stated in essence, "Do you know how many pedophiles live in this town? It is disgusting." Garrett was observed to have what appeared to be fresh blood on his hands, boots, and jeans.

NVOL Criminal Complaint (10/2013) Criminal Rule 3 At approximately 1600 hours, Brian was pronounced deceased on scene. Troopers and investigators observed Brian to have a multiple lacerations to his head, neck, and hands. Based on my training and experience the lacerations on Brian's hands appear to have been defensive in nature.

While being placed into the Patrol vehicle Garrett reported to Troopers, without being asked any questions his remark stated earlier. He then made mention of "another pedophile" who runs a food business out of a bus.

During an interview with investigators, Garrett stated he lives in the basement with the Bohman family. He added that he wanted to expose Brian as a sex offender, so he confronted Brian in the living room area and told him that he is going to hell for being a pedophile. According to Garrett, Brian is a pedophile, sex offender, fat pig, and a disgusting demon. Garrett believed that "They" were going to kill him. Garrett stated Brian was going to kill him. Garrett reported as he was yelling at Brian, Brian lunged towards him like he was going to football tackle him. Garrett pulled his knife out and slashed Brian's neck then kept stabbing him because he stated he feared for his life.

Garrett could not provide any evidence that Brian was a pedophile.

Investigators were unable to locate any similar type of investigations against Bohman nor did he have any criminal convictions.

Garrett was arrested and charged with Murder in the First Degree and two counts of Murder in the Second Degree.
