Answer- The Wahpeton Police Department did not maintain a comprehensive "Use of Force" master list during the specified time period. Use of force reports were instead placed in specific case files. The Wahpeton PD does not issue batons or other impact tools so has had no incidents involving their use during the specified time period. TASER devices have been deployed very sparingly, generally only 1 -2 times per year or less. The majority of Wahpeton PD Officers have only activated their TASER during training.

Question 2. the total number of civilian complaints alleging any form of law enforcement misconduct that were reported and the total number sustained from 2013-2020, separated by year (for example, 8 complaints in 2016, 2 complaints sustained in 2016, 4 complaints in 2017, 1 complaint sustained in 2017, etc.)

#### Answer- No complaints alleging police misconduct were received during the specified time period

Question 3. the total number of civilian complaints alleging law enforcement use of excessive force that were reported and the total number sustained from 2013-2020, separated by year.


