# Preview Request

If you are an attorney or a third party requesting information on behalf of someone else (other than your own minor child) you must attach a written consent from the subject of record. It is recommended that you use the G-28 form or G-639, or you may submit a written notarized consent. You can track your request by searching on the request number that we provide in your confirmation notice. If you have created an account, you will be provided with a view of your requests once you log onto FOIAonline. Click on the desired request number for additional details. You may also call the CBP FOIA Office at 202-325-0150, Mon-Fri 8am-5pm EST. However, they can only provide you with the same information that you can obtain online. DO NOT CALL THE FOIAonline HELPDESK FOR STATUS QUESTIONS. THEY CAN NOT HELP YOU WITH THIS.
