Covid Freedom/ Vaccine Mandates

As we had anticipated, the vaccine mandates for medical institutions have spread to other organizations. Employees from Hershey Medical and The Children's Hospital of PA (CHOP) have reached out to FreePA for support and guidance in filing their own lawsuits, just as the PICA group has done. The CHOP employees are also filing suit with the help of Attorney Bruce Castor, Philadelphia.

ACTION: Join your fellow PA residents in a "World-Wide Walk Out" to protest the unconstitutional employer vaccine mandates: November 3rd, 1-4pm on the steps of the Harrisburg Capitol.

LGH & other hospitals are continuing to deny therapeutics like hydroxychloroquine and Ivermectin, that have been proven to work and are continuing with the protocol that has resulted in many deaths-- that is, no treatment in early stages at all and then the use of Remdesivir (which causes kidney failure) and the use of ventilators and sedation, a certain death sentence.

LGH has gone so far as to refuse the requests of patients for Ivermectin, forcing them to go to court to obtain the drugs-- which is a violation of the Right to Try laws!

NATIONALLY:

- The President's Covid mandates are both unconstitutional and immoral. Thankfully, Republican Attorneys General around the country have vowed to fight if OSHA implements the President's orders. The AGs have emphasized that Biden's federal mandate for COVID-19 vaccinations have not yet come into effect for private businesses, adding that if it is ordered, they will file lawsuits against it. Montana Attorney General Austin Knudsen, a Republican, noted that the White House only recently submitted the text of its emergency rule regarding vaccinations to the Office of Management and Budget, meaning it hasn't gone into effect.
- To illustrate the corruption that is occurring at the federal level, we have learned that OSHA is discouraging the REPORTING OF ADVERSE EFFECTS TO COVID VACCINES! OSHA does not wish to have any appearance of discouraging workers from receiving COVID-19 vaccination, and also does not wish to disincentivize employers' vaccination efforts. As a result, OSHA will ***not enforce 29 CFR 1904's recording requirements to require any employers to record worker side effects from COVID-19 vaccination at least through May 2022.***
- Rep. Diana Harshbarger (R-Tenn.) and 10 other members of the House of Representatives late last week introduced the "**Natural Immunity Is Real Act,**" a companion to a Senate bill from Sens. Mike Lee (R-Utah), Tommy Tuberville (R-Ala.), Mike Braun (R-Ind.), and Dan Sullivan (R-Alaska). **It would require federal agencies to "acknowledge, accept, and agree to truthfully present, natural immunity pertaining to COVID-19 pursuant to promulgating certain regulations."** None of our PA senators are sponsors on this bill!! **ACTION: Call your House Reps and demand that they support this legislation!**
- Service members from all five branches of the U.S. military, federal employees, and federal civilian contractors have joined in a class-action lawsuit against the Department of Defense over its COVID-19 vaccine mandates.

- Joe Biden's U.S. Agency for International Development launched a new \$125 million dollar project with Washington State University and foreign collaborators to discover over 10,000 novel viruses in nature. The ambitious program follows the agency funding a similar form of research conducted by EcoHealth Alliance and its controversial partner: the Wuhan Institute of Virology. Many experts believe this Chinese Communist Party-run lab is the source of COVID-19. The new program, announced by Washington State University (WSU) on October 5th, will endeavor "to collect over 800,000 samples in the five years of the project." "This process is expected to yield 8,000-12,00 new viruses. See the story:

Knowing that it is only a matter of time before they come for us all, so to speak, FreePA is exploring the potential for us to legally organize in such a way that we become a 'private membership organization' under the law. This would give us certain immunities from government overreach. **In conjunction with that, we are seeking to develop a list of businesses and service providers to form a cooperative that would uphold 'medical freedom' in the workplace and in serving their customers. We at FreePA, would maintain a list of these on our webpage as a resource for you to know where to go! So, if you have a business, let us know by responding to us by email!! We will help one another through this difficult time, with God's help and protection.**

Our goal is to also achieve this for **medical services** as well. We are researching all of this at the moment.

PA Legislative Items:

A new challenge to Act 77 has been initiated! Rep. Dave Zimmerman (New Holland) has spearheaded an effort to challenge Act 77 on constitutional grounds. 14 legislators, including Mike Jones, Dawn Keefer and Frank Ryan, have signed onto the suit. The basis for the suit was that the PA constitution requires a process to be followed before election laws are amended: introduction into the legislature through two consecutive sessions and a constitutional amendment ballot to the public. This was not done and as a result, the changes should be nullified. The suit has been expedited to the Commonwealth Court and will continue through the appellate system. A victory will do away with mail in balloting, extended voting days and restore the straight party vote.

ACTION: Call your representative and DEMAND that they support this lawsuit. Remember that aside from Reps. Zimmerman & Mentzer, all of our Republican representatives voted for ACT 77!

National Election Security:

Mike Lindell petition: petition to encourage the Supreme Court to accept the bill of complaint brought by patriotic states to save our country. <https://fix2020first.com/>

Mike Lindell has complete and irrefutable evidence that the 2020 election was fraudulently reported, which fraud was done by China through cyber-electronics.

School Boards/Education:

Thank you to the 40 volunteers who signed up to work at polls on Election Day! You are making the difference! Please see the Comprehensive Lancaster Voting Guide (from the Lancaster Patriot) and the FreePA School Board Guide on our website at: FreePa.net under the Lancaster tab.

If you are battling your school board, here are two helpful items to take to them, the first as an attachment to this email:

1. Find out if your school board is part of the PA School Board Association. This Association supports CRT and equity (not equality) outcomes. They are fundamentally marxist. Demand that the school board dissolve their affiliation.

2. The NIH had previously published a study of the harms of masking. REMIND your school board members by showing them this document: <https://www.ncbi.nlm.nih.gov/pmc/articles/PMC8072811/>

Our presenter Eric Winter gave wonderful advice to the group with respect to masking/vaccine exemptions. I will try to summarize a few of the key points:

1. There is a very good chance that the mask mandates will be overturned by the commonwealth court. If that should happen, it would revert to the decision of each school board to mask or not which will bring more suits against those who continue mask policies. The battle may be won, but the war is not yet over.
2. PA Law will inhibit public schools from imposing vaccine mandates on children. It is a regulatory process that can take up to 2 years. We will continue to monitor this situation.
3. Do not quit your job if you are facing a mandate. Force the employer to terminate you. YOU are entitled to unemployment benefits under PA law if you are terminated.
4. Begin planning to make your case for religious exemptions. Eric stated that the exemptions most likely not to be rejected are those where the employee
 - o clearly stated the source of their belief (scripture, church, upbringing, pro-life rallies)
 - o showed how the belief was furthered throughout time
 - o ways that you demonstrated your commitment to that belief
 - you do not need to be a member of an official church
 - moral conviction is equal to religious conviction
 - you do not need a clergy signature, although it is helpful
5. Medical exemptions should not be denied; doctors cannot decline to see you to discuss exemptions
6. Demand that your employer provide for a baseline health assessment with the stipulation that if your health changes after vaccination, you will hold them accountable. Also, provide notice of liability (see our website).
7. Consider filing a complaint under the EEOC and Civil Disabilities Act if your rights are violated. There is no charge to you to do so.

Other:

Lastly, I am including here a link to a short film that I feel encompasses the solution to the situation we find ourselves in, and that is to stand together.

A little background-- my family emigrated to the US in 1956 as refugees from the brutal communist putdown of the Hungarian Revolution. Patriots rose up and pushed the communist government and its troops from the country's borders. The freedom fighters cries for help fell on the deaf ears of the western nations and Stalin then sent in troops to crush the rebellion, resulting in the deaths of thousands and the flight of over 200,000 Hungarians, my parents and brothers among them. Hungary has not forgotten what the chains of oppression and injustice look like. This short film (don't worry, it has English subtitles) is about middle school children who stand up against injustice in their own way. It is, however, a teaching moment for all of us.
