Priority Action Step:

• As leaders, we need to increase message effectiveness, find other like-minded groups to partner on messaging. Multiple campaigns leverage impact! Use the resources provided at alec.org/mappingtheleft/ to get started.

Other Action Steps:

- When corporations offend your values with leftist programs, be sure to notify them that their actions are offensive. Example of success Insurance company USAA restored Hannity sponsorship when its military customers complained.
- When negatively attacked on social media, use comment sections to challenge credibility of attacker. Truthful comments diminish credibility of leftist attacks.
- Social media is a proven game changer; learn it and exploit it!

Mapping the Left: Public Employee Unions

Priority Action Step:

• Tell the story of <u>Janus v. AFSCME</u> and explain why workers deserve a choice in whether they belong to a union.

Other Action Steps:

- Call on state and local authorities to <u>open union negotiations</u> to the public and to allow union members to vote on whether to <u>recertify unions</u>.
- Call on state legislators and HHS to take action against <u>dues skimming</u> (CA, CT, IL, MA, MD, MI, MN, NJ, NY, OR, RI, VT, WA) and share these <u>videos</u>.

Mapping the Left: Education

Priority Action Step:

• Send coalition letters to Betsy DeVos asking her to advocate for non-government-regulated school choice (use tax dollars to spend on private education, not choose between public schools).

Other Action Steps:

- Use social media to build support and encourage President Trump to sign these <u>17 executive orders</u> that will improve higher education.
- Push for viewpoint diversity in hiring university faculty to ensure conservative professors have fair representation on college campuses.

Priority Action Step:

Other Action Steps:

- Call your congressmen before the SPLC testifies before the House Committee on Homeland Security in October. Let them know that the SPLC is not a credible organization.
- Infiltrate progressive organizations to learn their objectives, strategies and supporters.
